**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE THE AGREEMENT BETWEEN THE CITY AND PALM BEACH COUNTY TO ACCEPT COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS IN THE AMOUNT OF \$154,063 FROM PALM BEACH COUNTY FOR FISCAL YEAR 2016-2017 FOR THE MILLING AND RESURFACING OF WEST 15<sup>th</sup> TO WEST 17<sup>th</sup> STREET BETWEEN AVENUE S AND AVENUE R AS WELL AS AVENUE S FROM WEST 15<sup>th</sup> STREET TO BLUE HERON BOULEVARD; AUTHORIZING THE DIRECTOR OF FINANCE AND ADMINISTRATIVE SERVICES TO APPROPRIATE A BUDGET AND APPROPRIATE FUND BALANCE FROM 301-1116-541-2-6355 IN THE PAVING AND DRAINAGE CONSTRUCTION FUND IN THE AMOUNT OF \$178,000; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City's annual submission of an application to Palm Beach County for Community Development Block Grant Funds was granted; and

**WHEREAS**, Palm Beach County has approved said application and has allocated \$158,063 to be utilized for the milling and resurfacing of West 15<sup>th</sup>-West 17<sup>th</sup> Street between Avenue R and Avenue S as well as Avenue S from West 15<sup>th</sup> Street to Blue Heron Boulevard; and

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA as follows:**

**SECTION 1.** The City Council hereby approves the acceptance of Community Development Block Grant Funds from Palm Beach County for fiscal year 2016-17 in the amount of \$154,063.

**SECTION 2.** The Mayor and City Clerk are authorized to execute the agreement.

**SECTION 3.** The Director of Finance and Administrative Services is authorized to appropriate fund balance from account 301-1116-541-2-6355 to set up a budget in the Paving and Drainage Construction Fund in the amount of \$178,000 and setup a budget in the CDBG fund in the amount of \$154,063 for the construction of West 15<sup>th</sup>-West 17<sup>th</sup> Street between Avenue S and Avenue R as well as Avenue S from West 15<sup>th</sup> Street to Blue Heron Boulevard.
