AMENDMENT TO THE CONTRACT FOR CONSULTING AND
PROFESSIONAL SERVICES FOR
INVESTMENT MANAGER

This Amendment extending the Contract for Consulting and Professional Services made and entered into this 15th day of December, 2016, by and between the City of Riviera Beach, Palm Beach County, Florida, a municipal government existing under the laws of the State of Florida, hereinafter referred to as the "City", whose mailing address is 600 West Blue Heron Boulevard, Riviera Beach, Florida, 33404 and Public Trust Advisors, LLC, a limited liability corporation authorized to do business in the State of Florida, whose mailing address is 999 18th Street, Suite 1230, Denver, Colorado, 80202 and whose Federal I.D. Number is 45-3356583.

WHEREAS, the City entered into a Contract for Consulting and Professional Services with Public Trust Advisors, LLC on December 1, 2014, to provide investment and advisory services, with two optional one year renewals, at the City's discretion, and

WHEREAS, the value of Public Trust Advisor, LLC contract did not exceed \$25,000, the City Manager approved an extension of the contract's expiration date from December 1, 2015 to January 31, 2016; and

WHEREAS, on January 20, 2016, the City Council approved the first one year renewal that extended from February 1, 2016 to November 30, 2016; and

WHEREAS, the City and Public Trust Advisors, LLC desires to extend the second year renewal expiration date from December 1, 2016 to November 30, 2017.

NOW THEREFORE, in consideration of the mutual promises contained herein, the City and Public Trust Advisors, LLC agree as follows:

SECTION 1. The Contract for Consulting and Professional Services for Investment Manager, is hereby extended until November 30, 2017 unless otherwise extended under the terms of the original contract.

SECTION 2. In all other respects, the terms of the contract shall remain in full force and effect, and the parties agree to perform all duties and obligations as set forth therein.


