A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, AUTHORIZING THE MAYOR TO EXECUTE THE CONTRACT FOR CONSULTING AND PROFESSIONAL SERVICES WITH GALLAGHER BASSETT SERVICES, NOT TO EXCEED THE AMOUNT OF \$94,715; AND AUTHORIZING THE DIRECTOR FINANCE & ADMINISTRATIVE SERVICES TO MAKE PAYMENTS FOR THE PURPOSE OF CLAIMS ADMINISTRATION AND LOSS CONTROL SERVICES FROM INSURANCE LIABILITY FUND ACCOUNT No. 602-0539-513-0-3101 FOR CLAIMS ADMINISTRATION SERVICES FOR FISCAL YEAR 2016-2017; AND PROVIDING AN EFFECTIVE DATE.
