**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, AWARDED RFP 826-17-1 FOR A CITYWIDE ERP SYSTEM AND IMPLEMENTATION TO TYLER TECHNOLOGIES AND AUTHORIZE STAFF TO NEGOTIATE CONTRACT TERMS AND CONDITIONS FOR THE SAME; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City of Riviera Beach issued RFP 826-17-1 for a Citywide ERP System and Implementation; and

**WHEREAS**, Tyler Technologies was the only submitter to the RFP Solicitation; and

**WHEREAS**, the Selection Committee made an unanimous recommendation to award the contract to Tyler Technologies based on their submittal package and previous implementations; and

**SECTION 1.** The City Council award RFP 826-17-1 for Citywide ERP System and Implementation to Tyler Technologies and authorize staff to negotiate contract terms and conditions for the same.
