A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE AN INTERLOCAL GRANT AGREEMENT BETWEEN THE CITY OF RIVIERA BEACH AND LOWE'S CHARITABLE AND EDUCATIONAL FOUNDATION, ACCEPTING A GRANT IN THE AMOUNT OF \$38,750.00, FOR THE CUNNINGHAM PARK REVITILIZATION AND BEAUTIFICATION PROJECT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Section 163.01, Florida Statutes, known as the "Florida Interlocal Cooperation Act of 1969", authorizes local governments to make the most efficient use of their powers by enabling them to cooperate with other localities on a basis of mutual advantage and thereby to provide services and facilities that will harmonize geographic, economic, population and other factors influencing the needs and development of local communities; and

WHEREAS, the Governing Board of the Lowe's Charitable and Educational Foundation (hereinafter LCEF) has appropriated funds for Municipality Grants; and

WHEREAS, the City of Riviera Beach submitted an application for funds available through this Grant for the revitalization of Cunningham Park, a City owned and operated park, in order to improve the quality of life of residents and the surrounding community; and

WHEREAS, the LCEF has approved the City's Grant application in the amount of \$38,750.00 for the rehabilitation and beautification of Cunningham Park; and

WHEREAS, the LCEF Board approved the attached Interlocal Grant Agreement on Wednesday, November 22, 2016; and

WHEREAS, the City Council of the City of Riviera Beach has determined it is in the best interest of the City to execute the attached Interlocal Grant Agreement.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, AS FOLLOWS:

SECTION 1. The City Council hereby finds that the foregoing recitals are true and correct and are hereby incorporated herein by reference.

SECTION 2. The City Council hereby authorizes the Mayor and City Clerk to execute the Interlocal Grant Agreement with the Lowe's Charitable and Educational Foundation, for the amount of \$38,750.00.
