WHEREAS, the Riviera Beach Maritime Academy, Corp., desires to extend the lease term for two additional years; and

WHEREAS, the legal description has been adjusted to reflect the property lines that were made a part of the lease for the Boys and Girls Club.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA AS FOLLOWS:

SECTION 1. That the Mayor and City Clerk are authorized to execute the two year Lease Amendment on behalf of the City of Riviera Beach with the Riviera Beach Maritime Academy, Corp.

SECTION 2. That the Riviera Beach Maritime Academy will continue to pay \$500 per month to the City for the term of the lease.

SECTION 3. This Resolution shall take effect immediately upon its approval by the City Council.
