A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, APPROVE THE CONTRACT TO WITH CONSTRUCTION FOR THE **INSTALLATION** OF HURRICANE SHUTTERS FOR CITY HALL AND THE LIBRARY IN AN AMOUNT NOT TO EXCEED \$95,500, AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE THE CONTRACT, AUTHORIZING THE CITY MANAGER TO APPROVE CHANGE ORDERS UP TO TEN PERCENT (10%); AND AUTHORIZING THE DIRECTOR FINANCE & ADMINISTRATIVE SERVICES TO TRANSFER \$95,500 FROM THE MAJOR DISASTER CONTINGENCY ACCOUNT AND MAKE PAYMENT FOR SAME, AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Riviera Beach Purchasing Department issued ITB 872-17-1 for the purchase and installation of hurricane shutters at City Hall and Library; and

WHEREAS, three firms responded to the mandatory pre-bid and of which only firm submitted a proposal; and

WHEREAS, CJ Construction was found to be responsive and responsible to the bid proposal; and

WHEREAS, CJ Construction is a certified Palm Beach County Small Business Entity.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, FLORIDA THAT:

SECTION 1. The Mayor and City Clerk is authorized to approve the contract.

SECTION 2. That the Director of Finance & Administrative Services is authorized to transfer \$95,500 from the Major Disaster Contingency Account as follows:
