A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, AWARDED A PROFESSIONAL SERVICES AGREEMENT TO THOMPSON CONSULTING SERVICES, LLC OF LAKE MARY, FLORIDA BY PIGGYBACKING THE SOLID WASTE AUTHORITY OF PALM BEACH COUNTY (SWA) AGREEMENT NUMBER 17-205 TO PROVIDE DEBRIS MANAGEMENT SERVICES ON AN AS-NEEDED BASIS AS REQUIRED BY THE CITY OF RIVIERA BEACH WITH SERVICES COMMENCING IMMEDIATELY UPON EXECUTION OF THE AGREEMENT AND ENDING MAY 7, 2022; AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE THE AGREEMENT; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City needs to ensure that it is adequately prepared to effectively respond to potential future needs for debris management services in the event of a natural disaster; and

WHEREAS, having a debris management firm is essential for ensuring that debris collected is properly tracked and documented as such activities will directly affect the City's ability to qualify for State and Federal reimbursement of debris related costs associated with declared disasters; and

WHEREAS, the City desires to piggyback the Solid Waste Authority of Palm Beach County contract to contract with Thompson Consulting Services, LLC to provide debris management services.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, AS FOLLOWS:

SECTION 1: The Mayor and City Clerk are authorized to execute the agreement with Thompson Consulting Services, LLC for debris management services by piggybacking the Solid Waste Authority of Palm Beach County (SWA) agreement number 17-205.

SECTION 2: The Mayor and Director of Finance and Administrative Services are authorized to make payment from the appropriate account(s).

SECTION 3: That the City Manager is hereby authorized to execute agreement any and all renewals as detailed in the agreement.
