Chen Moore and Associates (CMA) is pleased to submit the attached of Services to provide civil engineering construction administration services for the Federal Gardens 11th – 14th Street Neighborhood Improvement Project for the Riviera Beach Utility District (RBUD).

BACKGROUND

The City of Riviera Beach previously contracted with CMA to design roadway, drainage, water and sewer improvements in the Federal Gardens Neighborhood. The RBUD has requested that CMA provide construction engineering and administration services related to the water and sewer improvements within this project. The construction duration is 300 calendar days. It is assumed that the utility construction will be 150 calendar days.

The "Client" is the Riviera Beach Utility District (RBUD) The "City" is the City of Riviera Beach The "Consultant" is Chen Moore and Associates (CMA)

SCOPE OF SERVICES

The professional engineering services and the associated fees are described below.

TASK 1 – CONSTRUCTION ADMINISTRATION

Chen Moore and Associates will provide construction administration services as needed.

- 1.1 Construction Inspections: CMA will perform construction inspections while contractor is on site (assumes 45 calendar days, 4 hours per day) and prepare daily field reports.
- 1.2 Construction Testing: CMA will observe construction testing required for permit certification.
- 1.3 Meetings: CMA will attend progress meetings throughout construction at a schedule determined by the CITY. It is assumed that a total of 15 meetings will require CMA to be present. CMA will produce meeting minutes related to the utility items for each meeting.

- 1.4 Process Payment Requests: CMA will review contractor's payment request for utility components and compare to daily report for accuracy. CMA will make recommendations to the RBUD on the amounts to process for pay requests.
- 1.5 RFI Responses and Change Orders: CMA will review and provide response to Request for Information and Change Orders. It is assumed that a maximum number of five (5) RFI and two (2) Change Orders will be evaluated.
- 1.6 Contractor Coordination: CMA will coordinate with prime contractor and subcontractors regarding the scope of work and scheduling.
- 1.7 Walk Throughs: CMA will attend substantial completion and final walk through and prepare a punch list of items to be corrected.
- 1.8 Project Closeout and Certification: ENGINEER will review project asbuilts, certify the project at completion and close out all permits.

ASSUMPTIONS

- This proposal does not include any services required for easement or right-of-way acquisitions.
- Surveying services are not included.
- Preparation of record drawings is not included. CMA will review asbuilts prepared by Contractor for permit certification.
- RBUD shall provide all required respective permit certification fees.
- The City will perform the main construction administration tasks related to the overall project. CMA will only provide services related to the water and sewer utility improvements.

DELIVERABLES

Chen Moore and Associates will provide the following deliverables:

- Construction inspection reports (PDF)
- Permit certification (signed and sealed and PDF)

SCHEDULE OF SERVICES

Chen Moore and Associates will complete tasks according to the construction schedule established by the City. It is assumed that the construction schedule will be 300 calendar days from the Notice to Proceed.

ENGINEERING FEES

The fees for the above task are \$39,745. The fees will be billed on an hourly basis according to the time spent.
