**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, AUTHORIZING THE PURCHASE AND DELIVERY OF SEVENTEEN NEW REPLACEMENT VEHICLES AND TRAILERS THAT WERE IDENTIFIED ON THE CITY'S VEHICLE REPLACEMENT PLAN FOR THE FOLLOWING CITY DEPARTMENTS, STORM WATER, PARKS & RECREATION, WATER UTILITIES, FIRE, FLEET, ENGINEERING, COMMUNITY DEVELOPMENT AND HUMAN RESOURCES, IN THE AMOUNT OF \$400,055.00 BY UTILIZING THE COOPERATIVE PURCHASE PROGRAM AND THE FLORIDA SHERIFFS ASSOCIATION CONTRACT NUMBER FSA17-VEL15.0 AND VEL 25.0 SPECIFICATIONS #51, #37, #53, #57, #58 #46, AND #27; AUTHORIZING THE DIRECTOR OF FINANCE AND ADMINISTRATIVE SERVICES TO MAKE PAYMENT FOR SAME FROM ACCOUNT NUMBER 503-1129-519-0-6451 IN THE AMOUNT OF \$322,671.00; ACCOUNT NUMBER 460-1127-541-0-6351 IN THE AMOUNT OF \$26,884.00; AND ACCOUNT NUMBER 411-1438-535-0-4608 IN THE AMOUNT OF \$50,500.00; AUTHORIZING THE DIRECTOR OF FINANCE AND ADMINISTRATIVE SERVICES TO DEPOSIT PROCEEDS FROM THE SALE OF SURPLUS VEHICLES INTO THE FLEET SERVICES FUND, AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the Public Works Department currently has identified fourteen vehicles and three trailers within the city fleet that have met or exceeded the city's vehicle replacement plan criteria; and

**WHEREAS**, the existing vehicles and trailers are increasing maintenance and repair costs due to lower reliability and it is no longer cost effective for these vehicles to remain in the fleet; and

**WHEREAS**, the Public Works Department desires to purchase fourteen new vehicles and three new trailers to replace the identified units; and

**WHEREAS**, the purchase of these new vehicles and trailers will ensure fleet reliability, thereby improving productivity of the various departments and lowering maintenance & repair costs.

**WHEREAS**, the City of Riviera Beach has established a Fleet Services Fund to administer all vehicle acquisitions, disposals, repairs and maintenance.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA AS FOLLOWS:**

**SECTION 1.** That the City Council authorizes the purchase of seventeen new 2018 vehicles and trailers from Duval Ford Prestige Ford and Texas Trailer Sales and Service, by utilizing the Cooperative Purchase Program and the Florida Sheriffs Association Contract Number FSA17-VEL15.0 and VEL 25.0 Specifications #51, #37, #53, #57, #58 #46, and #27.
