Hyacinthia "Cinthia" Becton has lived in Riviera Beach since 1967. She moved to the area after graduating from the College of Great Falls in Montana.

Cinthia's children are Wayne and Margo Weaver and their three children - Marshay, Wayne II, and Joshua. She has three sisters, Letha Morris (Dan), Sharvell and Ellarene Becton. These persons and others family members represent a blessing for her.

Cinthia is a member of Mount Zion Missionary Baptist Church where Reverend James E. Adams is the Pastor. She is blessed to be with prayer warriors. Mount Zion has several ministries. Cinthia serves as the Church Secretary.

Cinthia is currently employed as the Executive Director at St. George's Center, Inc. St. George's primary focus is to feed hungry individuals and families.
