RE: Silver Beach Road from E. of Congress Ave to President Barack Obama/Old Dixie Highway Palm Beach County Project No. 2003514

Dear Mr. Bailey:

Palm Beach County Engineering Department (County) is nearing completion of the design of Silver Beach Road. The right-of-way acquisition phase has begun with the hiring of an appraiser to perform all parcel appraisals required for the project. Before we send offers out to affected property owners, we would like to memorialize the following items that have been discussed and previously agreed to by the City and County.

- 1) County will construct the proposed driveways within the City's jurisdiction as shown on the project design plans. This includes the closure of driveways currently located on Silver Beach Road between Avenue S and President Barack Obama Highway and the proposed relocation of said driveways to W. 37th Court.
- 2) Between Avenue S and Avenue P, and just east of Avenue P, County realigned Silver Beach Road by shifting it north and away from houses on the south side. The existing Silver Beach Road will be reconstructed and will become a frontage road for the residents. The City previously agreed to take over maintenance of the new frontage road upon completion of construction.

County expects to open the construction bids for Silver Beach Road in June 2018 with a notice to proceed for construction in January 2019. Anticipated duration of construction is one (1) year.

Please provide us with your concurrence on the items above so that we may proceed with acquisition and our schedule for bid. If you have any
