This Item is needed in order for us to accurately locate facilities as we progress into the future with repairs, locating valves and whatnot. We're need to replace.., we have on GPS system presently that is not operable and we need at least two others to give to the field crews as they work in the field. So, we've gotten, we've gotten several proposals, this was the best approach. We worked with IT to make sure it was compatible with systems that they are using for the CIS system and so, I recommend approval of this Item.

BOARD CHAIRPERSON MILLER-ANDERSON: Okay.

**BOARD MEMBER PARDO:** Madam Chair?

**BOARD CHAIRPERSON MILLER-ANDERSON:** Do we have any public comment cards for this?

**BOARD MEMBER PARDO:** But what.., but you said it's gonna help us with equipment and everything. So, what is exactly is it doing for us?

**EXECUTIVE DIRECTOR OF UTILITY SPECIAL DISTRICT HORTON:** This device actually helps us to get locations of valves, pipes, down to within two or three inches. That piece of metal right there, we could stand there with the device and accurately locate that and give the coordinates of that piece of metal there to an accuracy within two or three inches, which is extremely needed.

BOARD MEMBER DAVIS: [Inaudible].

**EXECUTIVE DIRECTOR OF UTILITY SPECIAL DISTRICT HORTON:** We're having difficulties now where we are identifying facilities but they may be off four, five feet.

**BOARD MEMBER PARDO:** Right.

**EXECUTIVE DIRECTOR OF UTILITY SPECIAL DISTRICT HORTON:** And that's the issue.

**BOARD MEMBER PARDO:** Okay. So, it's really for the pi'.., pipes and underground infrastructure?

**EXECUTIVE DIRECTOR OF UTILITY SPECIAL DISTRICT HORTON:** Yes.

**BOARD MEMBER PARDO:** Okay. Thank you.

# BOARD CHAIRPERSON MILLER-ANDERSON: DISCUSSION BY THE EXECUTIVE DIRECTOR OF THE UTILITY SPECIAL DISTRICT

**EXECUTIVE DIRECTOR OF UTILITY SPECIAL DISTRICT HORTON:** Yes, Madam Chair. A couple of Items I'd like to bring to the Board's attention. Myself and the Finance Director have been in communication with the Township of Mangonia Park relating to the rate study that was initiated. As a result of the rate study, we're prepared to bring that before the Board. Mangonia Park has requested a joint meeting with the Board and the timeframe is the 18<sup>th</sup> of January, which is the week of the Martin Luther King birthday holiday. And so, I'm, I'm asking the Board's concurrence to hold that meeting on the 18<sup>th</sup>.

# **BOARD MEMBER PARDO:** On a Thursday?

**EXECUTIVE DIRECTOR OF UTILITY SPECIAL DISTRICT HORTON:** If, if the Board accepts it, it'll start at 5:30.

**BOARD MEMBER PARDO:** It's a Thursday.

**BOARD CHAIRPERSON MILLER-ANDERSON:** Okay. So, I think we discussed this in the meeting the other night about the 18<sup>th</sup> and we said the 18<sup>th</sup> was fine, everybody?

**BOARD MEMBER DAVIS:** Nah. I can't do the 18<sup>th</sup>.

**BOARD MEMBER PARDO:** I don't know. I need to look at my calendar.

BOARD MEMBER DAVIS: Yeah.

**BOARD MEMBER PARDO:** And I don't have [inaudible]...

**BOARD CHAIRPERSON MILLER-ANDERSON:** Alright. So, you want Ms. Hoskins to get back with us?

**BOARD MEMBER PARDO:** Yes, please.

**BOARD CHAIRPERSON MILLER-ANDERSON:** Okay. Ms. Hoskins?

**BOARD MEMBER DAVIS:** And I thought it was.., I just realized...

**BOARD CHAIRPERSON MILLER-ANDERSON:** Just get back with us, find out from everyone if the 18<sup>th</sup> will be okay.

**BOARD MEMBER DAVIS:** The 25<sup>th</sup> would be better. [Inaudible].

**EXECUTIVE DIRECTOR OF UTILITY SPECIAL DISTRICT HORTON:** Madam Chair, if the Board concurs with that, I would also ask, since we're not able to have our regularly scheduled meeting on the 15<sup>th</sup>, that we also have the regularly scheduled Board meeting for that time, and at that meeting, we will have an Item on the Agenda to, to approve or accept the rate study that the consultants will present at the earlier meeting.

**BOARD CHAIRPERSON MILLER-ANDERSON:** Okay. I, I think I recall saying about the 24<sup>th</sup>...

**BOARD MEMBER DAVIS:** 25<sup>th</sup>.

**BOARD CHAIRPERSON MILLER-ANDERSON:** ... or the 10<sup>th</sup>. No, the.., for the CRA meetings. I.., I'm not sure if we're having two in January or not. If we're not.., I know sometimes we only have one.

**BOARD MEMBER DAVIS:** We can do that.

**BOARD CHAIRPERSON MILLER-ANDERSON:** So maybe, Ms. Hoskins, you can find out from Scott if one of those Wednesdays would be open, then maybe we can just do it on a Wednesday. The.., instead of the 18<sup>th</sup>.

CITY MANAGER HOSKINS: So, you're saying...

**BOARD MEMBER PARDO:** Right. Do it on the 17<sup>th</sup>.

**CITY MANAGER HOSKINS:** The 24<sup>th</sup>.

**BOARD MEMBER PARDO:** It's a Council meeting.

**BOARD CHAIRPERSON MILLER-ANDERSON:** I was looking at December. I don't know what I was looking at. Yeah. Whichever, the, the January 10<sup>th</sup> or the January 24<sup>th</sup> for the CRA. One...

CITY MANAGER HOSKINS: Remember...

**BOARD CHAIRPERSON MILLER-ANDERSON:** ...of those meetings, find out if he's only.., what?

**CITY MANAGER HOSKINS:** January 10<sup>th</sup> is the Palm Beach County Days in Tallahassee.

**BOARD CHAIRPERSON MILLER-ANDERSON:** Right, right. Okay. So.., right. So, the 24<sup>th</sup>, I think we mentioned, find out...

BOARD MEMBER HUBBARD: We are having a meeting on [inaudible]...

**BOARD CHAIRPERSON MILLER-ANDERSON:** The 24? Because we're not gonna have one on the 10<sup>th</sup>?

**BOARD MEMBER HUBBARD:** I don't know if that's, if that's why he's having it, I was talking to him and he said he was presenting something at the 24<sup>th</sup> meeting. But it could be because...

**BOARD CHAIRPERSON MILLER-ANDERSON:** But is.., but, because of Palm Beach County Day, are we looking to.., 'cause I'm.., I'll be here. I'm not going, so, is it.., will we not have a meeting that week at all or are we going to look to make it up on the 31<sup>st</sup>?

**BOARD MEMBER PARDO:** Well, P'... Madam Chair?

BOARD CHAIRPERSON MILLER-ANDERSON: Mhmm.

**BOARD MEMBER PARDO:** So, Palm Beach County Day falls within a CRA meeting. We are having a meeting on the 17<sup>th</sup> of January.

**BOARD CHAIRPERSON MILLER-ANDERSON:** For the City.

**BOARD MEMBER PARDO:** Right.

BOARD CHAIRPERSON MILLER-ANDERSON: Mhmm.

**BOARD MEMBER PARDO:** So why can't we just put the Utility meeting prior to the Council meeting on the 17<sup>th</sup>?

**BOARD MEMBER DAVIS:** Because they [inaudible]...

**BOARD CHAIRPERSON MILLER-ANDERSON:** Well, he wants to have the Util'.., he wants the Utility... He wants two things.

**EXECUTIVE DIRECTOR OF UTILITY SPECIAL DISTRICT HORTON:** Rate study.

BOARD CHAIRPERSON MILLER-ANDERSON: Right? Two different...

EXECUTIVE DIRECTOR OF UTILITY SPECIAL DISTRICT HORTON: We...

**BOARD CHAIRPERSON MILLER-ANDERSON:** ...things? **BOARD MEMBER DAVIS:** A joint [inaudible].

**EXECUTIVE DIRECTOR OF UTILITY SPECIAL DISTRICT HORTON:** Yeah. We, we're, we're wanting to do it conjunction with the joint meeting...

BOARD CHAIRPERSON MILLER-ANDERSON: Yeah. Joint meeting...

**EXECUTIVE DIRECTOR OF UTILITY SPECIAL DISTRICT HORTON:** ...that you had requested.

**BOARD CHAIRPERSON MILLER-ANDERSON:** ...with Mangonia.

EXECUTIVE DIRECTOR OF UTILITY SPECIAL DISTRICT HORTON: On...

BOARD CHAIRPERSON MILLER-ANDERSON: and...

**EXECUTIVE DIRECTOR OF UTILITY SPECIAL DISTRICT HORTON:** ...on the rate study ...

**BOARD CHAIRPERSON MILLER-ANDERSON:** ... the Utility meeting.

**EXECUTIVE DIRECTOR OF UTILITY SPECIAL DISTRICT HORTON:** ...and then we would come back to the Utility meeting to approve the rate study.

**BOARD CHAIRPERSON MILLER-ANDERSON:** So, that would need to be on a separate day.

BOARD MEMBER PARDO: Well...

BOARD CHAIRPERSON MILLER-ANDERSON: Okay. So, Ms. Hoskins...

UNK: She can get back to you.

**BOARD CHAIRPERSON MILLER-ANDERSON:** ... just check on, check on the 18<sup>th</sup> with everyone and then check with Scott and see if we are going to use the January 31<sup>st</sup> date, to make up a CRA, that 10<sup>th</sup>.., our January 10<sup>th</sup> meeting. And we can kinda throw out a few other dates and see if, um, what works.

**CITY MANAGER HOSKINS:** Okay. And remember, on Monday night, you scheduled the sales surtax and the...

**BOARD CHAIRPERSON MILLER-ANDERSON:** Monday, what day? Which one?

**CITY MANAGER HOSKINS:** Monday you scheduled for January 18<sup>th</sup> to have a City Council workshop on the...

BOARD CHAIRPERSON MILLER-ANDERSON: Okay. So...

**CITY MANAGER HOSKINS:** ....sales surtax and the Youth Summer Program.

**BOARD CHAIRPERSON MILLER-ANDERSON:** So did.., so, maybe the conversation was we wouldn't have it on that day because we were going to be doing something already. So, we've already committed to having the 18<sup>th</sup> as our workshop day. Okay. So, just get with everyone, Ms. Hoskins, in regards to all of those workshops, Mr. Horton's request and Scott.

**BOARD MEMBER HUBBARD:** What did she say the workshops were for?

**BOARD CHAIRPERSON MILLER-ANDERSON:** The Youth Employment and the sales tax.

**CITY MANAGER HOSKINS:** The sales surtax and the Youth.., the Summer Youth Employment Program.

BOARD CHAIRPERSON MILLER-ANDERSON: Alright. Is that it, Mr. Horton?

**EXECUTIVE DIRECTOR OF UTILITY SPECIAL DISTRICT HORTON:** Madam Chair, I have a.., I found an Item I'd like to bring before the Board.

BOARD CHAIRPERSON MILLER-ANDERSON: Mhmm.

**EXECUTIVE DIRECTOR OF UTILITY SPECIAL DISTRICT HORTON:** In an effort to really move things forward with a lot of the projects that need to move forth from the capital program, I would like concurrence from the Board to move forth with an RFQ to request qualifications of additional engineers, to get additional engineering services for the District. If the Board concurs with that tonight, I would move forward working with Procurement to make that happen and try to bring it back before the Board, um, probably February or March.

**BOARD CHAIRPERSON MILLER-ANDERSON:** What services is that for?

**EXECUTIVE DIRECTOR OF UTILITY SPECIAL DISTRICT HORTON:** In.., professional engineering services.

BOARD MEMBER DAVIS: Madam Chair?

**BOARD CHAIRPERSON MILLER-ANDERSON:** Go ahead.

**BOARD MEMBER DAVIS:** I have no issue with it. I support it.

BOARD MEMBER HUBBARD: And... Madam Chair?

**BOARD CHAIRPERSON MILLER-ANDERSON:** Go ahead.

**BOARD MEMBER HUBBARD:** Mr. Horton, this is to expand the list beyond what we are currently working with.

**EXECUTIVE DIRECTOR OF UTILITY SPECIAL DISTRICT HORTON:** That is correct.

BOARD MEMBER HUBBARD: Okay.
