- 1 CHAIR MILLER-ANDERSON: We're going to go ahead and get
- 2 started with the CRA meeting here.
- 3 I want to call to order the Riviera Beach CRA meeting,
- 4 December 13, 2017, 6:00 p.m.
- 5 Madam, roll call.
- 6 (Upon roll call by Administrative Assistant Tamara Seguin, the
- 7 following were present: Chair KaShamba Miller-Anderson,
- 8 Commissioner Terence Davis, Commissioner Lynne Hubbard,
- 9 Commissioner Dawn Pardo. Also present: Attorney Michael
- 10 Haygood and Interim Executive Director Scott Evans.)
- 11 CHAIR MILLER-ANDERSON: We'll have a moment of silence,
- 12 followed by the Pledge led by Councilwoman Hubbard.
- 13 (Moment of silence, followed by the Pledge of Allegiance.)
- 14 CHAIR MILLER-ANDERSON: Do we have any additions and
- 15 deletions?
- 16 INTERIM EXECUTIVE DIRECTOR EVANS: No, Chairperson
- 17 Miller-Anderson.
- 18 CHAIR MILLER-ANDERSON: Let the record reflect Councilwoman
- 19 Davis Johnson is on the dais.
- 20 Any disclosures by commission or staff?
- Do we have a motion to adopt the agenda?
- 22 COMMISSIONER PARDO: So moved.
- 23 COMMISSIONER DAVIS: Second.
- 24 CHAIR MILLER-ANDERSON: Madam Clerk.
- 25 (Vote taken.)

- 1 THE CLERK: Motion carries.
- 2 (Motion passed unanimously.)
- 3 CHAIR MILLER-ANDERSON: Consent agenda. Any person who
- 4 would like to speak on an agenda item please fill out a blue
- 5 public comment card located in the back of council chambers and
- 6 give it to the staff prior to the beginning of the meeting.
- 7 Members of the public shall be given a total of three minutes
- 8 for all items listed on the consent agenda. Members of the
- 9 public will be given three minutes to speak on each regular
- 10 agenda item. In no event will anyone be allowed to speak on an
- 11 agenda item after the resolution is read or the item is
- 12 considered.
- Do we have anyone that would like to pull an item from the
- 14 consent agenda?
- 15 VICE CHAIR DAVIS JOHNSON: Madam Chair, I'd like to pull
- 16 item 2.
- 17 CHAIR MILLER-ANDERSON: Item 2.
- 18 Anyone else?
- Do we have a motion for the consent agenda with item number
- 20 2 being pulled?
- 21 COMMISSIONER DAVIS: So moved.
- 22 COMMISSIONER PARDO: Second.
- 23 (Vote taken.)
- 24 THE CLERK: Motion carries.
- 25 (Motion passed unanimously.)

- 1 CHAIR MILLER-ANDERSON: Item number 2.
- VICE CHAIR DAVIS JOHNSON: The question that I have --
- CHAIR MILLER-ANDERSON: Hold on. Do you want to read off
- 4 item number 2?
- 5 THE CLERK: Item number 2, Request for the approval of
- 6 minutes, November 29, 2017 CRA Workshop.
- 7 CHAIR MILLER-ANDERSON: Go ahead, Ms. Davis Johnson.
- 8 VICE CHAIR DAVIS JOHNSON: The question that I have, I
- 9 believe that I was late to the meeting. I came in late to the
- 10 meeting but I don't see in the minutes where it was reflected.
- 11 THE CLERK: I believe you came in late at the end of the
- 12 first meeting.
- 13 VICE CHAIR DAVIS JOHNSON: No, not at the workshop. These
- 14 are the minutes -- I want the regular minutes, item 1, I'm
- 15 sorry.
- 16 CHAIR MILLER-ANDERSON: You want 1 or 2?
- 17 VICE CHAIR DAVIS JOHNSON: One.
- 18 CHAIR MILLER-ANDERSON: Okay. So we'll make a correction
- 19 for item 1 to be pulled instead of 2.
- 20 VICE CHAIR DAVIS JOHNSON: Thank you.
- 21 COMMISSIONER DAVIS: So do we have to dismiss this motion
- 22 by approving this first and then reconsidering 2 -- 1?
- 23 CHAIR MILLER-ANDERSON: Ask your attorney over there.
- 24 COMMISSIONER DAVIS: Excuse me?
- 25 CHAIR MILLER-ANDERSON: Ask your attorney over there.

- 1 MR. HAYGOOD: It may be best to, just for the record, to
- 2 clarify that the consent agenda was approved except for item 1.
- 3 So if you just redo the motion. I apologize.
- 4 CHAIR MILLER-ANDERSON: Say that again.
- 5 MR. HAYGOOD: If you would just restate the motion and say
- 6 that it's being approved except for item 1, correcting the
- 7 record.
- 8 CHAIR MILLER-ANDERSON: So we're striking -- we're going to
- 9 withdraw that other motion --
- 10 MR. HAYGOOD: Yes, ma'am.
- 11 CHAIR MILLER-ANDERSON: -- to accept all of the other?
- MR. HAYGOOD: Yes.
- 13 CHAIR MILLER-ANDERSON: Because we accepted 1 and 3, and
- 14 pulled 2.
- MR. HAYGOOD: Yes. Just restate the motion.
- 16 CHAIR MILLER-ANDERSON: That we're pulling item number 1
- instead of item number 2.
- MR. HAYGOOD: Yes, ma'am.
- 19 CHAIR MILLER-ANDERSON: And will that motion -- second
- 20 still stand? For those who made the motion --
- 21 COMMISSIONER PARDO: Yeah. Madam --
- 22 CHAIR MILLER-ANDERSON: -- and the second?
- 23 COMMISSIONER PARDO: -- Chair. Madam Chair. So I made the
- 24 motion, so I would like to rescind the original motion. My new
- 25 motion is to approve item 2 and 3 and pull item 1.

Page 6 COMMISSIONER DAVIS: Second still stands. CHAIR MILLER-ANDERSON: Alright. 3 (Vote taken.) THE CLERK: Motion carries. 4 5 (Motion passes unanimously.) CHAIR MILLER-ANDERSON: So item number 1. VICE CHAIR DAVIS JOHNSON: Thank you, Madam Chair. I remember attending late but I don't show where I was recognized as having been on the dais. Or does --9 MS. HATCHER: It's actually on page 15. 10 11 VICE CHAIR DAVIS JOHNSON: I sure didn't see it. Hold on. MS. HATCHER? "Chair Miller-Anderson: Let the record 12 reflect Ms. Davis Johnson is on the dais." 13 VICE CHAIR DAVIS JOHNSON: Where? 14 MS. HATCHER: On page 15. 15 16 VICE CHAIR DAVIS JOHNSON: I'm looking at page 15. 17 MS. HATCHER: Under regular minutes. VICE CHAIR DAVIS JOHNSON: Okay. I overlooked that. 18 Because I got through the end and I was like when do I start 19 talking, when was I recognized. Thank you for pointing that 20 21 out. Because I do read them. I just overlooked it. Thank you. 22 CHAIR MILLER-ANDERSON: Anyone else for item number 1? 23 Madam Clerk. 24 (Vote taken.) 25 THE CLERK: Motion carries.

- 1 (Motion passes unanimously.)
- 2 CHAIR MILLER-ANDERSON: That's the end of the consent
- 3 agenda.
- 4 Regular business, item number 4.
- 5 THE CLERK: A resolution of the Board of Commissioners of
- 6 the Riviera Beach Community Redevelopment Agency approving
- 7 amendments to the Agency's Comprehensive Policies and Procedures
- 8 Manual, providing an effective date.
- 9 COMMISSIONER PARDO: So moved.
- 10 CHAIR MILLER-ANDERSON: Do we have a second?
- 11 COMMISSIONER DAVIS: Second.
- 12 CHAIR MILLER-ANDERSON: Okay. Who is presenting?
- 13 INTERIM EXECUTIVE DIRECTOR EVANS: Good evening, Board.
- 14 In October we extended Palm Beach Consulting Group's
- 15 contract, Mr. Arnold Broussard's work to complete assisting us
- 16 in our Finance Department as interim finance director; and we
- 17 also added some work to help us move forward, some policies and
- 18 procedures update.
- 19 And Mr. Broussard has a brief presentation on this agenda
- 20 item.
- 21 CHAIR MILLER-ANDERSON: Okay.
- 22 MR. BROUSSARD: Madam Chairperson, members of the Board of
- 23 Commissioners. Thank you for this opportunity to appear before
- 24 you.
- 25 In front of you you have -- probably one of the most

- 1 important things that an organization does is the putting in
- 2 place a policies and procedures manual which identifies and lays
- 3 out and presents the -- in many ways the day-to-day operational
- 4 activities that staff go through; and in the case of the
- 5 situation where we have a board where the board interacts with
- 6 staff.
- 7 What we've done is the interim executive director
- 8 identified several areas that he wanted to start to address in
- 9 terms of bringing the CRA's policies and procedures more in line
- 10 with those policies and procedures followed by the, by the City.
- 11 Especially over the past year, with your assistance and
- 12 direction and guidance we, the CRA has been moving to move its
- 13 financial operations under the, under the oversight and
- 14 management of the City's Finance Department. And with that we
- 15 will gain a number of operational efficiencies and the interim
- 16 CRA director will have the ability of having senior financial
- 17 support and management over the Finance Department staff of the
- 18 agency.

19

- 20 In connection with that we identified several areas that we
- 21 wanted to be able to address immediately in terms of redoing
- 22 some of the policies and procedures of the agency. And at the
- 23 same time make the board aware of the fact that there will be a
- 24 need for us to comprehensively look at the policies and
- 25 procedures manual, policies and procedures that the agency

- 1 follows, as we become more in line with the City's operations.
- 2 Little by little we -- you know, given the fact that the
- 3 CRA has some very specific legal mandates that it must follow
- 4 from a programmatic standpoint. From an operational standpoint
- 5 the agency can look more and more like a city department in many
- 6 ways. And that's one of the main things that we're trying to be
- 7 able to accomplish.
- 8 So what we have in front of you identify two separate
- 9 categories of policies and procedures. The category A ones,
- 10 there were two areas that were addressed by the agency's
- 11 auditors during the last audit that would require a change in
- 12 agency policy. And one of those areas dealt with the fact that
- 13 the, that the agency and the city had difficulties in
- 14 reconciling balances, receivables and payable balances between
- 15 the City and the CRA. And during the audit from two years ago,
- 16 and not as much the last year's audit, those differences or the
- 17 reconciliation of those differences created some major problems
- 18 with respect to the City being able to finish and complete its
- 19 audit that's mandated by the state.
- 20 So one of the findings that we're addressing is a finding
- 21 that was mentioned in the 2015 audit, and then it came up again
- 22 in the 2016 audit. And we have made some procedural changes
- 23 there, and we need to get your approval to incorporate that
- 24 change and the next change that I'll discuss to the CRA's
- 25 procedures manual.

- 1 The second area that the auditors identified dealt with
- 2 long outstanding checks that the agency had written that would
- 3 not -- had not been cashed by the individuals who the checks
- 4 were written to. And according to state law at a point those
- 5 amounts, if an entity cannot find the owner of those funds, then
- 6 they should be turned over to the state in the unclaimed
- 7 property area; and it becomes the state's responsibility to
- 8 either find the owners of those funds or to otherwise dispose of
- 9 those properties, if you will.
- 10 So these two procedures were, you know, were somewhat
- 11 fairly straightforward in terms of us putting together
- 12 procedures in order to be able to address them and identify them
- in category A, because I think they're very much different from
- 14 the ones that we have in the second category and that I'll
- 15 discuss soon.
- 16 So I'll first start off by asking you if you have any
- 17 questions on those two areas.
- 18 CHAIR MILLER-ANDERSON: Anyone have any questions?
- 19 COMMISSIONER PARDO: Yeah. Madam Chair.
- 20 CHAIR MILLER-ANDERSON: Go ahead.
- 21 MR. BROUSSARD: Yeah, and I apologize. These policies and
- 22 procedures are probably the next worst thing to -- it's like
- 23 having a root canal. It's not an exciting topic area.
- 24 COMMISSIONER PARDO: No. But, you know what, but sometimes
- 25 we really need to revisit them.

- 1 MR. BROUSSARD: Absolutely.
- 2 COMMISSIONER PARDO: Okay. So you mentioned the checks
- 3 that have not been cashed.
- 4 MR. BROUSSARD: Yes.
- 5 COMMISSIONER PARDO: Is that the same policy that the City
- 6 has?
- 7 MR. BROUSSARD: I don't know what the -- I don't know what
- 8 policy the City is following. What we did was the auditors
- 9 identified the section of state law that needed to be addressed,
- 10 and that's what we went to --
- 11 COMMISSIONER PARDO: Do we have a number of checks still
- 12 outstanding?
- MR. BROUSSARD: It's a small amount. It's not that they
- 14 were major in terms of amounts or the number, it was more the
- 15 fact that we had a few that were there that we had not done
- 16 anything with.
- 17 COMMISSIONER PARDO: Thank you.
- MR. BROUSSARD: But it was not material, nothing material.
- 19 COMMISSIONER PARDO: Okay. Thank you.
- 20 CHAIR MILLER-ANDERSON: Anyone else? Questions?
- 21 MR. BROUSSARD: Okay. The second category of policies and
- 22 procedures dealt with annual and sick leave, travel, small
- 23 purchases, and the use of purchasing cards.
- In the annual and sick leave area, again these were two
- $25\,$ $\,$ areas that the CRA in terms of looking at what it does as

- 1 opposed to what the City does, there were some very minor
- 2 differences that existed. One of the major areas was in the
- 3 area of annual leave, where the City has a -- for employees who
- 4 have been with the City in excess of five years, there's a
- 5 little bit of an increase in the number of annual leave -- in
- 6 the amount of annual leave that may be awarded to an employee
- 7 who has been with the City for in excess of five years. Other
- 8 than that the basic procedures that are in place at the CRA and
- 9 the City were very much in line. The City's procedures were in
- 10 more detail. And I felt it was -- in terms of the review that I
- 11 was making I felt that given the amount of additional discussion
- 12 if you will that the City had in terms of its policies and
- 13 procedures that it might be better for us to more -- to better
- 14 utilize what the City was doing from the standpoint of the
- 15 clarification that it provided to -- in this particular area.
- 16 There are also minor word changes that were made because I
- don't write the same way that whoever wrote the City's
- 18 procedures wrote. But other than that, and correcting some of
- 19 the wording, if you will, the basic policies and procedures in
- 20 those two areas are basically the same.
- 21 And what I'll try to do is address, if you don't mind,
- 22 answer any questions that you might have as it relates to annual
- 23 and sick leave before moving on.
- 24 COMMISSIONER DAVIS: Madam Chair.
- 25 VICE CHAIR DAVIS JOHNSON: Mr. Davis.

- 1 COMMISSIONER DAVIS: I just want to say to Mr. Broussard --
- THE WITNESS: Sir? I'm sorry, Mr. Davis.
- 3 COMMISSIONER DAVIS: I just want to say thank you for,
- 4 definitely for the work that you've done. We're helping tighten
- 5 up these departments and providing a stronger structure in place
- 6 so that we can have something to build off of. This is
- 7 something that would never get promoted, that we're actually
- 8 doing our job, we're making sure we're having transparency and
- 9 things that allows us to follow a simple blueprint. And I want
- 10 to say thank you for your job, for the effort and the time. I
- 11 can see from reading there's a lot of time put into this. But I
- 12 didn't have any other -- no other questions at this time. But I
- 13 just wanted to say just thank you for the work that you've done
- 14 on this particular item.
- 15 MR. BROUSSARD: Thank you for your comments, Mr. Davis.
- 16 I'd like to go on to the small purchases area at this
- 17 stage. Small purchases are identified as purchases of \$25,000
- 18 or less. The issue area that the CRA was having is one that had
- 19 been basically addressed by the City but not by the CRA and that
- 20 was purchases, small purchases up to, up to and including \$2500.
- 21 The process that's normally, that has normally been followed at
- 22 the CRA is for purchases under \$25,000, that in order to
- 23 identify a competitive price, if you will, three quotations were
- 24 requested.
- 25 The City -- the City's policies and procedures more

- 1 specifically look at small -- well, small purchases are
- 2 identified too as \$25,000 and below. But at the same time when
- 3 you come to a purchase of \$2500 or less the City has an
- 4 abbreviated procedure in place generally that can be followed by
- 5 staff. And we're talking about \$2500 or less; most of the time
- 6 it's the or less. Because if somebody wants to buy some memo
- 7 pads, you know, they've had to go through the process of making
- 8 three -- you know, of getting three quotations on memo pads in
- 9 order to make a purchase, which becomes quite an inefficient
- 10 process at a period -- at a point, you know, because, you know,
- 11 things like that you can easily, you know, find competitive
- 12 prices at Office Depot or Staples, and it's just a matter of
- 13 you're looking at an ad in a paper sometimes and being able to
- 14 identify some of those things. So it became -- it becomes
- 15 burdensome on small purchases, small purchase like that. And
- 16 what the City has done is it allows, it allows employees to, you
- 17 know, to make small purchases like that without having to go
- 18 through that three, you know, bid process or three quotation
- 19 process, but go through the process of looking for competitive
- 20 prices and then documenting what those, you know, those
- 21 competitive prices might be. And what this procedure, what the
- 22 proposed procedure does is one that basically tracks what the
- 23 City's policy is and procedures are in that purchase of items of
- 24 \$2500 or less. That's the only addition, if you will, to the
- 25 procedure that's proposed.

- 1 And I'll stop and address any questions again at this
- 2 point.
- 3 VICE CHAIR DAVIS JOHNSON: Are there any questions for
- 4 Mr. Broussard regarding the small purchases?
- 5 Hearing none, please proceed, Mr. Broussard.
- 6 MR. BROUSSARD: The next area is purchasing cards or credit
- 7 cards. The City at a -- commissioners at a point in time had
- 8 CRA credit cards. And as you realize -- you know, today you
- 9 don't have CRA credit cards. But determination was made -- the
- 10 City made a determination to allow council members and
- 11 commissioners the ability to use the credit cards that they had
- 12 for the City to also make purchases that were CRA related. And
- 13 that they process all of the paper the same way, necessary
- 14 communications are made between the CRA -- I mean between the
- 15 City and the CRA as those purchases are made and reconciled in
- 16 order to keep track of purchases but --
- 17 COMMISSIONER PARDO: Madam Chair.
- 18 CHAIR MILLER-ANDERSON: Go ahead.
- 19 COMMISSIONER PARDO: Okay. But I think you need to make it
- 20 clear that the only purchases that the commission can use their
- 21 credit card for is travel, and that's it. So I think it -- you
- 22 know, you just need to make that clear. We're just using it for
- 23 travel and nothing else. Not supplies, promotion, nothing.
- 24 Just travel.
- MR. BROUSSARD: You're quite right, Commissioner Pardo.

- 1 Travel is the primary area where those cards are being used.
- 2 COMMISSIONER PARDO: The only area.
- 3 MR. BROUSSARD: And with the work that we're doing in terms
- 4 of coming under the control of the City, if you will, from the
- 5 finance standpoint, you know, that process should and will
- 6 continue to work I think fairly effectively for the CRA and the
- 7 City. We're not aware of any -- I haven't been made of any --
- 8 although I haven't talked with any of you all directly, in my
- 9 communications with the Finance Department I haven't identified,
- 10 you know, any areas where the use of that one card has presented
- 11 a problem for the purposes that, you know, that you all have
- 12 used the card in the past.
- So from the standpoint of the CRA, the procedure that's in
- 14 front of you, proposed procedure that's in front of you right
- 15 now very specifically deals with CRA employees and does not
- 16 cover the issuance or the control of purchasing cards by
- 17 commissioners because you don't have any. And it's not proposed
- 18 at this time that you have this type of card issued by the CRA.
- 19 So the procedure that's in front of you right now is
- 20 basically what the City does in terms of procurement cards, but
- 21 it's very particular and very specific as it relates to the, to
- 22 CRA -- issuance of credit cards or purchasing cards to CRA
- 23 employees.
- 24 CHAIR MILLER-ANDERSON: Alright.
- MR. BROUSSARD: And I'll address, you know, any -- if there

- 1 are any questions that you might have along those lines.
- 2 CHAIR MILLER-ANDERSON: Anyone have any questions?
- 3 MR. BROUSSARD: I saved the best one for last. Travel.
- 4 The travel, the proposed travel policy, and what I did was in
- 5 looking at the proposed travel policy we took the City's travel
- 6 policy and went through the City's travel policy word for word.
- 7 You know, there are some changes, there are some differences
- 8 between what the City did and what the CRA did. One of the
- 9 major ones was in the area of using the GSA schedule that the,
- 10 that the federal government uses. And it was primarily used in
- order to facilitate a process for dealing with costs associated
- 12 with travel to high cost areas, New York, Washington, D.C., you
- 13 know, places like that. Many other cities pretty much fall
- 14 into -- you know, there may be some regional, you know, regional
- 15 highs and lows but there are some very high cost areas; and the
- 16 GSA schedule pretty much tracked and followed those. But as we
- 17 went through the -- as we went through the -- and using the GSA
- 18 schedule created some problems for the CRA in terms of the last
- 19 audit that we had. And I'm not sure if it was a problem with
- 20 just the auditors understanding what the -- how the policy
- 21 worked. But it turned out to be more convenient for us to look
- 22 at the City's approach because the City's approach gives the,
- 23 you know, we feel gives the traveler, in this case our
- 24 commissioners and the executive director and those few staff
- 25 people who travel, it gives those individuals the same

- 1 flexibility to be able to deal with some of those high cost
- 2 situations without running into a situation where it creates
- 3 just an administrative burden if you will or a nightmare in
- 4 terms of being able to administer.
- 5 So, you know, from a travel standpoint one of the things
- 6 that we did, the City's policy, excuse me, the City's policy and
- 7 procedures specifically indicates that the city council members,
- 8 the city manager, and the city attorney make their own travel
- 9 arrangements. The CRA's policy was different than that because
- 10 it identified the executive director as approving the travel for
- 11 board members.
- The way the policy reads right now tracks the City policy
- in that board member travel is authorized by board members, and
- 14 the executive director authorizes his or her travel and any
- 15 travel of people travelling on behalf of the CRA or CRA staff.
- 16 And that -- those two areas are the primary areas where
- 17 there's a difference between what the City does and what the CRA
- 18 used to do. And again we're coming more in line with what the
- 19 City's policies are. And hoping that as we step through not
- 20 only the policy changes that we're recommending to you today but
- 21 as we look at any policy and procedural changes moving forward,
- 22 that this represents an effort, you know, to give you a
- 23 situation where you're dealing with one set of rules, you don't
- 24 have to worry about a CRA set of rules and the City's set of
- 25 rules in the process. Things should be simplified from that

- 1 standpoint, from the standpoint of staff, with the relationship
- 2 being brought closer to the city, there's one set of rules that
- 3 the staff follows and they're basically going to be the same set
- 4 of rules that are followed by the City. And only in those areas
- 5 where we -- where there's a need from a statutory standpoint or
- 6 a problematic standpoint, where there needs to be a difference,
- 7 will there be identified, you know, any change, if you will, in
- 8 the proposed policies and procedures. And I'll open up to any
- 9 questions as it relates to travel.
- 10 CHAIR MILLER-ANDERSON: Do we have anyone that have any
- 11 questions or concerns?
- 12 COMMISSIONER HUBBARD: None, Madam Chair, for me.
- 13 CHAIR MILLER-ANDERSON: Anyone else?
- 14 COMMISSIONER DAVIS: Madam Chair.
- 15 CHAIR MILLER-ANDERSON: Go ahead.
- 16 COMMISSIONER DAVIS: While I do support this item, the one
- 17 concern I've always had, CRA staff has always spent quite a bit
- 18 of time on our items when it comes to travel. So now as this
- 19 has shifted over to the City's -- well, the records and stuff
- 20 which we submitted to the City, our staff will be taking on that
- 21 responsibility.
- Now, on the City's side --
- 23 MR. BROUSSARD: I'm glad you raised that but I'll --
- 24 COMMISSIONER DAVIS: I'll wait.
- MR. BROUSSARD: Finish your question. But I'm glad you

- 1 raised that.
- 2 COMMISSIONER DAVIS: One of the things is though, how do we
- 3 address now that staff is going to be doing something for an
- 4 entity that they're not employed by or receiving any kind of
- 5 compensation for?
- 6 MR. BROUSSARD: From the City's standpoint?
- 7 COMMISSIONER DAVIS: From the City's standpoint. Because
- 8 the City's staff now has to do all the reconciliations.
- 9 MR. BROUSSARD: I'm going to address that one first and
- 10 then I'm going to go to -- you know, to answer another question
- 11 that I feel was implied in the -- you know, in where you were
- 12 going.
- Right now the CRA pays the City for certain services that
- 14 it provides to the Agency. Purchasing, you know, the City
- 15 handles, the City handles our purchasing, the CRA's purchasing.
- 16 Human resources, the City handles the CRA's human resources, you
- 17 know, issues. There are a lot of things that are happening
- 18 right now that the City provides services for and the CRA pays,
- 19 you know, pays, you know, it's budgeted and, you know, it's been
- 20 approved by you from the CRA's budget stand -- your side, and by
- 21 the City Council as it relates to the, you know, the City's
- 22 budget, if you will.
- 23 And the one thing that we keep in mind is that -- and, you
- 24 know, at Mr. Evans' direction I made sure that I talked with the
- 25 City Finance Director to make sure that, you know, the work that

- 1 we were talking about them picking up, you know, from the --
- 2 that the City's Finance Department is going to be picking up,
- 3 that is going to be covered under the budget that's in place or
- 4 we'll have discussions about what needs to be done in order to
- 5 modify that. So we're thinking about things from that, you
- 6 know, definitely from that standpoint.
- 7 COMMISSIONER DAVIS: So the person that now would be
- 8 working on the City's side -- that was working on the CRA's
- 9 side -- will be handling that responsibility on the City's side?
- 10 MR. BROUSSARD: Now I'm going to get to that part of your
- 11 question.
- 12 The City -- the CRA still has a -- just like -- and I'll
- 13 use the Recreation Department. The Recreation Department has an
- 14 accountant internally within the Recreation Department who has a
- 15 relationship and relates to the Finance Department. That
- 16 accountant, you know, they do all of the paperwork processes,
- 17 all of the requisitions, purchase orders, you know, they do all
- 18 of that for the Recreation Department. Send their paperwork
- 19 into the Finance Department for overall review, budget checks,
- 20 and processing. Your payments come out of the Finance
- 21 Department, but all of it's based upon the work that the
- 22 accountant for the Recreation Department, you know, the
- 23 interface that they have. We still will have -- the CRA will
- 24 still have a staff -- accountants on staff to perform that same
- 25 function. And they're going to be interacting with and relating

- 1 to the Finance Department the same way that any other
- 2 departmental city department accounting staff person, you know,
- 3 would be.
- 4 The Finance Department will be writing, you know, will be
- 5 processing purchase orders, you know, like they do for the
- 6 Recreation Department. They'll be writing checks for the CRA
- 7 like they do for the Recreation Department. You know, a lot of
- 8 those activities will be handled, you know, through the Finance
- 9 Department, you know, based on, you know, that type of
- 10 relationship.
- Now, there's still pieces that have to be worked out in
- 12 that process. I'm not going to say to you that, you know, that
- 13 everything is done but -- because this is a -- you know, we're
- 14 in transition, you know, the City Finance Department is working
- 15 with our, with the CRA staff, you know, in order to, in order to
- 16 make all of the pieces work. So we're in transition. But as we
- 17 see it there shouldn't be any difficulties moving forward.
- 18 So in many ways we're going to look just like a department,
- 19 if you will, of the City from an operational standpoint.
- 20 CHAIR MILLER-ANDERSON: That's it?
- 21 Anyone else? Other questions?
- That's the end of your presentation?
- 23 MR. BROUSSARD: That's it.
- 24 CHAIR MILLER-ANDERSON: Madam Clerk.
- 25 (Vote taken.)

- 1 THE CLERK: Motion carries.
- 2 (Motion passes unanimously.)
- 3 CHAIR MILLER-ANDERSON: Item number 5.
- 4 THE CLERK: A resolution of the Board of Commissioners of
- 5 the Riviera Beach Community Redevelopment Agency authorizing the
- 6 execution of a Development Agreement, Agreement for Sale and
- 7 Purchase, and properties of Distinction Grant Agreement, by and
- 8 between the Agency and Blue Lagoon Plaza, LLC, for the sale and
- 9 development of the Blue Lagoon Plaza; finding that the sales
- 10 price represents fair value; finding that the project eliminates
- 11 slum and blight; and directing and authorizing the chairman and
- 12 executive director to take such actions as shall be necessary
- 13 and consistent to carry out the intent and desire of the Agency;
- 14 providing an effective date.
- 15 COMMISSIONER PARDO: So moved.
- 16 COMMISSIONER DAVIS: Second.
- 17 CHAIR MILLER-ANDERSON: Okay.
- 18 INTERIM EXECUTIVE DIRECTOR EVANS: Good evening, Members of
- 19 the Board.
- The proposed agenda item and resolution is the next step in
- 21 the redevelopment of CRA owned property. It's located on the
- 22 northwest corner of Avenue F and Blue Heron Boulevard. And this
- 23 is a picture of the site right there.
- 24 On March 29th the CRA Board approved resolution accepting
- 25 the proposal from Blue Lagoon Plaza, LLC, to redevelop the

- 1 property. And the address is 200 West Blue Heron Boulevard.
- 2 The proposal comes from Mr. George Steel, who's operated Tony's
- 3 Subs Restaurant for the last 21 years, located at 64 West 21st
- 4 Street in Riviera Beach. And the board authorized staff to
- 5 negotiate a development agreement to include a property of
- 6 distinction grant and the sale of the property to bring a new
- 7 commercial building that would allow Tony's Subs to relocate and
- 8 expand their business and operations.
- 9 At the meeting the board established high expectations for
- 10 the design of the building, and directed that the future tenants
- of the other two bays be controlled or limited in the
- 12 development agreement.
- And a picture of the concept plan is shown above. The plan
- 14 that was presented to the board, this was shown on September
- 15 27th, and it was developed by the applicant after the feedback
- 16 that was provided by the board in March. The project will build
- 17 three commercial spaces within a building that establishes a new
- 18 standard for commercial development on Blue Heron Boulevard, and
- 19 that will complete redevelopment of the site that was formerly
- 20 blighted and boarded up when the CRA first purchased it.
- 21 The largest space, approximately 2700 square feet, will be
- 22 used by Tony's Subs for their relocated restaurant. And the
- 23 development in order -- the development agreement before you
- 24 tonight includes two separate incentives. The first is a
- 25 Property of Distinction grant in the amount of \$195,000 to

- 1 complete the project. This grant is provided from the board
- 2 approved 2018 budget. The Property of Distinction Commercial
- 3 Grant Incentive Program enables the CRA to stimulate development
- 4 in our major corridors and it allows us to create customized
- 5 grants to leverage CRA dollars to bring new development to the
- 6 City.
- 7 The CRA will -- the second portion of the incentive is
- 8 we'll sell the property to the owner of Tony's Subs. Mr. Steel
- 9 offered the appraised value of \$180,000. We had the property
- 10 appraised in 2016. And then this debt would be held as a
- 11 subordinated mortgage for ten years at zero interest.
- 12 If the project has complied with all requirements of the
- 13 development agreement the mortgage will then be forgiven after
- 14 ten years.
- 15 Mr. Steel will prepare development plans, obtain
- 16 construction permits, build the new commercial building, and it
- 17 will have a total project value of over one million dollars on
- 18 the property.
- 19 The next step in the project following tonight would --
- 20 Mr. Steel will be required to complete a site plan application
- 21 to the City's Department of Community Development and obtain
- 22 site plan approval from the City Council. The CRA will only
- 23 disburse up to \$7,500 of the grant until the site plan is
- 24 approved and the construction loan is approved. And then once
- 25 it begins -- that once the project then moves forward the rest

- 1 of the grant would be disbursed.
- 2 At the previous meeting the CRA board expressed concern
- 3 about future tenants that would be located in the new project.
- 4 The proposed agreement allows a specific list of uses that are
- 5 permitted to be located on the site. These include office,
- 6 beauty salon, barber shop, medical office, retail -- but only
- 7 limited to clothing, flowers, arts and crafts, marine
- 8 accessories, and jewelry -- restaurants, professional services,
- 9 banking, security services, and media businesses such as web
- 10 design, social media and graphic arts. If the project wishes to
- 11 rent to a different tenant, then they'll be required -- other
- 12 than that approved list, then they'll be required to obtain CRA
- 13 Board approval.
- 14 The project will generate over \$100,000 in new tax revenue
- 15 over the next 10-year period. It brings a new much needed
- 16 commercial redevelopment to the Blue Heron corridor. And it
- 17 establishes a new standard of development.
- 18 It will also allow the expansion of an existing local
- 19 business who's been in the community over 20 years; and provide
- 20 space for two new businesses.
- 21 Mr. Paul Skyers has assisted the CRA to bring this project
- 22 forward, along with Mr. George Steel. And both of them are here
- 23 this evening as well.
- Thank you.
- 25 VICE CHAIR DAVIS JOHNSON: Madam Chair.

- 1 CHAIR MILLER-ANDERSON: Do we have any public comment cards
- 2 for this item?
- 3 THE CLERK: No, Madam Chair.
- 4 CHAIR MILLER-ANDERSON: Okay. Go ahead.
- 5 VICE CHAIR DAVIS JOHNSON: So I certainly am pleased to see
- 6 this come before us. And certainly I am pleased that we have
- 7 now -- and are now providing an opportunity for someone who's
- 8 been in the city for 20 plus years providing a service,
- 9 operating a business. So to see that growth, it shouldn't --
- 10 certainly it shouldn't take us 20 years. But we're at this
- 11 point, and I'm so elated that we are at this point.
- I am very appreciative of the fact that we have the user
- 13 restrictions in because we are trying to certainly brand the
- 14 corridor and help it to flow in line with what we will
- 15 ultimately do on Broadway.
- 16 But I want to congratulate you for staying the course, for
- 17 being diligent and persistent in wanting to see this dream
- 18 become a realty.
- 19 And certainly I am excited for us as a city to be able to
- 20 have a new project go online in that space, offering the
- 21 residents an opportunity to have a service, a restaurant where
- 22 they can get fresh foods prepared. So I am just elated.
- 23 And I want to commend Scott and the team, Mr. Skyers, thank
- 24 you so much for all of your efforts and making sure that our
- 25 desires were met. So I'm appreciative and I am most excited

- 1 about this project.
- 2 CHAIR MILLER-ANDERSON: Anyone else?
- 3 COMMISSIONER DAVIS: Madam Chair.
- 4 CHAIR MILLER-ANDERSON: Yes.
- 5 COMMISSIONER DAVIS: I must piggyback off what my colleague
- 6 just stated pertaining to this project. I've watched Mr. --
- 7 watched Tony and his family really go from a very small space
- 8 where they were next door in the very beginning to where they
- 9 are now currently, and it's great to see, you know, your son's
- 10 working as a police officer in this great city.
- 11 This is something that our residents, you know, this will
- 12 probably be one of the most proud ground breaking ceremonies for
- 13 myself, I would say. A piece of me would like to see could we
- 14 even do more to help this business, support this business. You
- 15 know, and I look at what we did for -- and what we did, we did
- 16 great, you know. I wish we could do even more financially to
- 17 support this business. Because this is -- we talk about
- 18 business being prepared. I hear my colleagues say all the time,
- 19 they need to have their stuff ready. And this is one of those
- 20 businesses that's done that for quite sometime, you know. But
- 21 I'm happy with what we have, you know. This day has come.
- 22 Thank you. I'm proud of you. You always have this board's
- 23 support. I don't -- there's no one in the city who's ever
- 24 talked anything but greatness about your business.
- 25 Especially -- I call it your flu soup. You know, your soup has

- 1 saved my life on plenty of flu seasons, and brought me back to
- 2 life.
- 3 And I want to say thank you all for doing such a wonderful
- 4 job, you know. This is, this is one of those nights that we can
- 5 proudly say job well done.
- 6 And I got to do this one time. And if the board says no,
- 7 cool. You know, I got to do it, it's in my heart. If it's in
- 8 our budget to do more to help out with the equipment, with the
- 9 grant, will my colleagues be willing to entertain some funds to
- 10 assist with the --
- MR. HAYGOOD: We have some restrictions on the use of the
- 12 money. We're trying to do vertical construction. Trying to
- 13 do -- and we went through the source and uses with Mr. Skyers so
- 14 that we tailored it to those areas that we thought we could
- 15 justify as far as use of the CRA money.
- 16 COMMISSIONER DAVIS: So what -- where on here that would be
- 17 justifiable?
- 18 MR. HAYGOOD: Say it -- I'm sorry?
- 19 COMMISSIONER DAVIS: Which item on here would be
- 20 justifiable?
- 21 MR. SKYERS: The CRA was challenged because of state rules
- 22 to be selective with regards to what kinds of equipment it could
- 23 use public funds to invest in. And standard is no rolling
- 24 stock. In other words, you can invest in an air conditioning
- 25 unit that's set up and fixed to the building. You can invest in

- 1 a hood system within a kitchen environment. But you can't
- 2 invest in the cart, anything that has wheels on it, that the
- 3 state frowns on so...
- 4 COMMISSIONER DAVIS: And that's what I was talking about
- 5 related to equipment. I know a lot of restaurants, those hoods,
- 6 those grease traps, cost quite a bit of money. If there's more
- 7 that this board can do to address that specific equipment, you
- 8 know, support of that, I would like to at least entertain some
- 9 conversations to discuss that, to see if it's possible that we
- 10 can do more to help. This business has done a wonderful job for
- 11 over the last decade.
- 12 COMMISSIONER HUBBARD: Madam Chair.
- 13 CHAIR MILLER-ANDERSON: Go ahead.
- 14 COMMISSIONER HUBBARD: I too am excited to see a small
- 15 business in the City of Riviera Beach grow. One especially who
- 16 I should own stock in. And have -- that they have -- they have
- 17 provided a service and they've always been very generous to the
- 18 community and have community days where they just give to the
- 19 community. So we are, we are pleased with you and we are
- 20 honored to have you as a business here. And we're glad to see
- 21 that you are the recipient of this particular award, and well
- 22 deserving.
- 23 You know, as you go along your way in developing this plan
- 24 and building this, if there, you know, is a need for you to come
- 25 back before us for further assistance, I would definitely go

- 1 along with entertaining that at that time.
- 2 And I too want to say I want to continue to see more small
- 3 business like yours thrive. And you're setting a good example.
- 4 And I think that it will give the rest of the community, small
- 5 businesses hope. Because a lot of times people just need to see
- 6 someone else ignite that light and see that, yes, we don't have
- 7 to give up, there's going to be opportunities for the local
- 8 small businesses, for the local residence.
- 9 And I know your daughter has purchased a home here, and
- 10 your son is serving for us, and you've served us, you know,
- 11 continually, so we definitely consider you a viable part of this
- 12 community. And I'm definitely entertaining -- interested in
- doing anything that we can to help. So if there is a need in
- 14 the future then I can look forward to you coming back to make us
- 15 aware of that.
- 16 Thank you. And congratulations.
- 17 COMMISSIONER PARDO: Madam Chair.
- 18 CHAIR MILLER-ANDERSON: Yes.
- 19 COMMISSIONER PARDO: Okay. Sir, congratulations. And
- 20 it's -- you know, my colleague said everything that needs to be
- 21 said. But I'm excited for you. I'm glad that the agency was
- 22 able to work out this financial plan with you. And, you know,
- 23 it's a, you know, another great day for the City of Riviera
- 24 Beach, because we're cleaning up another blighted parcel. And,
- 25 you know, little by little we're cleaning up the city. It takes

- 1 a long time. But it takes commitment from people like you who
- 2 are looking to expand, who are looking to build something
- 3 spectacular on that little blighted corner.
- 4 So I'm excited for you and I'm excited for everyone in the
- 5 City of Riviera Beach. Today is a good day. And I look forward
- 6 to cutting that ribbon, sir. So thank you.
- 7 CHAIR MILLER-ANDERSON: And I'd just like to say that I'm
- 8 especially excited because it is in District II and we have not
- 9 had a lot going on in our district for a while. So I'm very
- 10 pleased to see this coming along.
- I certainly would be in support of assisting you all in any
- 12 way that we can. But I just want to, you know, make sure that
- 13 we're cautious of, you know, just randomly doing this and
- 14 throwing it out there because as you all know we get calls, we
- 15 get e-mails all the time from different organizations,
- 16 businesses, non-profits, trying to get assistance. And I want
- 17 to make sure that we sort of be consistent in a way in which
- 18 we're assisting everyone. Because we don't want it to seem like
- 19 we favor one over the other. We want to see everyone thrive and
- 20 be successful.
- 21 So I'm certainly happy to see something new coming right
- 22 there at that corner. That corner has been empty for a very
- 23 long time. And as someone that is a resident in that area it
- 24 really pleases my heart to see something coming there. And one
- of the restaurants that many people go to any way. It's just a

- 1 little closer now, so we won't have to do as much travelling to
- 2 get to it.
- 3 So I just want to say congratulations to you all. And I
- 4 look forward to ground breaking day.
- 5 COMMISSIONER DAVIS: Madam Chair.
- 6 CHAIR MILLER-ANDERSON: Yes.
- 7 COMMISSIONER DAVIS: As we talk about other businesses
- 8 coming, one thing I know, we have three bays there; Tony's Subs
- 9 will be the catalyst, will be the draw. And I know, being the
- 10 man that he is, the man of God that he is, he will be the
- 11 catalyst that will help other businesses come to the area and be
- 12 sustainable.
- Helping this project -- well, not just helping just one
- 14 project -- helping this project helps three businesses. And,
- 15 you know, tomorrow is not promised to none of us. I don't know
- 16 what's going to happen to me when I leave this room today. But
- 17 this is an opportunity to help a business that's going to help
- 18 other businesses, where they won't have to come before us; and
- 19 that's less heavy lifting for us. And I definitely have to
- 20 definitely ask my colleagues to at least entertain doing
- 21 something that will help the other businesses, maybe creating an
- 22 allotment or something that may do the exterior signage for all
- 23 the businesses, all the bays there, as they promote the lot
- 24 or -- or cover an allotment that covers all the grease traps for
- 25 all the businesses that may come to the area or something. Not

- 1 just saying that a business may come -- there may be another
- 2 restaurant. But if they do, that we may have an allotment set
- 3 aside that we can address that so that that will help -- also
- 4 help out with any costs or any other future business that may
- 5 need to occur; and they won't have to come before this board to
- 6 ask for that assistance.
- 7 VICE CHAIR DAVIS JOHNSON: Madam Chair.
- 8 CHAIR MILLER-ANDERSON: Yes.
- 9 VICE CHAIR DAVIS JOHNSON: Mr. Davis, while I can
- 10 appreciate the sentiment that you're expressing, I think that it
- 11 is -- it would probably be improper for us to do such a thing
- 12 simply because when you have other businesses that are going to
- 13 go online that request is going to come back and we don't have
- 14 an abundance of funds to help with the establishment.
- 15 I think it's admirable. But I think that we have to
- 16 understand, and businesses have to understand, what the cost of
- 17 doing business looks like for them. And we cannot position
- 18 ourselves to financially become responsible for certain aspects
- 19 of the business's operation. So I think that, you know, we have
- 20 to be careful as to what we do. And I believe that with regards
- 21 to, I think it was vertical construction and those kinds of
- 22 things, and maybe there is some other grant that may possibly be
- 23 out there, but I think that we need to be a little careful when
- 24 we think about that.
- 25 Maybe there are some -- maybe the County has some dollars

- 1 through Housing and Economic Development.
- 2 COMMISSIONER DAVIS: Do they?
- 3 VICE CHAIR DAVIS JOHNSON: I don't know. It's a question
- 4 we can ask Mr. Brown, who is the new executive director there.
- 5 COMMISSIONER DAVIS: Here's why -- Madam Chair.
- 6 CHAIR MILLER-ANDERSON: Go ahead.
- 7 COMMISSIONER DAVIS: Here's why I said that. Because
- 8 looking at the last two years of what we've done in the CRA,
- 9 specifically District II and various areas of your area, the
- 10 only -- the last two years of grants that was expended was along
- 11 Dixie, which is JW, he had a strong grant, and what we had on
- 12 Broadway, was the exterior for --
- 13 COMMISSIONER PARDO: The facade program.
- 14 COMMISSIONER DAVIS: The facade program. There's a lot of
- 15 money that carry over -- that went back into the general fund
- 16 from last year. And there's a lot of funding that's still in
- 17 the budget that we will not expense this year coming because I
- 18 don't see any businesses coming online this year other than this
- 19 one project.
- 20 So being careful is one thing I would consider doing. But
- 21 if we're going to do something to help a business now, that we
- 22 haven't done a lot in the last two or three years, I don't see
- 23 anything happening for the next year or two significant that we
- 24 can say that's going to happen until -- outside of this marina
- 25 development project or some neighborhood improvements. And also

- 1 we got the potential housing issues that we're going to do, that
- 2 Mr. Evans at some point is going to bring back before this
- 3 board.
- 4 Like I said before, you know, I cannot go to sleep without
- 5 trying. And with this particular project, this is not about
- 6 favoritism. This is a project that's -- company that's been in
- 7 business for more than a decade. We all support this company.
- 8 This is a company that's bringing their own money. This is a
- 9 company that have their own lenders. They have their own
- 10 collateral. They have their own history. They have a structure
- 11 in place. They've done it right.
- 12 A lot of folks come before us need to see businesses like
- 13 this make it, and knowing what's required when they come before
- 14 us. And they can also go buy and as we all do go spend money
- 15 and eat there, to see what's being done. You know what, I went
- 16 before the board and I asked for this on this date but I see
- 17 what I didn't have because they had this, they had the finance,
- 18 they had their own money, you know, they had some things in
- 19 place that I didn't realize which was needed. So now I can
- 20 understand because in the next five years what is our plan to
- 21 spend any funding with a lot of the small businesses. Or who
- 22 are we recruiting, who are we having discussions with, and with
- 23 our future planning short-term and long-term.
- 24 So, you know, I just got -- you know, it's just something
- 25 to think -- Mr. Evans, I have a question.

- 1 INTERIM EXECUTIVE DIRECTOR EVANS: Yes, sir.
- 2 COMMISSIONER DAVIS: What do we have in our budget that we
- 3 haven't spent for this year for these businesses, this grant
- 4 program now?
- 5 INTERIM EXECUTIVE DIRECTOR EVANS: We have 350,000 reserved
- 6 for the commercial facade program. And that closes on December
- 7 22nd. So those applications will be ranked and brought before
- 8 you in February.
- 9 And then the Property of Distinction Grant Program has over
- 10 \$600,000 in it. And that money is earmarked for this project.
- 11 And then if the board decides to move forward with improvement
- 12 of the corner of Broadway and Blue Heron, which was the subject
- 13 of our workshop at the last meeting.
- 14 COMMISSIONER DAVIS: \$600,000 for which property?
- 15 INTERIM EXECUTIVE DIRECTOR EVANS: For Properties of
- 16 Distinction grants. So this project would utilize --
- 17 COMMISSIONER DAVIS: That's the project on Broadway and the
- 18 corner that we was discussing how we're going to spend the
- 19 funding?
- 20 INTERIM EXECUTIVE DIRECTOR EVANS: Yes. So it's not
- 21 expended at this time.
- COMMISSIONER DAVIS: So \$600,000 for Broadway improvements.
- 23 COMMISSIONER HUBBARD: And when does that close?
- 24 INTERIM EXECUTIVE DIRECTOR EVANS: Of the six hundred, two
- 25 hundred -- one hundred ninety-five would go to this project.

- 1 That would leave about four hundred --
- 2 COMMISSIONER PARDO: Madam Chair.
- 3 CHAIR MILLER-ANDERSON: Are you finished, Mr. Davis?
- COMMISSIONER DAVIS: Yeah, I'm done.
- 5 CHAIR MILLER-ANDERSON: Okay. Go ahead.
- 6 COMMISSIONER PARDO: Okay. One other thing we need to
- 7 remember. I understand what you're trying to do. And I totally
- 8 respect it. And if he feels, you know, once construction is
- 9 underway that he runs into an issue, he can always come back.
- But, you know, hopefully the moratorium that we have along
- 11 the Broadway corridor and along parts of Blue Heron Boulevard
- 12 are going to be lifted soon. And I know there are several
- 13 businesses that are chomping at the bit to be able to come in
- 14 and file plans with the City for some of the parcels along
- 15 Broadway. So I would hate to use all of the money that we have
- 16 allocated right now toward one project. And then, you know,
- 17 what we're doing then is just handcuffing ourselves and we won't
- 18 be able to assist other properties.
- 19 But like I said, if we don't -- you know, if he runs into
- 20 an issue, the other funds haven't been expended --
- 21 COMMISSIONER DAVIS: I can wait.
- 22 COMMISSIONER PARDO: -- then --
- 23 COMMISSIONER DAVIS: I'll wait.
- 24 COMMISSIONER PARDO: -- you know, then fine.
- 25 COMMISSIONER DAVIS: I'll wait.

COMMISSIONER DAVIS: Oh. So moved. 22 23 CHAIR MILLER-ANDERSON: Do we have a second? 24 COMMISSIONER DAVIS: Second. 25 CHAIR MILLER-ANDERSON: Mr. Evans.

- 1 INTERIM EXECUTIVE DIRECTOR EVANS: Yes. The CRA's Director
- of Neighborhood Services, Annetta Jenkins, will present this
- 3 item.
- 4 MS. JENKINS: Good evening. Annetta Jenkins, Director of
- 5 Neighborhood Services.
- 6 Commissioners, thank you for your attention to this matter.
- 7 This is a new lease for the 1101 Avenue E property. A
- 8 lease would be between the CRA and the Riviera Beach Community
- 9 Development Corporation.
- Just to give you a little background, in February of 2013
- 11 the CRA approved a similar lease with the Riviera Beach CDC,
- 12 that also included a sublease to Healthy Foods, Healthy Living.
- 13 That lease will expire on February 13th of 2018 and we are
- 14 bringing back a new lease to you to enter into a new five-year
- 15 opportunity with the CDC, with the intent for the same
- 16 programming on that site.
- 17 COMMISSIONER PARDO: Madam Chair?
- 18 CHAIR MILLER-ANDERSON: Are you finished, Ms. Jenkins?
- Do you have a question for Ms. Jenkins?
- 20 COMMISSIONER PARDO: Yeah. Are you done with your
- 21 presentation?
- MS. JENKINS: Yes.
- 23 COMMISSIONER PARDO: Thank you.
- 24 So when we approved this several years ago -- what was it?
- 25 Five years now?

- 1 MS. JENKINS: Yes.
- COMMISSIONER PARDO: -- so we approved a food bank. And
- 3 the food bank has turned into -- they're now distributing
- 4 limited clothing services for the homeless and near homeless
- 5 people, a referral service -- and I don't see it here, but
- 6 they're storing all kinds of stuff outside. I was there before
- 7 the hurricane, and they had all kinds of furniture, all kinds of
- 8 stuff, cars. And I went by after the hurricane and the stuff
- 9 was scattered everywhere. So -- and to me, I haven't been
- 10 inside the pantry in quite a while, but from the outside it
- 11 seems to me that there would be rodents all around because of
- 12 all the debris that is around there.
- So are we -- and I haven't been down there probably since
- 14 the hurricane, so I don't know what they finally did with all of
- 15 the items that they had. And there were multiple, multiple
- 16 items. So is anyone monitoring the food pantry? Are we
- 17 allowing them to store all of the furniture and cars and
- 18 everything else in there?
- 19 You know, it just seems to me it went from a food pantry to
- 20 a bring whatever you want and just drop it. And I don't think
- 21 that was the intent.
- 22 So perhaps you can go over and look at it.
- 23 And some of the neighbors around there complained about it.
- 24 INTERIM EXECUTIVE DIRECTOR EVANS: Commissioner Pardo, I do
- 25 share your sentiments.

- I met with the food bank two weeks ago to discuss how we
- 2 can -- how they need to make improvements to how they keep the
- 3 outside of the property. And we're working with them to try and
- 4 create a new awning that would help improve the outside. And
- 5 the agreement we have with them is that they will then no longer
- 6 continue to store all of those items outside that are a hazard
- 7 obviously to wind and just really not an acceptable place to
- 8 store furniture. So we are actively working with them to try
- 9 and get that site cleaned up.
- 10 COMMISSIONER PARDO: Well, I wish the site was cleaned up
- 11 prior to you bringing this contract to us. Because we need to
- 12 make certain that the, you know, that that facility is cleaned
- 13 up.
- 14 And, you know, I understand you want to put an awning, but
- 15 I don't want an awning out there so they can store more junk
- 16 under the awning. You know, it's...
- 17 CHAIR MILLER-ANDERSON: So did anyone else have any
- 18 questions or comments regarding? Maybe, Ms. Pardo, you would
- 19 like to motion that it comes back after the conversation that
- 20 they have? If anyone else has any comments.
- 21 MR. HAYGOOD: The only thing I would add, Madam Chair, is
- 22 the way the lease is drafted, it's limited -- it's to a food
- 23 distribution center.
- 24 COMMISSIONER PARDO: Exactly.
- MR. HAYGOOD: So I mean if in fact you pass -- you agree to

- 1 this, you can have some enforcement. You can default -- you
- 2 know, you have a -- have some teeth to it so you could go in and
- 3 default them or you do have some provision to make them comply
- 4 with.
- 5 CHAIR MILLER-ANDERSON: Yeah, but I would think that the
- 6 conversation -- if they've been operating in that manner for a
- 7 while you would want to have a conversation with them to let
- 8 them know that it's going to change prior to the lease being
- 9 signed.
- 10 COMMISSIONER PARDO: Yeah. Madam Chair.
- 11 CHAIR MILLER-ANDERSON: Yeah.
- 12 COMMISSIONER PARDO: Yeah. If no one else has a comment
- 13 I'd like to make a motion just to table this --
- 14 CHAIR MILLER-ANDERSON: Hold on. Did you have a comment?
- 15 VICE CHAIR DAVIS JOHNSON: Yeah. I simply want us not to
- 16 lose sight that she's providing a very valuable service. So
- 17 certainly if there are issues and there needs to be the clean up
- 18 then we can table it. But I don't want us to hold this up --
- 19 well, does it prevent --
- 20 CHAIR MILLER-ANDERSON: Well, it's not until February -- it
- 21 expires in February.
- 22 VICE CHAIR DAVIS JOHNSON: Okay. So she has time to come
- 23 into compliance. But I certainly want to see the service
- 24 continue on. And if Mr. Evans has already been in contact with
- 25 her and had conversations regarding this we should give her a

- 1 deadline to make those -- to come into compliance before it
- 2 comes back to us.
- 3 COMMISSIONER PARDO: And, Madam Chair --
- 4 CHAIR MILLER-ANDERSON: Go ahead.
- 5 COMMISSIONER PARDO: Yeah, and I totally agree, I don't
- 6 want to see the service go away. But I don't want the food
- 7 bank -- the food bank has turned into a junk yard. It really
- 8 has. So let's clean it up and bring the contract back.
- 9 COMMISSIONER DAVIS: Madam Chair.
- 10 CHAIR MILLER-ANDERSON: Go ahead.
- 11 COMMISSIONER DAVIS: The last time we was at this stage we
- 12 did discuss -- was the nonprofit still working with the food
- 13 bank?
- 14 MS. JENKINS: To the best of our ability, yes.
- 15 COMMISSIONER DAVIS: Okay. So are they two separate
- 16 entities or are they the same?
- 17 MS. JENKINS: I'm sorry. The food bank is operated by
- 18 Healthy Food, Healthy Living.
- 19 COMMISSIONER DAVIS: Which is a nonprofit, right?
- MS. JENKINS: Yes.
- 21 COMMISSIONER DAVIS: At any point have we had a chance to
- 22 review their books to see what they're taking in?
- 23 MS. JENKINS: We have not in the last 18 months. The
- 24 commission removed the requirement for us to be able to do that.
- 25 COMMISSIONER DAVIS: Because I remember there was a

- 1 discussion --
- 2 COMMISSIONER PARDO: Right. With Jim Gibbs.
- 3 COMMISSIONER DAVIS: -- with Mr. Jim Gibbs at the time,
- 4 that there's monies mixed -- stuff being donated and collected,
- 5 we not knowing how much and what is being collected with us.
- 6 While we do want to support the service we still need to know
- 7 what everyone is doing in that backyard. So I definitely want
- 8 to definitely at least ask nicely, you know.
- 9 MS. JENKINS: That was an original requirement in the
- 10 sublease agreement.
- 11 CHAIR MILLER-ANDERSON: Okay. You're done?
- 12 COMMISSIONER DAVIS: I guess. I think it would be -- if it
- does come back that would be one of the things I would like to
- 14 see questions being asked as they come -- as it comes -- that it
- 15 comes back with that information.
- 16 CHAIR MILLER-ANDERSON: Did you have any comments,
- 17 Ms. Hubbard?
- 18 COMMISSIONER DAVIS: That's all I have.
- 19 COMMISSIONER HUBBARD: My comment would be the -- based on
- 20 the services that that particular nonprofit provides, it sounds
- 21 like clothing for homeless, food for the needy; and the
- 22 donations that come there help to provide food and clothing, be
- 23 they clothing donations, food donations, or monetary donations.
- 24 Because if you do go out to that food pantry you have to pay for
- 25 gas, you have to rent the van, and you have to provide your own

- 1 persons to go with you to load and to come back and unload. So
- 2 there's costs associated with running that food service and
- 3 being a member of that -- to be able to pick up those foods from
- 4 the different facilities that allow them to get it.
- 5 I just want to understand a little bit more about us
- 6 looking at their books. Exactly what do we think that they are
- 7 receiving that we're missing out on?
- 8 COMMISSIONER DAVIS: Was that a question for me?
- 9 COMMISSIONER HUBBARD: Yes.
- 10 COMMISSIONER DAVIS: Here's the thing that have taken
- 11 place. When we approved this before there was questions about
- 12 that nonprofit, of how much funding they were getting.
- 13 COMMISSIONER HUBBARD: From who?
- 14 COMMISSIONER DAVIS: From people from all over the county,
- 15 if not the state. From those who have the resources to give
- 16 back. And with the lease agreement and how much they may or may
- 17 not have versus how we structure this lease does play a role.
- 18 So it was just something we didn't know because we never
- 19 had a chance, haven't had a chance to look. And I didn't think
- 20 it was fair to staff for them to negotiate a lease without even
- 21 knowing -- it would be different if it was a start-up nonprofit,
- 22 it would be different. Now are we going to keep the services
- 23 going? At least know what's going on, that's all. Not to
- 24 prohibit but to know.
- 25 COMMISSIONER HUBBARD: Well, no. And I understand what

- 1 you're saying. Again we have the -- it provides a valuable
- 2 service that provides the very basic needs of an individual.
- 3 We also provide for the Fishing Academy monies. And I'm
- 4 just using them as an example. Do we review their books?
- 5 And I quess what I'm saying is, this is -- this speaks to
- 6 the very core of somebody's daily existence. And this is --
- 7 some people, this is all they have. But it's -- if that's
- 8 something that we think that they are cuffing or we're not -- or
- 9 receiving, you know, lots of funds or something, then I guess
- 10 that would bring about this question. But I guess I just didn't
- 11 see them -- I just see them kind of barely surviving.
- 12 COMMISSIONER DAVIS: Madam Chair.
- 13 CHAIR MILLER-ANDERSON: Go ahead.
- 14 COMMISSIONER DAVIS: I'm not saying that anyone was
- 15 cuffing. It was just --
- 16 COMMISSIONER HUBBARD: I know.
- 17 COMMISSIONER DAVIS: -- for information only.
- I don't want nobody to interpret -- to hear that and go
- 19 running with that. I want to be very clear of that.
- 20 COMMISSIONER HUBBARD: I misspoke, Mr. Davis.
- 21 COMMISSIONER DAVIS: Okay.
- 22 COMMISSIONER HUBBARD: That was a word that --
- 23 COMMISSIONER DAVIS: Like I said, I just wanted to know
- 24 that this came up and --
- 25 COMMISSIONER HUBBARD: And you're right.

- 1 COMMISSIONER DAVIS: -- years ago.
- COMMISSIONER HUBBARD: You're right. That might not have
- 3 been an appropriate word to use. But I'm just saying I think
- 4 that --
- 5 COMMISSIONER DAVIS: And if the Fishing Academy is doing
- 6 the same -- collecting money, I would love to know from them as
- 7 well.
- 8 COMMISSIONER HUBBARD: Okay. Thank you.
- 9 CHAIR MILLER-ANDERSON: So, Ms. Pardo, did you -- were you
- 10 making a -- were you --
- 11 COMMISSIONER PARDO: Yeah, thank you, Madam Chair. I'd
- 12 like to make a motion to table this item until the next CRA
- 13 meeting in January.
- 14 COMMISSIONER DAVIS: Second.
- 15 CHAIR MILLER-ANDERSON: Madam Clerk.
- 16 (Vote taken.)
- 17 THE CLERK: Motion carries.
- 18 (Motion passed unanimously.)
- 19 MS. JENKINS: Thank you.
- 20 CHAIR MILLER-ANDERSON: Thank you.
- 21 Do we have any items tabled?
- 22 INTERIM EXECUTIVE DIRECTOR EVANS: No, Chairperson
- 23 Miller-Anderson.
- 24 CHAIR MILLER-ANDERSON: Do we have any public comment
- 25 cards?

- 1 THE CLERK: Yes, Madam Chair. We have two.
- 2 CHAIR MILLER-ANDERSON: Okay.
- 3 THE CLERK: The first one is Margaret Shepherd. And Marie
- 4 Davis.
- 5 MS. SHEPHERD: Margaret Shepherd, Riviera Beach.
- 6 CHAIR MILLER-ANDERSON: Good evening.
- 7 MS. SHEPHERD: Good evening, Council.
- 8 COMMISSIONER PARDO: Good evening, ma'am.
- 9 MS. SHEPHERD: I wasn't coming out today but I thought it
- 10 would just be robbery if I did not come out and thank the board
- of the CRA for such a wonderful time for the Riviera Beach
- 12 senior citizens at Lindsey Davis. It was a phenomenal time.
- 13 And I want to make it clear that the seniors really don't go out
- 14 at night, but I kept telling them to come out, come out, come
- 15 out, and they will enjoy, because I know Mrs. Jenkins will be
- 16 topnotch. And she did not, she did not, not at all, make it
- 17 what I said it would be. It was a phenomenal event. And I
- 18 thank the vice chair for coming out, Mr. Scott Evans for coming
- 19 out, and meeting with the seniors. And I'm so glad they were
- 20 sitting there saying who is that now, who is that? And of
- 21 course being a senior myself, I repeat myself over and over.
- 22 But they enjoyed theirself. The Caribbean music was fantastic.
- 23 The food was fantastic. And we want to thank the CRA.
- I wanted to come out again tonight because we met with
- 25 Ms. Jenkins, the board -- we are forming the Lindsey Davis

- 1 Senior Citizens Garden Club. And I want to tell you they are
- 2 excited that we are now getting ready -- and I keep hearing the
- 3 chair, Miss Alice, say, my green thumb, my green thumb. I don't
- 4 have a green thumb but I'm looking with the help of Dennis and
- 5 that group to get a green thumb.
- 6 And we want to make sure -- I think it's in your district,
- 7 Mrs. Hubbard. I think it's in your district. We're looking for
- 8 you to come out and support us. We are a 501(c)(3) so we do
- 9 need your support. We need everybody's support.
- 10 And with that, I thank you very much.
- I have a few seconds, and I want to say thank you to
- 12 Mrs. Carolyn Bradden over at Hilltop Missionary Baptist Church.
- 13 I keep forgetting to talk about her and thank her for a good job
- 14 she has done at Hilltop for Reverend Davis's 52nd Annual
- 15 Appreciation. It was a real wonderful event. And I thank
- 16 Carolyn for just -- last year he cried. This year he was
- 17 smiling. And I want to say thank you, Carolyn. I hope they go
- 18 back and tell her for putting on such a wonderful, wonderful
- 19 fiasco for the Reverend Griffin Davis, Sr., and Mrs. Griffin
- 20 Davis.
- 21 And with that, I'm a stickler detail for birthdays. If you
- 22 miss my birthday I get very upset. My children know that.
- 23 So I want to say happy birthday to Ms. Miller-Anderson's
- 24 mother's birthday. She had a birthday.
- 25 CHAIR MILLER-ANDERSON: Her birthday was in October.

- 1 MS. SHEPHERD: It was in October?
- 2 CHAIR MILLER-ANDERSON: Yeah.
- 3 MS. SHEPHERD: Well, I don't know, somebody started telling
- 4 me about her birthday.
- 5 CHAIR MILLER-ANDERSON: Yes, it was October.
- 6 MS. SHEPHERD: October. Well, happy birthday anyway.
- 7 Many, many, many more.
- 8 Let's give her a hand. Isn't she beautiful?
- 9 Thank you. Thank you, CRA and to Mr. Scott Evans.
- 10 CHAIR MILLER-ANDERSON: Appreciate it.
- MS. SHEPHERD: My birthday is in April so you got lots of
- 12 time.

- 19 aware of it. And they are, and they are working on it right
- 20 now. So I'll just leave it like that. They are working on it
- 21 and there should be a solution shortly.

- 23 write letters to the --
- 24 COMMISSIONER PARDO: No, I have numerous letters.
- 25 CHAIR MILLER-ANDERSON: Ms. Marie, we're still in public

- 1 comment so the three minutes is up. But Ms. Pardo comes around
- 2 and just provides the answer so --
- 3 MS. DAVIS: Thank you.
- 4 CHAIR MILLER-ANDERSON: Thank you.
- 5 Is that the end of public comment?
- 6 The report of the executive director.
- 7 INTERIM EXECUTIVE DIRECTOR EVANS: I just want to remind
- 8 everyone that our second family movie night is this Friday, and
- 9 the movie is The Grinch. So I just wanted to remind the board
- 10 and our residents that we'll have popcorn and there will be food
- 11 trucks there. And so all -- everyone is invited to come out and
- 12 enjoy the movie.
- 13 CHAIR MILLER-ANDERSON: Discussion by the board.
- 14 Ms. Pardo?
- 15 COMMISSIONER PARDO: No, I don't have anything.
- 16 CHAIR MILLER-ANDERSON: Mr. Davis?
- 17 COMMISSIONER DAVIS: I would just say congratulations to
- 18 the CRA for the first movie night that we had in the park. I
- 19 was able to attend for about an hour. It was really wonderful
- 20 to see this get back started. And I wish you well as you
- 21 continue those efforts. Let us make sure that we all tell
- 22 somebody to tell somebody to come out and bring their families
- 23 out.
- And I also want to say if we don't see you for the next CRA
- 25 meeting, Merry Christmas. Be safe over the holidays and just

- 1 really enjoy yourselves as we get ready to kick off the New
- 2 Year.
- 3 Thank you.
- 4 CHAIR MILLER-ANDERSON: Ms. Davis Johnson.
- 5 VICE CHAIR DAVIS JOHNSON: With regards to the movie night,
- 6 are we bringing the heaters down? Because it's -- we're on the
- 7 water, it's supposed to get a little chillier. So are we going
- 8 to have some, have those heaters maybe --
- 9 INTERIM EXECUTIVE DIRECTOR EVANS: It was discussed
- 10 actually as an idea. But because there are so many children
- 11 running around, we felt it would be a safety concern to have the

We will 5 certainly blast that to our constituents. I also want to extend a Happy Holidays, Merry Christmas, 6 7 Happy Hanukkah, to all of our residents. Thank you. 9 CHAIR MILLER-ANDERSON: Ms. Hubbard. COMMISSIONER HUBBARD: I just would like to take this 10 11 opportunity to wish everybody a Merry Christmas and safe happy 12 holidays.
