A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE RIVIERA BEACH COMMUNITY REDEVELOPMENT AGENCY (THE AGENCY) APPROVING A LICENSE AGREEMENT BETWEEN WILLIS WILLIAMS AND THE AGENCY FOR THE USE OF A PORTION OF SPANISH COURTS FOR A MOBILE FOOD TRUCK; DIRECTING AND AUTHORIZING THE CHAIRMAN AND EXECUTIVE DIRECTOR TO EXECUTE THE LICENSE AGREEMENT AND TO TAKE SUCH ACTIONS AS SHALL BE NECESSARY AND CONSISTENT TO CARRY OUT THE INTENT AND DESIRE OF THE AGENCY; PROVIDING AN EFFECTIVE DATE.

**SECTION 3.** This resolution shall be effective immediately upon its adoption.

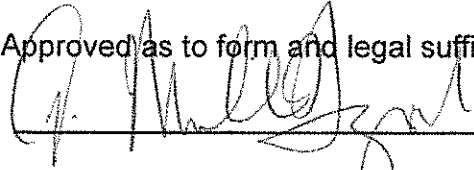
