A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, ENDORSING PALM BEACH COUNTY ROADWAY PROJECT 2003514, (SILVER BEACH ROAD, CONGRESS AVENUE TO PRESIDENT BARACK OBAMA HIGHWAY) FOR ROADWAY RECONSTRUCTION AND ACCEPTING OBLIGATION FOR CONTINUED MAINTENANCE AND OPERATION EXPENSES ASSOCIATED WITH THE NEW ACCESS ROAD FROM AVENUE S TO AVENUE P PROPOSED AS WEST 37TH COURT ONCE CONSTRUCTED BY PALM BEACH COUNTY AT NO EXPENSE TO THE CITY OF RIVIERA BEACH; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in 2003 the Palm Beach County initiated a road project to reconstruct Silver Beach Road from Congress Avenue to President Barack Obama (fka Old Dixie) Highway; and

WHEREAS, during the design process, it was determined that an access road would need to be constructed from Avenue S to Avenue P so that residential driveways did not back out onto the County thoroughfare; and

WHEREAS, the proposed access road will be designated West 37th Court; and

WHEREAS, the City of Riviera Beach desires for Palm Beach County to make improvements to Silver Beach Road to improve the traveling experience of residents; and

WHEREAS, following construction of the Project, the City of Riviera Beach shall accept ownership and appropriate such funds as may be necessary for the continued operation and maintenance of the newly constructed West 37th Court.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA as follows:

<u>SECTION 1</u>. The City of Riviera Beach supports the reconstruction of Silver Beach Road from Congress Avenue to President Barack Obama Highway.

SECTION 2. The City of Riviera Beach shall take ownership of the proposed access road known upon completion as West 37th Court.

<u>SECTION 3.</u> The City of Riviera Beach agrees to appropriate such funds as may be necessary to support the continued operation and maintenance of West 37th Court following completion.

SECTION 4. That this Resolution shall take effect upon its passage and approval by City Council.
