A RESOLUTION OF THE BOARD OF DIRECTORS OF THE CITY OF RIVIERA BEACH UTILITY SPECIAL DISTRICT, PALM BEACH COUNTY, FLORIDA, ACCEPTING THE WATER AND WASTEWATER REVENUE SUFFICIENCY AND RATE DESIGN ANALYSIS; AUTHORIZING THE UTILITY SPECIAL DISTRICT TO UPDATE THE WATER SYSTEM AND WASTEWATER SYSTEM FEES, RATES AND CHARGES; AND PROVIDING AN EFFECTIVE DATE.

- **WHEREAS**, on December 4, 2013, the Utility Special District Board of Directors approved Resolution No. 25-13UD to enter into an agreement with Public Resources Management Group, Inc. (PRMG); and
- **WHEREAS**, PRMG was authorized to provide Utility Rate and Financial Consulting Services for the Utility Special District; and
- **WHEREAS**, the purpose of the Study was to develop a Water and Wastewater Revenue Sufficiency and Rate Design Analysis; and
- **WHEREAS**, the most important objective of the study was to develop proposed utility rates that meet the expenditure requirements of the individual water and wastewater utility systems; and
- **WHEREAS**, the water and wastewater utility systems rates must be able to maintain sound financial operations and to fund the anticipated capital needs of the utility system.
- **WHEREAS**, on June 22, 2015, PRMG submitted the Water and Wastewater Revenue Sufficiency and Rate Design Analysis; and
- **WHEREAS**, PRMG's Report provided a basis for the recommended rates, fees and charges for the water system and wastewater system; and
- **WHEREAS**, these rates, fees and charges are necessary to meet the near term expenditure requirements of the water system and wastewater system for a period of five (5) fiscal years; and
- **WHEREAS**, this Update modified the initial recommendations as to the annual rate adjustments required for long-term sustainable service.
