## RESOLUTION NO.

## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA AUTHORIZING THE INCREASE OF FEES AT BARRACUDA BAY WATER PARK; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, the City of Riviera Beach has developed Barracuda Bay Water Park, and

**WHEREAS**, the facility is a valuable asset to the residents of and visitors to Riviera Beach for recreation, leisure, exercise, learning and competition, and

**WHEREAS**, the Parks and Recreation Department manages the facility and has a responsibility to balance fiscal and community need, and

**WHEREAS**, staff has identified revenue opportunities to assist with funding the operation of Barracuda Bay,

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, FLORIDA THAT:

**SECTION 1**. Increase fees as follows:

- 1) Non-resident entry fee from \$4 to \$5 ea.
- 2) Swimming lessons from \$25 to \$30 (residents) and \$40 (non-residents)
- 3) Swim team fees from \$85 to \$95 for non-residents

4) Birthday Package activity fee for non-residents from \$65 to \$85 for 10 attendees and from \$7 each additional person to \$10 each additional (non-resident)

5) Private rental from (resident) \$200 for four hours to \$300 for four hours and nonresidents from \$200 for four hours increased to \$400 for four hours

6) Each additional hour on private rental raised from \$50 to \$75 (residents) and from \$50 to \$100 (non-resident)

**SECTION 2.** This Resolution shall take effect upon its passage and approval by the City Council.
