A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, ACCEPTING A DONATION OF \$25,000 FROM THE COMMUNITY FOUNDATION FOR PALM BEACH AND MARTIN COUNTIES FOR THE RICHARD RELLFORD AND KENNY ANDERSON BASKETBALL ACADEMY AND AUTHORIZING THE DIRECTOR OF FINANCE AND ADMINISTRATIVE SERVICES TO INCREASE THE GENERAL FUND BUDGET FOR SAME, AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, The City of Riviera Beach has received a donation of \$25,000 from the Community Foundation for Palm Beach and Martin Counties from the Richard and Lesley Stone Family Fund for the purpose of conducting the 2018 Richard Rellford and Kenny Anderson Basketball Academy in the City of Riviera Beach; and

WHEREAS, the Academy is free to middle and high school participants and will begin June 11, 2018 and end on August 11, 2018 and operate Monday thru Thursday from 4:15 P.M. until 10 P.M. and on Saturdays per the game schedule; and

WHEREAS, the Academy will also promote academics and education by a required one hour per week computer lab time,

NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, FLORIDA:

SECTION 1. The City Council authorizes the acceptance of \$25,000 from the Community Foundation for Palm Beach and Martin Counties for the Richard Rellford and Kenny Anderson Basketball Academy and authorize the Director of Finance & Administrative Services to increase the General Fund budget for same:
