WITNESS (AT) That the said party of the first part, for an in consideration of the sum of Ten and 00/100 (\$10.00) Dollars to it in hand paid by the party of the second part, the receipt whereof is hereby acknowledged, has granted, bargained and sold to the party of the second part, its successors and assigns forever, the following described and lying and being in Palm Beach County, Florida:

LOT 124, MOLPHUS HEIGHTS), ACCORDING TO THE PLAT RECORDED IN PLAT BOOK 9, PAGE 58, PUBLIC RECORDS OF PALM BEACH COUNTY, FLORIDA. THE ABOVE BEING THE REAL PROPERTY DESCRIBED UNDER TAX CERTIFICATE NUMBER 20/13/92 IN THE TAX DEED RECORDED IN OFFICIAL RECORD BOOK 13880 RAGE 0389, PUBLIC RECORDS OF PALM BEACH COUNTY, FLORIDA.
