**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA AUTHORIZING THE SUBMITTAL OF A GRANT APPLICATION AND EXECUTION OF A GRANT AGREEMENT WITH THE FLORIDA DEPARTMENT OF STATE CULTURAL FACILITIES GRANT PROGRAM FOR RENOVATIONS AT DAN CALLOWAY PARK AMPHITHEATER; AUTHORIZING THE CITY MANAGER TO EXECUTE THE APPLICATION; AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE SAID AGREEMENT; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, staff has identified grant opportunities to assist with funding the renovations and upgrades to the Dan Calloway Park amphitheater in the amount of \$100,000.00.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, FLORIDA THAT:**

**SECTION 1.** The City Manager is hereby authorized to execute the grant submittals for the Florida Department of State Cultural Facilities grant program.

**SECTION 2.** That the Mayor and City Clerk are hereby authorized to execute the agreement for same.
