Subject: AWARD RECOMMENDATION: RFP 871-17 BODY WORN CAMERA AND VIDEO MANAGEMENT SOLUTION

Consistent with the City of Riviera Beach Code of Ordinance (MUNICODE Section 16.5), a Request for Proposal (RFP) was advertised in the "Legal Notices" section of the Palm Beach Post on March 5, 2017, to solicit licensed, insured, and qualified proposers to provide Body Worn Camera and Video Management Solution for the City of Riviera Beach Police Department.

To provide additional exposure and to ensure maximum competition for the project, it was also advertised on the City's internet web-page and Demand Star on **March 1, 2017**. On Demand Star, the solicitation had a broadcast list of 278 and there were 19 plan holders. Six (6) proposals were received with none of the respondents being from Palm Beach County or Riviera Beach.

On **June 27, 2017**, an evaluation committee consisting of the Assistant Police Chief, Finance and Administrative Services Director, Assistant Finance Director, Assistant Fire Chief, Parks & Recreation Director, Police Major and Buyer, convened to review and discuss the responses to the RFP for Body Worn Camera and Video Management Solution.

Firms were evaluated in two (2) separate phases and ranked based on the criteria established in the City's RFP which included the following:

## PAGE 2: EVALUATION COMMITTEE RECOMMENDATION: RFP 871-17

Committee members shared their observations, and evaluated and scored the responses in accordance with their understanding of the written criteria established in the public solicitation.

Scores for the written proposal (**Phase I**) were tallied, and based upon a measure of average score, the firms ranked as follows:

In accordance with the RFP's evaluation process, the three (3) top ranked firms were "Shortlisted" and invited for oral presentations. On **July 13, 2017**, the three responsive firms were invited to give oral presentations before the committee to discuss their approach and ability to meet or exceed the service requirements of the City, their business operation, their fees and qualifications of those persons that will be assigned to work with or Consult with the City on this project as listed below:

Technical Experience and Experience of the Team	10 points
Business Operations and Customer Support	25 points
Technical Soundness of Presentation	20 points

Committee members evaluated and scored the responses in accordance with their understanding of the oral presentation criteria established in the public solicitation.

Scores for the oral presentation (**Phase II**) were tallied, and based upon a measure of average score, the firms ranked as follows:

As a result of Phase I and Phase II evaluations, an **overall score** was calculated based on the sum of both evaluations. The results are:
