RESOLUTION OF THE CITY COUNCIL OF THE Α CITY OF RIVIERA BEACH, PALM BEACH FLORIDA. AUTHORIZING THE RENEWAL COUNTY. OF HEALTH CARE COVERAGE WITH AETNA HEALTH CARE OF FLORIDA, AND AUTHORIZING THE DIRECTOR OF FINANCE TO MAKE PAYMENTS FROM VARIOUS DEPARTMENTAL ACCOUNTS UP TO THE AMOUNT EQUAL TO \$878.68 A MONTH PER EMPLOYEE FOR FISCAL YEAR 2018-2019 TO AETNA HEALTH CARE OF FLORIDA; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the City recognized the need to renew its health care insurance for all employees; and

WHEREAS, the City's Health utilization has increased for the past 11-months to 86% (aggregate Premium Billed \$6,028,512 vs aggregate Incurred Claims \$5,170,672) making it difficult to receive favorable renewal rates for FY 2018-2019; and

WHEREAS, City staff survey local municipalities and City employees to determine best strategies for the FY 2018-2019 renewals;

WHEREAS, Aetna proposed a renewal increase of 4.99% with minor changes to the benefit structure;

WHEREAS, Broker's and Staff is recommending renewing Health Care with Aetna to include Dental as an additional option alongside Solstice Dental for FY 2018-2019.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, AS FOLLOWS:

SECTION 1. That staff is hereby authorized to bind coverage for the City of Riviera Beach for health insurance with Aetna Health Care Inc. for Fiscal Year 2018-2019.

SECTION 2. That the Director of Finance and Administrative Services is authorized to make payments from various departmental accounts for the total estimated amount of \$520,549.30 monthly.

SECTION 3. That this Resolution shall become effective immediately and coverage to commence as of October 1, 2018, upon its passage and approval by the City Council.
