A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE AGREEMENTS WITH MCLEAN & COMPANY, LLC., AND TORCIVIA, DONLON, GODDEAU & ANSAY, P.A., TO CONTINUE TO REPRESENT THE CITY IN THE NEGOTIATION OF LABOR CONTRACTS AND TO PROVIDE OTHER LABOR LEGAL SERVICES TO THE CITY; AUTHORIZING THE DIRECTOR OF FINANCE AND ADMINISTRATIVE SERVICES TO MAKE PAYMENT FROM ACCOUNT NUMBER 001-0512-5190-3101; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Riviera Beach is in need of attorneys to represent its interests in the negotiation of labor contracts and for other labor matters; and

WHEREAS, in 2012, the City issued a Request for Proposals for Labor Services, and Attorneys Jack L. McLean of McLean & Co. LLC, and Glen J. Torcivia of Torcivia, Donlon, Goddeau & Ansay, P.A., were selected to negotiate the City's union contracts governing City employees and to provide representation in arbitrations and other matters related to the enforcement of union contracts; and

WHEREAS, both firms have successfully negotiated the union contracts and handled other labor matters on behalf of the City; and

WHEREAS, the Agreement expired on April 15, 2018 in the middle of the negotiation of union contracts in implementing the compensation study and other matters; and

WHEREAS, staff recommends entering into an extended agreement with both firms.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, as follows:

SECTION 1. That City Council authorizes the Mayor and City Clerk to execute labor legal services agreements with McLean & Company, LLC., and Torcivia, Donlon, Goddeau & Ansay, P.A. to provide labor services to the City.

SECTION 2. That the Finance Director is authorized to make payment from Account Number 001-0512-5190-3101 for services rendered under these contracts.

SECTION 3. That this resolution shall take effect immediately upon its passage and approval by City Council.
