Subject: **AWARD RECOMMENDATION: RFP 944-18-2 FINANCIAL ADVISORY SERVICES**

Consistent with the City of Riviera Beach **Code of Ordinance (MUNICODE Section 16.5)**, a Request for Proposal (RFP) was advertised in the "**Legal Notices**" section of the Palm Beach Post on **March 25, 2018**, to solicit licensed, insured, and qualified Financial Advisor Services for the City of Riviera Beach.

To provide additional exposure and to ensure maximum competition for the project, it was also advertised on the City's internet web-page and Demand Star on **March 26, 2018**. On Demand Star, the solicitation had a broadcast list of 309 and there were 9 plan holders. Two (2) proposals were received with none of the respondents being from Palm Beach County.

On **May 23, 2018**, an evaluation committee consisting of the Director of Finance & Administrative Services, Treasury Manager, Interim Assistant Finance Director, Assistant Executive Director Utility District, Public Works Operations Manager, and Interim Director of Procurement as the Facilitator convened to review and discuss the responses to the RFP for Financial Advisory Services.

Firms were evaluated in one (1) phases and ranked based on the criteria established in the City's RFP which included the following:

EVALUATION COMMITTEE RECOMMENDATION: RFP 944-18-2

Committee members shared their observations, and evaluated and scored the responses in accordance with their understanding of the written criteria established in the public solicitation.

Scores for the written proposal were tallied, and based upon a measure of average score, the firms ranked as follows:

FIRM	RANKING	AVERAGE SCORE
PFM FINANCIAL	1	49.40
HILLTOP SECURITIES	2	38.80

The evaluation process has validated that the proposal submitted by PFM Financial satisfies the requirements established in the RFP and that the firm is qualified to be awarded the contract for the services identified in RFP #944-18-2.

PFM provide decades of traditional financial advisory experience along with a broad range of complementary services including: bond pricing; long term capital planning; public/private partnerships and strategic consulting assistance with budgeting, workforce management, and pension issues.
