A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE RIVIERA BEACH COMMUNITY REDEVELOPMENT AGENCY (“AGENCY”), AWARDED BID NO. ITB 2018-01 TO E&F FLORIDA ENTERPRISES D/B/A CREATIVE CONTRACTING GROUP OF WELLINGTON FLORIDA FOR THE REMOVAL OF EXISTING MARINA VILLAGE SEAWALL AND REPLACEMENT WITH DECORATIVE RAIL IN THE AMOUNT OF \$259,300.00; AUTHORIZING THE EXECUTIVE DIRECTOR TO APPROVE CHANGE ORDERS UP TO NINE PERCENT (9%); TOTAL CONTRACT VALUE SHALL NOT EXCEED \$282,637.00 EXCEPT FOR AUTHORIZED CHANGE ORDERS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on May 4, 2018, the Agency solicited bids for the removal and replacement of the Marina Village seawall through the issuance of bid number ITB2018-01 as specified in the Scope of Work and Specifications detailed in Exhibit "A" (“Services”); and

WHEREAS, E&F Florida Enterprises D/B/A Creative Construction Group, of Wellington, Florida was the lowest responsive and responsible bidder.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE RIVIERA BEACH COMMUNITY REDEVELOPMENT AGENCY as follows:

SECTION 1. Riviera Beach Community Redevelopment Agency hereby accepts the bid proposal and awards a Construction Services Contract to E&F Florida Enterprises D/B/A Creative Construction Group the lowest and responsible bidder in the amount not to exceed \$259,300.00 for the Services.

SECTION 2. The Executive Director is authorized to approve Change Orders up to nine percent (9%).

SECTION 3. The RBCRA Commission Board are authorized to execute the contract.

SECTION 4. That the Resolutions takes effect upon its passage and approval by RBCRA Commission Board
