**EXECUTIVE DIRECTOR HORTON:** Thank you, Madam Chair and City Manager, Members of the Board.

This is completion of the selection of both engineering firms and those firms that we are going to use to provide inspection services for Utility District projects. This will complete that list. If you recall, back in December, I asked for consensus of the Board to allow me to move forward to bring these firms on, on board. So, this will complete that process.

**BOARD PRO TEM HUBBARD** Councilwoman Miller-Anderson.

**BOARD MEMBER MILLER-ANDERSON:** Yes. I had a engineering firm, that's a local based firm, I believe, near 95 and Blue Heron.

**EXECUTIVE DIRECTOR HORTON:** Yes, ma'am.

**BOARD MEMBER MILLER-ANDERSON:** Which, which group is that?

**EXECUTIVE DIRECTOR HORTON:** I think they're made up...

**BOARD MEMBER MILLER-ANDERSON:** Is that one of them on here?

**EXECUTIVE DIRECTOR HORTON:** ...of, uh...

**BOARD MEMBER MILLER-ANDERSON:** That's one of them...

**EXECUTIVE DIRECTOR HORTON:** They, they are...

**BOARD MEMBER MILLER-ANDERSON:** ....on the list?

**EXECUTIVE DIRECTOR HORTON:** ...a team of one of the... Do you.., you know

which, which group?

**EXECUTIVE DIRECTOR HORTON:** I would have to go back and look at the details

to determine what group. I, I, I know the firm that you're, you're referring to.

BOARD MEMBER MILLER-ANDERSON: Mhmm.

**EXECUTIVE DIRECTOR HORTON:** They are a sub to one of the groups that we've

selected.

**BOARD MEMBER MILLER-ANDERSON:** Were..., did they submit a bid for the...

**EXECUTIVE DIRECTOR HORTON:** Did they submit...

**BOARD MEMBER MILLER-ANDERSON:** ...ask to be the prime?

**EXECUTIVE DIRECTOR HORTON:** ...qualifications?

**BOARD MEMBER MILLER-ANDERSON:** Mhmm. Do be the prime?

**EXECUTIVE DIRECTOR HORTON:** I, I do believe they did. There were a total of

nine firms that submitted...

BOARD MEMBER MILLER-ANDERSON: Mhmm.

**EXECUTIVE DIRECTOR HORTON:** ...on the engineering services.

BOARD MEMBER MILLER-ANDERSON: Mhmm.

**EXECUTIVE DIRECTOR HORTON:** And th'.., and we selected five. There were a

total of five firms that submitted on the inspection services, and we selected three.

**BOARD MEMBER MILLER-ANDERSON:** Okay. Alright. Thank you.

**EXECUTIVE DIRECTOR HORTON:** Yes, ma'am.

**BOARD PRO TEM HUBBARD** No. 3. Item No. 3.

**BOARD MEMBER DAVIS:** Madam Chair?

**DEPUTY DISTRICT CLERK BURGESS:** We're still on 2, Madam Chair.

But I was looking at Items 1 and 2 that was on, on the Consent and it does not have a dollar amount. I just was wondering, do we have dollar amounts on these Items and, you know, what kind of monies are we planning to spend on them, because I didn't see any and that was the purpose of the Agen'.., you know, my card on speaking on these Items? And, that was the purpose I was here, you know, I wanted to ask.

**EXECUTIVE DIRECTOR HORTON:** Yes, ma'am.

**BOARD PRO TEM HUBBARD** Is there.., can...

These are annual services agreements, and so, there will be work orders issued. This is a three year agreement with two one-year renewals. And, and the way this works for professional services, we will issue work orders on'.., against this agreement. They will provide proposals to the office, we will review those proposals. If, if those proposals look acceptable to us, then we will bring those back to the'.., if they're over \$25,000, we would bring them back to the Board for approval.

We, we asked them to provide us a proposal to address the metering issue and they've provided the proposal and that's what this Resolution is about, authorizing them to do the metering relocation in this project area.

**BOARD PRO TEM HUBBARD** Thank you. Any comments from the Board?

**BOARD MEMBER BOTEL:** No.

**BOARD MEMBER DAVIS:** No.

**DEPUTY DISTRICT CLERK BURGESS:** Board Member Botel?

**BOARD MEMBER BOTEL:** Yes.

**DEPUTY DISTRICT CLERK BURGESS:** Board Member Davis?

**BOARD MEMBER DAVIS:** Yes, ma'am.

**DEPUTY DISTRICT CLERK BURGESS:** Board Member Miller-Anderson?

**BOARD MEMBER MILLER-ANDERSON:** Yes.

**BOARD PRO TEM HUBBARD** Thank you.

**BOARD PRO TEM HUBBARD** Item 5.

DEPUTY DISTRICT CLERK BURGESS: RESOLUTION NO. 27-18UD. A RESOLUTION OF THE BOARD OF DIRECTORS OF THE CITY OF RIVIERA BEACH UTILITY SPECIAL DISTRICT, PALM BEACH COUNTY, FLORIDA AUTHORIZING THE CITY OF RIVIERA BEACH PURCHASING DEPARTMENT TO PARTICIPATE IN THE PROCUREMENT OF GOODS AND SERVICES THAT HAVE BEEN PUBLICLY SOLICITED BY OTHER GOVERNMENTAL ENTITIES, AUTHORIZING USE OF PROPRIETARY SERVICES, SOLE SOURCE PURCHASES, ANNUAL SERVICE.

MAINTENANCE AND REPAIR RENEWAL AGREEMENT ROUTINELY USED IN DAILY DEPARTMENTAL OPERATIONS FOR FISCAL YEARS 2018-2021 AND PROVIDING FOR AN EFFECTIVE DATE.

**BOARD MEMBER DAVIS:** So moved.

**BOARD MEMBER MILLER-ANDERSON:** Second.

**BOARD PRO TEM HUBBARD** Okay. Madam Manager.

**CITY MANAGER HOSKINS:** Thank you. Mr. Horton.

**EXECUTIVE DIRECTOR HORTON:** Thank you, Madam City Manager, Madam Chair and Members of the Board.

This particular Resolution allows the District the flexibility to go out quicker to secure the services that we need on a daily basis. When I first got here, there were many services that we were utilizing that didn't have the proper contractual agreements in place. And, what we found is, when we go out requesting three bids, a lot of vendors are getting tired of...

**BOARD PRO TEM HUBBARD** Pardon me. One minute, Mr. Horton. Councilwoman Botel, could you...

**BOARD MEMBER BOTEL:** I just realized I had my speaker on. I'll turn it... Thank you.

**BOARD PRO TEM HUBBARD** Thank you so much. Mr. Horton.

**EXECUTIVE DIRECTOR HORTON:** Thank you.

What we.., what, what we have found in recent months, is that we're having challenges now getting vendors to do three quotes under \$25,000 because they, a lotta times, the same vendor will beat them out on the quotes. And so, what, what I've tried to do is to initiate RFQ's to get people to apply, we've had challenges there and we have these needs, particularly from the laboratory perspective, laboratory testing perspective and things of this nature. And so what we've done, we've sought support from Procurement to help identify communities in, in our area that we may able to have cooperative agreements with, where we can get these services quickly. There are still some services that I do want to go out with individual RFP's on, but much of the services that are in need right now are in need today, chemical delivery, laboratory testing, which we do on a daily basis. And this will help cover that gap until such time as we can development and have the opportunity to have a competitive process where people can bid just on Riviera Beach type projects.

**BOARD PRO TEM HUBBARD** When you say chemical delivery, the chemicals that we need, they.., the cost is varying every time we need them? Is there.., is it not an item that

we use all the time that we can buy in bulk? What.., could you delve into that a little bit more, please?

## **EXECUTIVE DIRECTOR HORTON:** Yes, ma'am.

Our, our chemicals are a daily need requirement. The problem is, we don't have the right.., we don't have contractual agreements in place to cover us from a procurement perspective. This, this Resolution is going to remedy that by going out on the collaborative effort with some of our sister agencies until such time as we're able to have a competitive process to secure those same services.

**BOARD PRO TEM HUBBARD** Another question, the laboratory services, are.., we're testing inhouse, doing our labs or are we.., are you referring to things that we have to send out?

**EXECUTIVE DIRECTOR HORTON:** There are certain tests that we can perform inhouse that doesn't require any information being sent to our regulatory authorities. But, for every test that has to go to the regulatory authority, because we don't have the certification, or the personnel for our lab at.., in, in fact, the lab itself needs to be renovated. We just don't have that inhouse capability. So, we are, are very dependent upon three or four labs to provide us those services on a daily basis, first on the water side, but also on the wastewater side. Whenever there is a situation on the wastewater side where we have a spill, we have to pull samples, we have to send that to one of the local labs to test so that we can report accurate information to our state regulator.

**BOARD PRO TEM HUBBARD** Okay. Thank you.

**EXECUTIVE DIRECTOR HORTON:** Yes, ma'am.

**BOARD PRO TEM HUBBARD** Let the record show that Chairwoman Tonya Davis Johnson is on the dais. Okay. Are there any comments from the Board?

**BOARD MEMBER MILLER-ANDERSON:** Yes.

**BOARD PRO TEM HUBBARD** Councilwoman Miller-Anderson.

**BOARD MEMBER MILLER-ANDERSON:** So, how has this situation been handled prior to now? Or has there just been a delay or, getting things done, or how have we've been making it before now?

**EXECUTIVE DIRECTOR HORTON:** Nothing has been delayed. We have been securing services without the proper procurement contractual agreements in place. And I can't tell you how long that that's been going on, but it has been going on for a period longer than before I got here. And those are the types of things that I've been trying to straighten up. It has taken time to get to a process to where we could identify all the needs, but they.., and some of it was done, my understanding, some of it was done from an emergency standpoint when the Board declared an emergency, I guess a year or so ago.

#### BOARD PRO TEM HUBBARD Mhmm.

**EXECUTIVE DIRECTOR HORTON:** And so, I, I, I assume that, that the belief was that they could continue that way. I've tried to go out with individual RFP's.., or RFQ's rather... No. RFP's, I'm sorry, RFP's on these particular services, and we had not been as successful as I would, I'd like to be. So, the Procurement Department has come up with this process that we could use until such time as we can have success on our own, in securing those services, from a competitive process.

**BOARD MEMBER MILLER-ANDERSON:** And speaking of the emergency situation that we had, has that ceased? Or we're still operating...

**EXECUTIVE DIRECTOR HORTON:** We...

**BOARD MEMBER MILLER-ANDERSON:** ...in that manner?

**EXECUTIVE DIRECTOR HORTON:** We, we have it under control, but if, if you recall, particularly my first two or three months on the job, I, I indicated to the Board that we, we are living day by day. There, there are concerns that I personally have for the water plant as an, as an example, of a major catastrophe happening. So, there are certain things that we've had to continue in order to one, ensure that we can provide safe, palatable water to all of the customers within the City of Riviera Beach. We have to keep that water running, either through the plant or we would have to open the inner connects with Seacoast and/or the City of West Palm Beach. I'm, I'm, I'm, I'm reserved about using West Palm Beach because it's a different type water. They have a blended water of both surface and ground, and when you introduce that into a distribution system that solely depends on ground water, it can have a negative impact in the distribution system, so I've, I've kinda held off on that. Whenever we've needed water, Seacoast has been very, very supportive and cooperative in, in meeting our needs.

So, we are continuing that relationship. I've met with the Executive Director of Seacoast as recent as.., recently as, maybe two weeks ago. And so, we're continuing that relationship moving forward.

**BOARD MEMBER MILLER-ANDERSON:** But are we still processing payments or purchase orders, or getting quotes for.., under the State of Emergency, is my question? [Pause]. Like, 'cause I know during that particular time, the State of Emergency, some things are kinda, you know...

**EXECUTIVE DIRECTOR HORTON:** We...

**BOARD MEMBER MILLER-ANDERSON:** As afar as procedure and protocol, it's kinda ceased a little bit, but are we still operating that way? Because I don't...

**EXECUTIVE DIRECTOR HORTON:** To, to, to an extent I would have to say yes, only because we haven't had the proper contractual agreements in place. So, in.., so, in order to ensure that water is produced, we'.., we've had to continue that to a certain extent. With this, the approval of this Resolution, that will resolve all of that.

**BOARD MEMBER MILLER-ANDERSON:** Okay. So, after approving this here...

**EXECUTIVE DIRECTOR HORTON:** Yes, ma'am.

**BOARD MEMBER MILLER-ANDERSON:** ...we will no longer be operating in a manner of a State of Emergency where we have protocols or procedures that may have been laxed so that we could get things done?

**EXECUTIVE DIRECTOR HORTON:** From a procurement perspective, on the daily needs that we have, you're absolutely correct. However, and I have to put a qualifier to it. There are issues within the plant that has been in existence, and has been identified since as early at 2012. That must be addressed.

**BOARD MEMBER MILLER-ANDERSON:** Okay. Ms. Hoskins and Mr. Horton, could you please provide a breakdown of what those things are and how much longer you think we need to operate in this matter, based on the issues that you say are present. That need...

**EXECUTIVE DIRECTOR HORTON:** Yes, ma'am.

**BOARD MEMBER MILLER-ANDERSON:** ...to be fixed.

**EXECUTIVE DIRECTOR HORTON:** Yes, ma'am.

**BOARD MEMBER MILLER-ANDERSON:** By, let's say Friday.

**EXECUTIVE DIRECTOR HORTON:** I would like to be given until next week because I already have two things working.

**BOARD MEMBER MILLER-ANDERSON:** It is Monday. I mean, it not like it's Wednesday, today's Monday.

**EXECUTIVE DIRECTOR HORTON:** Yes, ma'am.

[Inaudible comment]

**EXECUTIVE DIRECTOR HORTON:** I, I've got a couple things working and I was already planning to come to Board Members individually to discuss some things.

BOARD MEMBER MILLER-ANDERSON: Mhmm.

**EXECUTIVE DIRECTOR HORTON:** So, if, if I would be allowed to be given the opportunity to have the collaborative efforts now that we've gotten the engineering firms approved, have those meetings and I also need to talk with our regulator on a couple of issues.

BOARD MEMBER MILLER-ANDERSON: Mhmm.

**EXECUTIVE DIRECTOR HORTON:** I would then like the opportunity to meet with you and your colleagues, individually, to talk about some things before we bring them forward to... for the Board.

**BOARD MEMBER MILLER-ANDERSON:** Well, I'm just trying to get an update as to what you have...

**EXECUTIVE DIRECTOR HORTON:** And I would be doing that at that time. And I'm just asking...

**BOARD MEMBER MILLER-ANDERSON:** So, when, when are...

**EXECUTIVE DIRECTOR HORTON:** ... for the ti'...

**BOARD MEMBER MILLER-ANDERSON:** When?

**EXECUTIVE DIRECTOR HORTON:** Well, two weeks. Two weeks.
