A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, APPROVING THE AGREEMENT FOR MERCHANT SERVICES WITH BRIDGEPAY AS THE GATEWAY PROVIDER AND AUTOMATED MERCHANT SERVICE INC. AS THE MERCHANT SERVICES PROVIDER; AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE SAID CONTRACT; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City's current merchant services provider is Point & Pay; and

WHEREAS, on October 18, 2017, the City entered into an Agreement with Tyler Technologies to serve as the City's new Enterprise Resource Planning provider; and

WHEREAS, Tyler Technologies provided a list of compatible merchant services providers; and

WHEREAS, Information Technology and Treasury staff researched multiple merchant services providers in regards to their products and implementations with the Tyler Technologies integration; and

WHEREAS, staff also reached out to multiple municipalities in Florida who have purchased and/or integrated with these providers to gain feedback on performance, user-friendliness, technical support, fees, and methodology for choosing that specific provider; and

WHEREAS, based on research and the discussions with associated representatives, staff is recommending BridgePay as the gateway provider with Automated Merchant Services Inc. as the merchant services provider; and

WHEREAS, the City desires for BridgePay as the gateway provider with Automated Merchant Services Inc. as the merchant services provider to utilize their efforts in providing merchant services to the City; and

WHEREAS, as of April 4, 2018 the City is in a month to month contract with Point & Pay that may be canceled upon 30 days written notice; and

WHEREAS, upon implementation with Tyler Technologies on October 1, 2018 the City desires to utilize the services of BridgePay as the gateway provider with Automated Merchant Services Inc. as the merchant service provider; and

WHEREAS, in comparison to Point & Pay, which is the City's current merchant services provider, the City is expected to save an estimate of \$1,400 a month by

utilizing the services of BridgePay as the gateway provider with Automated Merchant Services Inc. as the merchant service provider.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, FLORIDA THAT:

SECTION 1. The City Council authorizes the Agreement for merchant services with BridgePay as the gateway provider and Automated Merchant Services Inc. as the merchant services provider to be rendered on the live implementation date of Tyler Technologies integration, where the terms will be month to month and may be terminated for any or no reason with (90) days notice.

<u>SECTION 2.</u> The Mayor and City Clerk are authorized to execute the Agreement.

SECTION 3. This Resolution shall take in effect upon its passage and approval by the City Council.
