PETERSBURG, FLORIDA, A SUBSIDIARY OF MARINETEK GROUP OY OF HELSINKI FINLAND AS THE PRIMARY MANUFACTURER FOR THE MARINA DOCK REPLACEMENT PROJECT, FOR MANUFACTURING AND INSTALLATION OF THE FIXED AND FLOATING DOCK STRUCTURES INCLUDING, GANGWAYS, RELATED STRUCTURES AND COMPOEMENTS, AS A RESULT OF THE SUBMISSION TO REQUEST FOR PROPOSAL NO. 950-18-3, IN AN AMOUNT NOT TO EXCEED \$2.174.390.00 AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE THE PROPOSED MANUFACTURING AND **INSTALLATION** CONTRACT: AUTHORIZING THE **FINANCE** DIRECTOR TO ESTABLISH A BUDGET AND MAKE PAYMENTS FOR SAME; AND PROVIDING AN **EFFECTIVE DATE.**

WHEREAS, staff has determined the total cost to replace the City Marina docks including the seawall eastward to the dedication line is approximately 17 million dollars, and

WHEREAS, consistent with the provisions of the City's Procurement Ordinance (4010), a Request for Proposal was publicly solicited for qualified dock manufacturers to furnish all supervision, personnel, equipment, materials, labor and supplies to complete the manufacturing and installation of all fixed, floating docks and related structures and components, and

WHEREAS, one (1) manufacturer responded to the Request for Proposal No. 950-18-3, and

WHEREAS, Marinetek North America Inc., Of St. Petersburg, Florida, A Subsidiary Of Marinetek Group Oy Of Helsinki Finland (Marinetek) was evaluated and the proposal was found to be responsive and reasonable to provide a fixed and floating dock system as identified in the City's Request for Proposals; and

WHEREAS, the City desires to award a contract, restricted by available funds, to Marinetek ,as the top ranked manufacturer in the amount not to exceed \$2,174,390.00 for phases two of the marina dock replacement project; and

WHEREAS, staff recommends City Council approve the contract with Marinetek, in the amount of \$2,174,390.00.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, FLORDIA THAT:

- **SECTION 1.** The City Council hereby accepts staff's recommendation to award the contract to complete the manufacturing and installation of the fixed and floating docks and related fixed structures and components for the City Marina to Marinetek and authorizes the Mayor and City Clerk to execute the contract for same.
- **SECTION 2.** The City Council authorizes Marinetek to complete floating docks installation in the amount of \$2,174,390.00.
- **SECTION 3.** That the Finance Director is authorized to make payment from the appropriate account(s).
- **SECTION 4.** The City Manager is authorized to approve change orders in an amount not to exceed 10% of the total contract award amount.
- **SECTION 5** This Resolution shall take effect upon its passage and approval by the City Council.
