While I was hoping to make tonight's CRA meeting, it looks as though I may be unable.

Twenty four years ago when I was considering purchasing a house on Singer Island, I thought about living across the street from hotels, motels and down the road from a commercial retail center called the Ocean Mall. Knowing that hotels and motels on the beach bring traffic and a certain amount of noise, I weighed the pros and cons. After doing the necessary research to protect my investment, I purchased my house.

I have learned to live with the traffic and the caribbean music that the wind blows west on certain days. It's all part of living in a resort community.

Sixteen years ago, a quaint local waterfront restaurant closed their doors. The Crab Pot, located next to a vacant lot, fed locals and tourists for decades. They closed their door because progress was coming next door, but, the City reassured everyone that a restaurant would eventually be rebuilt on the Crab Pot site. The City kept the parcel zoned as commercial and we all waited for the restaurant.

Almost 14 years ago, residents on the east side of 27th, 28th 29th, Lakeshore Dr., Wilma Circle and many on Singer Island, were upset when the City approved a dense condo project now called Marina Grande. Residents in the surrounding area lost their view of the Intracoastal, lost morning sun in their yard, lost their quaint waterfront restaurant and the small fishing village feel. But the parcel was zoned residential, the City needed this 'progress' so we accepted the project, the density, and the increased traffic. We now embrace our new neighbors, the progressive project and life has moved on.

Finally, today, we have the chance to bring back a waterfront restaurant. A restaurant the City **promised** would someday return. A waterfront restaurant that will compliment our waterfront community. We have a lot of people talking about progress and moving our city forward, but only on their terms. When you make decisions, please remember that you are making decisions for over 30,000 residents not 100.

We look forward to having a restaurant built on the old Crap Pot parcel. The City promised it to us. Don't renege on the promise of those who preceded you.


