A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA AUTHORIZING THE SUBMITTAL OF A GRANT APPLICATION AND EXECUTION OF A GRANT AGREEMENT WITH THE FLORIDA RECREATION DEVELOPMENT ASSISTANCE PROGRAM FOR \$50,000 TO ASSIST WITH FUNDING THE RENOVATIONS TO CUNNINGHAM PARK; AUTHORIZING THE CITY MANAGER TO EXECUTE THE APPLICATION; AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE SAID AGREEMENT; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the State of Florida has opened the FY2019 Florida Recreation Development Assistance Program funding cycle; and

WHEREAS, the City of Riviera Beach has managed and operated Cunningham Park for many years; and

WHEREAS, the Cunningham Park is in process of renovation; and

WHEREAS, staff has identified grant opportunities to assist with funding the renovations in the amount of \$50,000.00.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, FLORIDA THAT:

SECTION 1. The City Manager is hereby authorized to execute the grant submittal for the Florida Recreation Development Assistance program.

SECTION 2. That the Mayor and City Clerk are hereby authorized to execute the agreement for same.

SECTION 3. This Resolution shall take effect upon its passage and approval by the City Council.
