WHEREAS, the Mayor and City Clerk executed the Legal Services Agreement for the same, providing for a term of two years commencing on September 17, 2014, with the option to extend the term of the agreement for additional two (2) year periods should the Attorneys wish to renew the Agreement for an additional Term;

WHEREAS, Corey Smith wishes to renew the Legal Services Agreement for an additional Term;

WHEREAS, the City Council hereby extends the Legal Services Agreement of Corey Smith for an additional two (2) year period, the original agreement is attached hereto.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, FLORIDA, that:

SECTION 1. The foregoing WHEREAS clauses are incorporated into this Resolution as true and correct statements and findings.

<u>SECTION 2</u>. The City Council hereby extends the legal services of attorney Corey Smith as special master for code enforcement hearings, unsafe building hearings and other City hearings as requested by City staff.

SECTION 3. The Mayor and City Clerk are authorized to extend the attached legal services agreements with attorney Corey Smith for an additional two (2) year period.
