A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, APPROVING A WORK ORDER WITH CHEN MOORE AND ASSOCIATES OF WEST PALM BEACH, FLORIDA FOR CIVIL ENGINEERING DESIGN SERVICES FOR AVENUE "M" FROM W. 23RD STREET TO W. 27TH STREET AND 26TH COURT FROM AVENUE "M" TO 27TH STREET IN ACCORDANCE WITH THE FY18 AND FY19 CDBG ROAD PROGRAM IN THE AMOUNT OF \$61,840.00; AUTHORIZING THE CITY MANAGER TO APPROVE CHANGE ORDERS UP TO TEN PERCENT (10%); AUTHORIZING THE DIRECTOR OF FINANCE AND ADMINISTRATIVE SERVICES TO MAKE PAYMENTS AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council approved, through Resolution No. 74-15, the design contract for Chen Moore Associates to provide general civil engineering services to the City; and

WHEREAS, Chen Moore and Associates as the City's continuing services engineering firm under contract, is capable of completing the post-design and construction oversight work required to meet all schedule deadlines;

WHEREAS, due to the magnitude of the project, design and construction oversight services will be required to help ensure that the project is as successful as possible.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA as follows:

SECTION 1. That the City Council hereby approves the issuance of a work order to Chen Moore and Associates of West Palm Beach, Florida to provide design services required to develop construction plans and aid in the bid process in the amount of \$61,840.00.

SECTION 2. That the Director of Finance and Administrative Services is authorized to make payments for same.

SECTION 3. That the City Manager shall have authority to approve change orders in an amount not to exceed ten percent (10%) of the contract amount.

SECTION 4. That this Resolution shall take effect upon its passage and approval by City Council.
