A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, APPROVING THE RENAMING OF THE RIGHT OF WAY PRESENTLY KNOWN AS WEST 30<sup>TH</sup> STREET SPANNING FROM BROADWAY TO AVENUE "T" AS "REV. GRIFFIN DAVIS, SR. STREET"; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the section of West 30<sup>th</sup> Street from Broadway to Avenue "T is platted road right-of-way; and

**SECTION 1:** The Mayor and City Council approve the renaming of the section of West 30<sup>th</sup> Street from Broadway to Avenue "T" to "Rev. Griffin Davis, Sr. Street".

**SECTION 2.** The City Council authorizes staff to transmit this resolution to the appropriate intergovernmental agencies.

**SECTION 3.** This Resolution shall take effect immediately upon its passage and approval by the City Council.
