A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, AWARDED BID NO. 957-18-4 TO JAMES S. LAVOLD, INC. OF RIVIERA BEACH, FLORIDA FOR THE CONSTRUCTION OF THE SINGER ISLAND DUNE WALKOVER IMPROVEMENTS IN AN AMOUNT NOT TO EXCEED \$86,300.00; AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE THE CONSTRUCTION SERVICES CONTRACT; AUTHORIZING THE CITY MANAGER TO APPROVE CHANGE ORDERS UP TO \$3,863 FOR A TOTAL NOT TO EXCEED AMOUNT OF \$90,163.00; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, in the matter of Lozman vs. City of Riviera Beach, Case No. 50 2016 CA 001527XXXXMB the City by court order was directed to re-establish and reconstruct the easement and dune walk over between the Via Delfino and Seawinds Condominiums; and

WHEREAS, the City has solicited competitive bids for the work required to re-establish and reconstruct the subject easement; and

WHEREAS, three (3) construction firms provided a response to said solicitation; and

WHEREAS, James S. Lavold Inc. of Riviera Beach, Florida was the lowest responsive and responsible bidder; and

WHEREAS, the City's purchasing department shall implement a direct purchase process to save tax on bulk material purchases.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA as follows:

SECTION 1. The City Council hereby accepts the bid proposal and awards a Construction Services Contract to James S. Lavold Inc., the lowest responsive and responsible bidder, in an amount not to exceed \$86,300 for the construction of the Singer Island Dune Walkover.

SECTION 2. The City Manager is authorized to approve Change Orders up to \$3,863.
