22	our special meeting.
23	Madam Clerk, item number two.
24	THE CLERK: A resolution of the Board of
25	Commissioners of the Riviera Beach Community

- 1 Redevelopment Agency authorizing staff to negotiate a
- 2 Comprehensive Development Agreement with ADP Solutions,
- 3 LLC, for development of the phase II Marina Village
- 4 project; providing for other purposes; authorizing the
- 5 Executive Director to take such actions as shall be
- 6 necessary and consistent to carry out the intent and
- 7 desire of the Agency; providing an effective date.
- 8 COMMISSIONER DAVIS: So moved.
- 9 CHAIR DAVIS JOHNSON: Microphone on?
- 10 COMMISSIONER MILLER-ANDERSON: Second.
- 11 CHAIR DAVIS JOHNSON: It's been moved and
- 12 properly seconded.
- 13 Mr. Evans.
- 14 INTERIM EXECUTIVE DIRECTOR EVANS: Good
- 15 evening, Board members.
- This project, we're here today after a long
- 17 process that started with the new plan for the Marina
- 18 District in 2012. The new Marina Village, Phase I, was
- installed, the infrastructure which allows us to
- 20 facilitate tonight's Phase II project discussion.
- 21 Regardless of the outcome tonight, this is a
- 22 milestone event for the Redevelopment Board. The CRA
- 23 Board intends to build upon its recent Phase I
- 24 strategic investments that included the completion of
- 25 the new Event Center, as well as the expanded and

- 1 improved marina, Bicentennial Park and the public
- 2 promenade that was built along the marina.
- 3 The Board started on the path towards Phase
- 4 II in 2017. Much was accomplished this year to
- 5 position the project for this year's efforts.
- 6 Milestone workshops were convened in January and May
- 7 that provided a reset to the existing Master Plan to
- 8 implement an updated vision, implementation and focus
- 9 for the project.
- The Board's goals for this project are to
- 11 reduce poverty and ensure that the public waterfront is
- 12 protected and enhanced by the project, provide a
- 13 tangible return to City residents, provide new
- 14 business, local business opportunities, and the project
- 15 should create a vibrant waterfront that is welcoming
- 16 both to the residents, visitors and to strengthen our
- 17 community assets.
- 18 Additional goals include giving the community
- 19 an opportunity to participate meaningfully in the
- 20 redevelopment process and to recognize the economic
- 21 opportunity of the unique waterfront location and have
- 22 Marina Village become an engine of revitalization in
- 23 the marina and eventually spreading out all along the
- 24 Broadway corridor.
- 25 By resetting our priorities for the next

- 1 phase, staff has done a lot of work to study and
- 2 evaluate the proposals, utilizing experienced public
- 3 and private industry professionals. I would like to
- 4 personally thank our CRA team, the selection committee
- 5 and the Board and the two teams who submitted
- 6 proposals. They put in a lot of hard work to get to
- 7 this point of a long and methodical process.
- 8 The Marina Village Phase II project will
- 9 continue the transformation of the City's waterfront
- 10 and pursue broader goals to catalyze economic
- 11 development and opportunities for the citizens, its
- 12 residents, and to enhance our property values, which is
- 13 a primary goal of the CRA.
- 14 Riviera Beach is ideally positioned to build
- 15 upon its assets and infrastructure that we installed in
- 16 Phase I. The City's redevelopment efforts
- 17 strategically position Riviera Beach to maximize the
- 18 market. The waterfront property is very valuable, and
- 19 we'd like to create a new destination.
- 20 On January 24th of 2018 the Board of -- CRA
- 21 Board of Commissioners approved Resolution 218-01
- 22 seeking development proposals from qualified master
- 23 developers for this phase of the Marina Village
- 24 project. The RFQ was issued on February 2nd, and the
- 25 Agency received two responses, provided by Tezral

- 1 Partners, LLC and APD Solutions, LLC.
- 2 The evaluation committee met over a period of
- 3 two days on October 17th and 19th, and after reviewing
- 4 both of the quality proposals provided by Tezral and
- 5 APD, have ranked APD's proposal as the highest, with a
- 6 total score of 421 points versus 382 points for Tezral.
- 7 The Agency is seeking to make
- 8 transformational improvements to Broadway and Marina
- 9 Village, with the goal of enhancing tax values and
- 10 bringing hundreds of new jobs, temporary construction
- 11 jobs and enhancing the local economy. The project
- 12 represents over \$100 million of future development and
- 13 will make Marina Village a local and regional
- 14 destination for residents and visitors.
- Once the CRA Board selects the highest ranked
- 16 proposal, the CRA and the City will begin negotiations
- 17 with the selected developer towards developing a
- 18 comprehensive development agreement that will provide
- 19 detailed plans, project elements, community benefits
- 20 and future management structure for the next phase of
- 21 Marina Village.
- The Marina Village redevelopment opportunity
- 23 has been assisted by our national development
- 24 consultant, Mr. Dana Nottingham. Mr. Nottingham has
- 25 served in a leadership role on large scale ventures in

- 1 eight urban markets that have generated in excess of
- 2 \$2 billion in economic impact.
- 3 As development executive advisor, he is the
- 4 local representative and negotiator and project
- 5 director for major development companies such as the
- 6 Rouse Company, including New Orleans Riverwalk,
- 7 Underground Atlanta, the Walt Disney Company, which
- 8 included Disney Village Marketplace, Celebration Town
- 9 Center, Downtown Disney strategic plan and work for the
- 10 Miami Downtown Development Authority.
- 11 Mr. Nottingham tonight will present an
- 12 overview of the review and evaluation process and
- 13 summarize the evaluation categories, findings of the
- 14 selection committee. Mr. Nottingham was a facilitator
- 15 and resource to the evaluation committee, but did not
- 16 participate in the scoring or formulation of findings.
- 17 His role was to guide discussions and document the
- 18 outcomes for the Board.
- MR. NOTTINGHAM: Good evening.
- 20 COMMISSIONER DAVIS: Good evening.
- MR. NOTTINGHAM: My role today is to present
- 22 the results of the RFP selection committee. I'll focus
- 23 on three areas. One, first to put in context how we
- 24 got to this critical juncture; second, to explain the
- 25 RFP evaluation process; and third, to summarize the

- 1 outcomes of the selection committee members, their
- 2 independent review and scoring. I'll read the report
- 3 into the record, which will be reinforced with visuals.
- 4 This slide symbolizes the starting point for
- 5 the current RFP process, the realization that based on
- 6 the market and the site's many strengths, there's a
- 7 huge opportunity to create a crossroads and gateway
- 8 destination, employment of an innovation center.
- 9 The CRA set out to develop the Marina
- 10 District in a manner that would catalyze broader
- 11 commercial and residential revitalization along the
- 12 U.S. 1/Broadway corridor and mainland neighborhoods.
- In 2012 the CRA approved a Master Plan vision
- 14 that was intended to be built out in multiple phases.
- 15 Phase I was completed and included the expanded marina,
- 16 improving Bicentennial Park and building a new Event
- 17 Center. At that time it was contemplated that Phase II
- 18 would include a major public market and waterfront
- 19 restaurants that would be followed by a sizeable retail
- 20 program.
- 21 With the completion of Phase I improvements
- 22 on CRA land, the undeveloped land ownership going
- 23 forward included approximately 11 to 12 acres, six
- 24 acres fronting the waterfront owned by the CRA and
- 25 City, five acres fronting U.S. 1/Broadway, of which

- 1 2.5 acres is owned by the CRA and the City, Spanish
- 2 Courts, and the additional 2.5 acres includes parcels
- 3 owned by the CRA, City and Viking. Approximately one
- 4 half acre, the old Yachtsman site, is centrally located
- 5 and owned by Viking.
- In 2007 the CRA's new leadership convened two
- 7 workshops in May and June. The workshops clarified the
- 8 Board's expectations in three areas, community benefits
- 9 objectives, Phase II hotel potential and retail
- 10 industry feedback. Based on the workshops the Board
- 11 reset the Marina Village vision to read: A marina and
- 12 Event Center, anchored dining, entertainment and hotel
- destination next to the cruise terminal, just minutes
- 14 away from the oceanfront and close to other
- 15 attractions.
- 16 The Board's quidance helped to clarify the
- 17 scope of the request for proposal. While the public
- 18 solicitation was called an RFP, it was more like a
- 19 request for qualifications that asked for far more
- 20 information related to financial capabilities and
- 21 tasked the proposals to prepare a conceptual
- 22 development plan for two scenarios.
- In summary, the RFP process included six
- 24 stages. First, to clarify the hotel opportunity, the
- 25 community benefits and to confirm industry feedback.

- 1 Second, the RFP was issued February 2nd. Proposals
- 2 were received on July 9th. The third stage was the
- 3 information requested in six areas: Leadership;
- 4 experience; approach; local participation; conceptual
- 5 development plan, two scenarios, base case and
- 6 alternate case; and financial capabilities.
- 7 The evaluation process included the technical
- 8 review committee, which was assembled to review the
- 9 submissions and formulate questions that was sent to
- 10 each proposer. The selection committee members
- 11 received and reviewed the proposals and responses to
- 12 the CRA's questions. The last stage, the selection
- 13 committee members completed their evaluations and
- 14 recommendations.
- The CRA received two proposals. One proposal
- 16 was from Tezral Partners, LLC, a startup West Palm
- 17 Beach based partnership created for this purpose, whose
- 18 parent company is owned by Tony Brown Consulting Group
- 19 and All Sites Construction, Ezra Saffold.
- They are joined by their retail placemaking
- 21 and implementation advisor, Montreal based Live, Work,
- 22 Learn and Play, an international consulting and
- 23 development firm who were the lead consultants in
- 24 developing the original Master Plan.
- The Tezral team includes Tony Brown

- 1 Consulting Group, managing partner; All Sites
- 2 Construction, Ezra Saffold, equity partner; advisor
- 3 Live, Work, Learn and Play, Richard Martz.
- 4 The development partners include Municipal
- 5 Acquisition, a private real estate investment firm
- 6 specializing in public facilities; Urgo Hotels, the
- 7 owner and operator of the Singer Island Marriott; and
- 8 Uptown Properties, an Ohio based residential developer.
- 9 The balance of the technical team included
- 10 primarily local and West Palm Beach based firms that
- 11 include Song & Associates, Weitz Construction, Kast
- 12 Construction, One World Realty, the Mosaic Group, Jones
- 13 Foster, attorneys, and FX Facility Group.
- 14 AP Solutions -- APD Solutions Real Estate
- 15 Group, LLC was the other proposal. APD Solutions Real
- 16 Estate Group is a nine year old Atlanta based economic
- 17 and real estate development firm that is wholly owned
- 18 by the 40 year old Chicago based Urban Retail
- 19 Properties, which operates approximately 50 shopping
- 20 centers, including six properties owned by them.
- 21 Urban Retail has eight regional offices and
- is a leasing hub located in Boca Raton and manages
- 23 approximately 14 shopping centers in the state of
- 24 Florida.
- 25 APD is joined by their local development

- 1 partner, New Synergy Ventures, which is led by Arnold
- 2 Broussard. APD Solutions' Vaughn D. Irons is the CEO.
- 3 Urban Retail Properties, the parent company, is led by
- 4 Craig Delasin, CEO, Paul D. Motta, CEO, both from Urban
- 5 Retail Properties. New Synergy Ventures, the local
- 6 partner, is led by Arnold Broussard.
- 7 The technical team, Florida and West Palm
- 8 Beach based, and includes REG Architects; ECF
- 9 Engineering; D. Stephenson Construction; Cooper
- 10 Construction Management; Schmidt Nichols, architects;
- 11 Nason, Yeager, attorneys; Protective Hands; and the TED
- 12 Center.
- 13 My role as facilitator was to complete a
- 14 comparative summary, share relevant information, set
- 15 the meeting agenda, guide the discussions and oversee
- 16 the scoring procedures.
- 17 The selection committee members reviewed the
- 18 proposals and completed independent evaluations,
- 19 scorings, rankings and recommendations based on the
- 20 following criteria and weights: Leadership, five
- 21 percent; experience, 15 percent; approach, 15 percent;
- 22 local participation, 20 percent; development plan,
- 23 30 percent; financial capabilities, 15 percent.
- 24 Here are key points that the selection
- 25 committee felt contrasted and differentiated the

- 1 proposals. On leadership, Tezral, the team leader, has
- 2 extensive economic development policy and financing
- 3 experience. APD Solutions, their team leader as well
- 4 has the same extensive economic development policy and
- 5 financing experience.
- In terms of experience, Tezral's adviser,
- 7 Live, Work, Learn and Play, has Phase I experience,
- 8 planning and implementation, consulting and development
- 9 experience globally. APD, the parent company
- 10 development partner has in-house cross-functional
- 11 experience operating a nationwide portfolio, including
- 12 14 centers in Florida.
- In terms of approach, Tezral featured a
- 14 parking garage, residential and retail financing
- 15 strategy, relying upon the City's comitting to
- 16 long-term parking lease, and they focused on workforce
- 17 housing. APD focussed on advancing centralized
- 18 district management and creating more attraction
- 19 appeal, and also focused on workforce housing.
- Tezral, concept plan: Built upon the
- 21 strengths of the original Master Plan and district
- 22 management approach. APD proposed more activated
- 23 waterfront promenade, with potential retail and
- 24 attraction anchors.
- 25 COMMISSIONER BOTEL: Could you change the

- 1 slide?
- 2 MR. NOTTINGHAM: Sorry.
- 3 Local participation, bullet number two.
- 4 Tezral: 100 percent MBE ownership, local WBE/MBE
- 5 participation, and a model to facilitate local
- 6 investment in anchor uses. APD, local participation,
- 7 local MBE equity partner, Florida and West Palm Beach
- 8 based team WBE and MBE participation.
- 9 Financial capabilities. Tezral: In their
- 10 proposal, they stated they will provide it if they were
- 11 the winning proposal. APD Solutions, financial
- 12 capabilities: They provided APD and Urban Retail
- 13 financial information that shed light on their
- 14 financial strengths.
- In terms of scoring, I will read you the
- 16 scores. The first would be for APD, the second will be
- 17 for Tezral. There were five evaluators. 78 to 80,
- 18 Tezral. 88 to 84, APD. 89 to 78, APD. 81 to 61, APD.
- 19 85 to 79, APD.
- 20 While both proposals were competitive, the
- 21 scoring in three areas gave APD a scoring advantage.
- 22 One, experience; two, financial capability; and three,
- 23 conceptual development plan. When the scores were
- 24 tabulated, four out of five selection committee members
- 25 ranked APD Solutions the top qualified proposal.

- 1 I've included a side by side comparison of
- 2 both conceptual plans. The Tezral proposal is on the
- 3 left, and APD is on the right. Note at this early
- 4 stage, the plans are conceptual and will be refined
- 5 based on validating market research and securing the
- 6 financing required to execute phased development of the
- 7 site. The final evolution of the plan will be done in
- 8 collaboration with the CRA and the City.
- 9 This is an enlarged photo of the APD plan,
- 10 which represents their vision of an activated
- 11 waterfront promenade with restaurants, hotel and retail
- 12 frontage. It indicates the potential opportunity to
- 13 locate anchor uses at both ends of the project. On the
- 14 north, it indicates a ferris wheel and activated beach.
- 15 On the south end, it identifies a zone, that green
- 16 building, for potential retail and entertainment
- 17 anchors and other potential uses.
- 18 This is the end of the report, and I'd like
- 19 to open up the house for questions.
- 20 COMMISSIONER BOTEL: Madam Chair.
- 21 CHAIR DAVIS JOHNSON: Councilwoman Botel,
- 22 you're recognized.
- 23 COMMISSIONER BOTEL: Thank you.
- 24 First of all, let me say how excited I am to
- 25 see this project coming to fruition. I think it's

- 1 probably the most important project that the CRA, at
- 2 least in my short tenure, and probably in the tenure of
- 3 many of my colleagues here, will be voting on. It's
- 4 really exciting to see Phase II coming to pass, and I
- 5 wouldn't want to put any stumbling blocks in the way of
- 6 it moving forward as quickly as possible.
- 7 I appreciate that the CRA has made a great
- 8 effort to ensure that the process has been above board
- 9 and scientific. I think a lot of work went into
- 10 developing the rubric for evaluation. I don't doubt
- 11 that the evaluators made every effort to evaluate in
- 12 good faith.
- But I think there might be one component, one
- 14 component that might be missing, and I think we can
- 15 rectify that at the November 14th meeting. I would
- 16 like to suggest that we have a presentation by both of
- 17 the developers so that the community can understand why
- 18 this decision was made the way it was.
- I have had many calls in the last 24 to
- 20 48 hours asking how this decision was made. You've
- 21 done a very good job explaining what the criteria was,
- 22 and I think that I fully understand that, but yet I
- 23 believe that there are members of the community who
- 24 would like to hear from both developers so they have a
- 25 very complete understanding of why APD was chosen over

- 1 Tezral. And I would just ask that that request be
- 2 honored by the CRA.
- 3 CHAIR DAVIS JOHNSON: Any other comments from
- 4 the Commissioners?
- 5 COMMISSIONER MILLER-ANDERSON: Madam Chair.
- 6 CHAIR DAVIS JOHNSON: Commissioner
- 7 Miller-Anderson.
- 8 COMMISSIONER MILLER-ANDERSON: I'd like to
- 9 reserve my comments until after, if we have any
- 10 comments from the public.
- 11 CHAIR DAVIS JOHNSON: Do you have any public
- 12 comment cards?
- 13 THE CLERK: Yes, ma'am.
- 14 VICE CHAIR HUBBARD: Madam Chair.
- 15 CHAIR DAVIS JOHNSON: Vice Chair, you're
- 16 recognized.
- 17 VICE CHAIR HUBBARD: Will ADP be making a
- 18 presentation tonight, since they are being recommended?
- 19 Is that based on what we have here?
- 20 INTERIM EXECUTIVE DIRECTOR EVANS: No, we
- 21 don't have them scheduled for a presentation.
- 22 MAYOR MASTERS: Madam Chair.
- 23 INTERIM EXECUTIVE DIRECTOR EVANS: If you
- 24 wanted to schedule a presentation, we'd have to give
- 25 the notice to both teams in order to have time.

- 1 CHAIR DAVIS JOHNSON: Mr. Mayor, you're
- 2 recognized.
- 3 MAYOR MASTERS: Yes, I certainly would like
- 4 to see a presentation on both sides, based on the fact

- 6 close. There seems to have been a lot more information
- 7 in certain categories on the other one than the one

- 11 MAYOR MASTERS: Tezral. I would like to know
- 12 why they did not provide financial information and

- 4 CHAIR DAVIS JOHNSON: Public comment cards.
- 5 THE CLERK: Bruce Guyton, followed by Andre
- 6 Rolle and Delsia Brooks.
- 7 MR. GUYTON: Good evening.
- 8 MAYOR MASTERS: Good evening, sir.
- 9 MR. GUYTON: To the Mayor, Council members,
- 10 my name is Bruce Guyton, as most of you know, a
- 11 lifelong resident of the beloved City of Riviera Beach.
- 12 And I'm also a planner by trade, and I'm also further a
- 13 three term Councilperson.
- I must concur it is very important for the
- 15 public to have an opportunity to hear both before a
- 16 decision is made. Customarily, the top two or three
- 17 are brought to the decision makers and/or presentations
- 18 are given after the responses are in writing.
- 19 There were only two responses here, so there
- 20 was no number of respondees to select from. That being
- 21 the case, I would suggest, and it's typical and
- 22 customary, before a decision is made, after the written
- 23 responses, you have the oral presentation, because that
- 24 sheds a lot of light, not just to the Board, who
- 25 already had interaction with maybe the teams, but for

- 1 the public.
- 2 It's called transparency. Before a decision
- 3 is made, the public have an opportunity to hear
- 4 presentations, and then we rely on our representatives
- 5 to make a decision, hopefully, that represents not only
- 6 their point of view, but the point of view of the
- 7 community. Thank you.
- 8 MAYOR MASTERS: Madam Chair, while the other
- 9 speaker is coming, if we have questions from any of the
- 10 public, like one or two, can we do that when they get
- 11 finished, because I would like to ask Mr. Guyton a
- 12 question at the end.
- MR. ROLLE: Good evening, Mr. Mayor,
- 14 Councilmen and women.
- 15 I'm here because, you know, looking at the
- 16 presentation that the gentleman gave before, you know,
- 17 I too have questions, because especially with the
- 18 approach method.
- And you look at the past history of the work
- 20 that's been done in Riviera Beach. And I'm in the
- 21 construction field, you know, supervises, you know,
- 22 concrete and everything. And when I ride around the
- 23 city and I look at what's being presented to me and I
- 24 look at the city for a local contractor who's talking
- 25 about building buildings -- and you all are familiar

- 1 with what happened at FIU with the bridge collapse, and
- 2 even in Orlando with the flooring falling in. And then
- 3 I look at Coleman Park, with fresh concrete that's just
- 4 been poured that's cracking.
- 5 So you know, when we come and we look at
- 6 financial stability, are we going to just put on paper
- 7 what's presented? This is I'm going to present to you
- 8 the highest quality of work, but yet when it comes to
- 9 building a project, that you're getting low standard
- 10 work. And now you have in this city a lot of rework, a
- 11 lot of back charges.
- 12 I'm here to stand for whatever contractor
- 13 that's going to present their work package to you guys
- 14 is a responsible contractor. And that's where we, as
- 15 citizens, need to understand that there is such a thing
- 16 called a responsible contractor.
- 17 And if a contractor is not responsible for
- 18 the little things, how can we be assured for not only
- 19 our safety, but the conditions? You can walk around,
- 20 if you know construction, and look at what's been built
- 21 and how much rework has been done.
- So my only thing is that, you know, I want
- 23 you guys to understand that we need to bring a
- 24 contractor here that's going to do the quality of work
- 25 and also be able to provide work for our local

- 1 citizens. We've been talking about it, and now, you
- 2 know, I'm going to be committed and more committed to
- 3 try to push local workers to work.
- 4 And I need the Council, the Mayor that we --
- 5 we need to be on this Board at that local
- 6 participation, local apprenticeship, and we're not
- 7 getting that. And all that comes back into the
- 8 financial stability. As you know, we can't 1099 every
- 9 worker. Because the citizens are paying for this deal,
- 10 and that tax revenue has to come back to pay for these
- 11 projects, and we're not doing that.
- 12 So we need to look at other things besides,
- 13 you know, if he a local. Let's get somebody in here
- 14 that's going to be willing to do local participation.
- 15 Thank you.
- 16 CHAIR DAVIS JOHNSON: Thank you, sir.
- 17 THE CLERK: Delsia Brooks, followed by Bonnie
- 18 Larson.
- MR. BROOKS: It's been a long time. My name
- 20 is Delsia Brooks-Hamilton. I live in Palm Beach
- 21 County.
- 22 And I wanted to thank all the Council members
- 23 for the decision they made. I just want to thank Scott
- 24 Evans and Mayor Masters, and of course, the community.
- I have been going through this process for

- 1 now four years. It's almost five years. When the
- 2 first RFP was submitted, I was the only participant
- 3 that submitted an LOI, and I was told that there was no
- 4 parking space for the restaurant. The name of my
- 5 restaurant is Pangea Grill, and it's intercontinental
- 6 cuisine.
- 7 So here it is, almost five years now. I'm
- 8 not sure whether I'm going to be selected or not,
- 9 because here it is ADP is the developer that has been
- 10 selected. I'm not certain whether or not they're going
- 11 to select me as a restaurant operator.
- But I have been in the process. I've got my
- 13 rendering, I've got my -- everything is ready. I also
- 14 have my investor that is willing to invest the money,
- 15 you know, for this project. So here it is.
- 16 I remember Mr. Nottingham. I participated in
- 17 the workshop a couple of times where he was actually
- 18 there. I don't know these gentlemen here, but I just
- 19 want to say that I hope that I will be one of the
- 20 restaurants that will be selected during this process.
- I'm a small business owner, I'm a black woman
- 22 business owner, and I think I do have the experience.
- 23 My family has been in the restaurant business for over
- 24 50 years. I do know how to cook, even though I do
- 25 have, you know, I do have three chef. And everybody's

- 1 basically waiting to move forward.
- 2 And I need to find out where do I stand at
- 3 this point, because I was told the reason of the delay
- 4 is that they didn't have any parking space. But then
- 5 yet there is Rafiki Tiki. You know, he's occupying
- 6 parking space. So I would like to be selected as one
- 7 of the restaurant operators. Thank you very much.
- 8 MAYOR MASTERS: Go and ask. They're right
- 9 there.
- MS. BROOKS: I'm sorry?

- 1 They could do it tonight. There's several of them
- 2 here. I don't understand why sometimes they come,
- 3 sometimes they don't, and we just pass it on to them.
- The two teams, I had asked for the names of
- 5 the people on the two teams. Mr. Haygood told me I was
- 6 not entitled to that. That rings with me as no
- 7 transparency. Why can't I know who's on the
- 8 committees? I don't understand that. Who's on the two
- 9 teams? But I was told: No, you can't know. So there
- 10 seems like some secrecy there, which I didn't like. So
- 11 tonight we know who's on there, but it should have been
- 12 more transparent. I don't know why the public wasn't
- 13 able to get that information.
- Mr. Brown, who's on the Tezral team, he had
- 15 six years to get a signature restaurant at the marina.

- 25 Still no signature restaurant.

- 1 Whoever is selected, we need to tell them
- 2 what we want, not them tell us what we're going to do.
- 3 It's our property. We live here. It's up to us, the
- 4 CRA and the City, to tell the developers what we want
- 5 down there. I don't like, of course, the thought of
- 6 having private people living on our public marina. I
- 7 have never liked that. I've spoken against it several
- 8 times. That seems to still be in the plan.
- 9 Let's see, what else? Oh, financial
- 10 stability. They ranked -- ADT ranked much higher.
- 11 Tezral offered no financial information. They should
- 12 do that. That's their responsibility to do that. We
- 13 shouldn't have to come back and say give it to us. We
- 14 didn't get anything from Viking. Look where we ended
- 15 up with Viking. We didn't get any financials from

- 25 MAYOR MASTERS: So what does that mean, trick

Page 38 1 or treat? THE CLERK: Ezra Saffold. 2 3 MR. SAFFOLD: Good evening, Council. MAYOR MASTERS: Good evening, sir. 4 5 MR. SAFFOLD: Ezra Saffold, local, home grown 6 developer. Glad to be here at this junction. 7 We are not a start-up. We've been around. Tony has proven his worth with the Phase I. I have 8 proven my worth here in the city. I have been a part 9 10 of many community and other endeavors on the 11 improvement of this city. My heart pumps Rivera Beach. 12 To the note of us not having financials, it 13 was stated that we will provide them upon negotiations. 14 No team provided audited financials. 15 It wasn't noted that we're bringing a 16 Marriott hotel here to my city, with local investment opportunities for the general area and people who want 17 18 to be a part of it. 19 It wasn't noted that we have a \$60 million 20 commitment for a parking garage and other things. So I 21 just wanted to let that go on the record. Thank you. 22 THE CLERK: There's no more public comment 23 cards. 2.4 CHAIR DAVIS JOHNSON: All right. Mr. Davis, 25 Councilwoman Miller-Anderson, you wanted to reserve

- 1 your comments.
- 2 COMMISSIONER MILLER-ANDERSON: Yes. I do
- 3 have the same concern regarding the presentations. And
- 4 I had several other concerns, but I don't -- if we're
- 5 going to have presentations done, I think that would be
- 6 the time to do it.
- 7 Other than that, it would be a waste of time
- 8 for me to sit here and talk about all of the different
- 9 things that we're talking about, because until we have
- 10 those presentations, I don't think any of this should
- 11 even come to us at this point in time.
- I do have questions regarding the selection
- 13 committee, those who were on the selection committee.
- 14 I do have concerns about -- I understand there may have
- 15 been some typos within the proposals or the package
- 16 that was there, because I was confused at one point
- 17 because it said ADP at one time, then it says APD, then
- 18 it says APD Reg. And so at one point I was thinking we
- 19 were talking about two different companies.
- 20 And so -- and then also within SunBiz, I
- 21 noticed that one APD Solutions is not in SunBiz for
- 22 Florida, but they do have it for Georgia, and I guess
- 23 they're going up under the Urban Retail.
- 24 But there's a lot of questions that I have
- 25 that need to be answered, but to sit here and talk

- 1 about it tonight, before we have those presentations,
- 2 would be, you know, not worth the time to go through
- 3 that, because once the presentations are done and then
- 4 we'll have an opportunity to speak with them, then
- 5 maybe that could be cleared up at that time.
- 6 CHAIR DAVIS JOHNSON: Okay. Mr. Davis,
- 7 you're recognized. You reserved your comments for
- 8 after public comments. Public comments are concluded.
- 9 COMMISSIONER DAVIS: I don't know if anyone
- 10 else wanted to go before me or now.
- 11 CHAIR DAVIS JOHNSON: No, it was --
- 12 COMMISSIONER DAVIS: I can wait.
- 13 CHAIR DAVIS JOHNSON: Go ahead, Mr. Davis.

- 15 VICE CHAIR HUBBARD: Madam Chair.
- 16 CHAIR DAVIS JOHNSON: Vice Chair, you're
- 17 recognized.
- 18 VICE CHAIR HUBBARD: The -- I agree that we
- 19 should wait to hear the presentations. But
- 20 Mr. Saffold, who is a member of the other team, made
- 21 some comments, and I notice that the gentlemen from
- 22 this team wants to make a comment as well.
- CHAIR DAVIS JOHNSON: I'm happy to have that,
- 24 but what we cannot do is have what is tantamount to a
- 25 presentation if we are asking for a presentation. If

- 1 he wishes to make a comment, that comment needs to not
- 2 be an extensive comment that is equivalent to
- 3 presentation related remarks.
- But before he comes, the question that I have
- 5 is: Was there a presentation before the selection
- 6 committee?
- 7 INTERIM EXECUTIVE DIRECTOR EVANS: The
- 8 selection committee did not review presentations. We
- 9 elected to review the proposals and submit detailed
- 10 questions for the gaps that we found in the proposals.
- 11 Those questions were then responded to by the various
- 12 teams, and all of that information was sent to the
- 13 selection committee.
- 14 CHAIR DAVIS JOHNSON: In my world, that is
- 15 just not a process that typically happens. When you
- 16 have a selection committee, a selection committee gets
- 17 a presentation so that they could bring their scores
- 18 forward, because a body, an elected body does not
- 19 typically, again, in my world, does not typically hear
- 20 the proposals and presentations made for a selection
- 21 process.
- So we're doing something that is, in my
- 23 opinion, unique and different to how we typically --
- 24 how proposals and responses to RFPs are handled. So I
- 25 just don't understand why the committee would elect

- 1 with there being such a grave difference in scoring.
- 2 Those questions could have been addressed during the
- 3 process of the presentation before the selection
- 4 committee, before it even gets here to the community
- 5 and this body.
- 6 So that lends me pause a bit, because your
- 7 full committee, as I understand it, didn't hear from
- 8 them other than to read whatever responses were
- 9 provided. That's just not a process. And I'm sure
- 10 that those of you who have participated and responded
- 11 to RFPs, that has been a typical process. So I do have
- 12 concerns with that.
- I too looked up -- I typically go through, so
- 14 that I can learn who the partners are and who the
- 15 companies are. And when I went into SunBiz, in any
- 16 iteration, ADP, APD, they were at one point active in
- 17 the Florida Department, Division of Corporations, but
- 18 they show as being inactive for failing to submit the
- 19 annual report.
- So I just want to -- you know, and that's
- 21 something that we'll hear about later, but I had
- 22 concerns as I was going through the responses, and then
- 23 that question as it related to the presentation to the
- 24 selection committee was a question for me.
- 25 So who is speaking on the APD?

Page 43 1 COMMISSIONER DAVIS: Madam Chair. 2 MAYOR MASTERS: Madam Chair. 3 CHAIR DAVIS JOHNSON: Mr. Davis, you're recognized. 4 5 COMMISSIONER DAVIS: As the gentleman 6 approaches, I definitely can support, understand of 7 where we are with the presentation. I'm not opposed to a committee reviewing that. 9 What I do understand is we rolled back from 10 2012 up until October 17, 2018. We had a six, seven 11 year window-way went by, and then in May, this Board 12 had a decision to approve a process. In that process, those are some rules and some foundations that were set 13 14 in place. 15 We all read this information as a five member 16 Board. We all approved this process in June of 2017, 17 5/0. The issues with the presentations was all in the backup. I had some concerns, but it was a 5/0 vote. I 18 supported it with this direction, the Commission wanted 19 20 to go with the recommendation. But we all agreed in 21 June of 2017. Between now and then, that's been a nine 22 month span when we knew what the process was doing. 23 We're -- the residents are going to benefit 2.4 from whatever decision we make, which is the ultimate 25 decision. And when we're going to do business, we must

- 1 make sure that -- and I'm not -- I'm going to be very
- 2 respectful to all of you, to all of my colleagues. But
- 3 I'm just saying that when we approve a process and we
- 4 go through the information, that information, those
- 5 questions that we're asking now should have been
- 6 brought up in June of 2017.
- As it relates to having a public meeting, one
- 8 thing I learned about competition, you have winners and
- 9 losers. And what I don't want our city to turn into is
- 10 a race to a Council meeting, and it becomes a political
- 11 decision. And you know who suffers? Our city and our
- 12 brand.
- I'm not -- I'm going to be very clear. I'm
- 14 not accusing anyone of anything. But I've been born
- 15 and raised in this city all my life, and I knows what
- 16 happens when we have a meeting with a big decision. It
- 17 becomes a race to who can ramp up the most friends and
- 18 family to come in and put political pressure in a
- 19 heated election season.
- 20 Just like the Mayor, I was wondering why, in
- 21 all due respect to Mr. Evans -- I respect him dearly --
- 22 why he said no matter what happens tonight. So if
- there's a tone being set before the meeting's being
- 24 started, you know, we could have saved the presentation
- 25 before the gentleman gave his presentation.

- I don't want to see that someone put their
- 2 best foot forth and they lost. I'm going to try to do
- 3 better. I think we all at a disadvantage to start this
- 4 process over for a presentation.
- 5 You have an oversight committee -- no,
- 6 evaluation -- I mean technical review committee that
- 7 sat in a meeting in June of 2017 and heard everything
- 8 that we talked about. So they went there asking
- 9 questions based on information that we gave them.
- 10 And the only issue I do have is maybe, yes,
- 11 that committee could had reviewed the presentation.
- 12 Just like in Phase I, the Council, the CRA Commission
- 13 at that time did not review a presentation. Just got
- 14 elected. There's a recommendation came before the
- 15 Board. It was approved.
- 16 At that time there was a protest because
- 17 someone lost, and then they protested. There was a
- 18 number, I want to say sixth place team, fifth or sixth
- 19 place -- I'll give it to you -- and they protested
- 20 about something that the CRA Director said during the
- 21 process, saying how there was two horses in this race,
- 22 and it felt like there was a compromise at that time.
- But we still moved forward with the decision,
- 24 with the understanding that we got folks that put some
- 25 significant amount of time, money, energy, including

- 1 our staff, including ourselves, we all worked together,
- 2 and including a previous Commission, how we going to
- 3 move.
- 4 So I'm only saying that if we're going to set
- 5 some rules and we want to approve something, if there's
- 6 some questions, I will support the entire Commission.
- 7 If they see something happening that's not comfortable,
- 8 let's address it right away. Don't wait till we make a
- 9 decision and then say, okay, you know what, this one,
- 10 you know, let's give everybody a fair shot and let's
- 11 find a reason to -- I'm not accusing anybody of
- 12 anything. I'm just telling you based upon the history
- of Riviera Beach, when folks are watching these
- 14 meetings there's always a reason why it seems that we
- 15 can't get anything done.
- 16 I'm just saying if you're going to approve
- 17 something, let's stick to what we're going to approve,
- 18 be very clear about what we're approving and make sure
- 19 that we're working well together, because we've got to
- 20 hold whoever we choose to the same standard.
- You know, we have a recommendation and now we
- 22 seem to what? Let's say team two was approved, the
- 23 other team was approved that's not here tonight, and
- 24 their strengths was put on the board of why they did
- 25 good. Of course, the team we didn't approve hoping for

- 1 a chance to get back in and give you everything that
- 2 you say we didn't do. So now I'm going to put on a
- 3 better show. Then you're put in a tougher position to
- 4 who do you believe at that point? But when they all
- 5 put their best foot forward, a team won and made a
- 6 decision, and then what happened? That's all I'm
- 7 saying.
- 8 COMMISSIONER MILLER-ANDERSON: Madam Chair.
- 9 CHAIR DAVIS JOHNSON: Councilwoman
- 10 Miller-Anderson, you're recognized.
- 11 COMMISSIONER MILLER-ANDERSON: By no means do
- 12 I have any opposition to him speaking, but we do
- 13 understand that Mr. Saffold spoke because he put a card
- in. So it wasn't like we were allowing anyone to do a
- 15 presentation. And he did not put in a card, so --
- VICE CHAIR HUBBARD: Well, be that as it may,
- 17 and -- be that as it may -- I'm sorry.
- 18 COMMISSIONER MILLER-ANDERSON: I don't have
- 19 an opposition to it, but that was the reason why he was
- 20 there, was because he put in a card. That's the only
- 21 thing I wanted to say.
- 22 MAYOR MASTERS: Madam Chair.
- CHAIR DAVIS JOHNSON: Your name, sir?
- 24 MAYOR MASTERS: I'll wait till he gets
- 25 through.

- 1 MR. IRONS: Good evening, Commissioners and
- 2 Mr. Evans and Mr. Mayor. My name is Vaughn Irons. I'm
- 3 the CEO of APD Solutions Real Estate Group based in
- 4 Atlanta, Georgia.
- 5 And what I want you to clearly know is that
- 6 we followed the process prescribed by you, and we were
- 7 completely compliant by the deadlines that you all set,
- 8 and we're happy to follow whatever process you want.
- 9 So if you would like for us to come back and
- 10 provide a presentation, we already have as a part of
- 11 our regular strategy to do a tremendous amount of
- 12 community outreach and get community participation and
- input in the process, we're happy to do that, inclusive
- 14 of the fact that I did fill out a comment card. So
- 15 just adding a little levity.
- 16 But the point that I'm really attempting to
- 17 make is our goal is to, you know, follow the process
- 18 that you all set for us. We're happy to present our
- 19 information, we're happy to answer any questions that
- 20 you have, and we feel confident that we can share with
- 21 you the strengths that we bring to the table and the
- 22 resources that we bring nationwide, internationally and
- 23 here locally.
- We have a very impressive group of local
- 25 participants that we hand selected to be a part of this

- 1 process, not because we just wanted names in the
- 2 package; because we believe that they can enhance what
- 3 we're able to bring here.
- 4 And our whole proposal is completely based on
- 5 us being at risk. The reason we presented our
- 6 financials is we're prepared to invest our own capital
- 7 and be at risk doing this project. And according to
- 8 your own process, submitting financials was a
- 9 requirement. And so since that wasn't done, that means
- 10 that there's a defect in one of the proposals simply on
- 11 the points that you all presented.
- We followed your process completely from
- 13 start to finish. When you asked supplemental
- 14 questions, we answered those questions and submitted
- 15 those by the deadline. If you'd asked us to do a
- 16 proposal, we'd be happy to be here with bells on and
- 17 present our information, and we feel confident that we
- 18 would win at that point as well.
- 19 So thank you very much for allowing me to
- 20 speak to you today.
- 21 CHAIR DAVIS JOHNSON: Thank you, sir.
- Mr. Mayor, you're recognized.
- 23 MAYOR MASTERS: Yes, Madam --
- 24 MR. WHITE: I just want to say one thing. I
- 25 just want to echo that as well. We do have -- and

- 1 Mr. Saffold was talking about -- I'm also one person
- 2 that's born and raised here. Steve White with
- 3 Protective Hands Communications.
- But we honored the process, and we look
- 5 forward to whatever else the Commissioners may require.
- 6 But we are, as Vaughn said, we're ready to move
- 7 forward.
- 8 CHAIR DAVIS JOHNSON: Thank you, sir.
- 9 MR. WHITE: And we do honor the process.
- 10 Thank you.
- 11 CHAIR DAVIS JOHNSON: Thank you, sir.
- Mr. Mayor, you're recognized.
- 13 MAYOR MASTERS: Yes, just briefly. I'm a
- 14 little confused about the hotel, the Marriott. Someone
- 15 said that in their proposal they're going to bring the
- 16 Marriott on this side. Which group was that?
- 17 CHAIR DAVIS JOHNSON: Mr. Mayor --
- MAYOR MASTERS: Mr. Saffold, okay. I know I
- 19 heard it, but I'm getting -- hearing a lot of things.
- 20 The other thing, I'm very impressed with the Marriott.
- 21 I'm a Marriott person.
- 22 Also, local participation is very big with
- 23 me. It's very important. Community benefits is very
- 24 important with me as well. And as my colleague
- 25 mentioned earlier, Mr. Davis, that Mr. Evans did state

- 1 earlier about however it goes, but I don't know how
- 2 that -- you know, he said it, but I'm sure he meant
- 3 well with that. So I wanted to make that statement as
- 4 well.
- No matter how it goes, I do want to say to
- 6 Mr. Saffold that I do appreciate what you have done in
- 7 this city in the past and the local participation that
- 8 I know that you've done in the past. No matter how it
- 9 goes, I want to go on record and say I appreciate your
- 10 local involvement.
- 11 And so we'll look forward to the
- 12 presentations. Each presentation should be able to
- 13 speak for itself and stand on its own merits. One's
- 14 from Georgia; the one from Riviera Beach, right?
- Okay, thank you.
- 16 CHAIR DAVIS JOHNSON: Is it then the desire
- 17 of this Council to hold off on voting before -- until
- 18 after the proposals are made?
- 19 COMMISSIONER MILLER-ANDERSON: Yes.
- MAYOR MASTERS: Yes.
- 21 CHAIR DAVIS JOHNSON: So do we need to --
- 22 well, there was a motion and a second on it, so we need
- 23 to have that motion rescinded, because we're not voting
- 24 on it until after the presentations are made. Who was
- 25 the maker of the motion?

Page 52 1 MAYOR MASTERS: Madam Chair. 2 CHAIR DAVIS JOHNSON: I just asked my 3 colleagues if they wish to hold off on the vote until 4 the presentations are made. I saw heads shaking. 5 COMMISSIONER BOTEL: Madam Chair, I wonder if 6 it helps take away the political aspect, and I hear 7 what my colleague is saying about not wanting to make it a -- not wanting to politicize it, if that's the right way to say it. It shouldn't be a popularity 9 10 contest. It should be a real --11 I want to preserve what the CRA Director has 12 attempted to do and has done and Mr. Nottingham has done in that they've made it a scientific process. 13 14 They've given it -- they've created a rubric, they've 15 created some guidelines. 16 I wonder, does it help if rather than we make 17 it -- my goal was to make it available to the 18 community, to make the presentations available to the 19 community so that our community could see what was 20 being proposed by both developers. Does it make it 21 less political if the presentations are done for the 22 evaluation committee rather than for this Council? 23 COMMISSIONER MILLER-ANDERSON: That's not 2.4 what I'm asking for. 25 COMMISSIONER BOTEL: It's not. Okay, then

- 1 I'll shut up. Just a thought.
- 2 CHAIR DAVIS JOHNSON: Well, personally I feel
- 3 that a presentation should have been made before the
- 4 selection committee. That is just --
- 5 COMMISSIONER BOTEL: See, that's where I'm
- 6 getting at.
- 7 CHAIR DAVIS JOHNSON: -- typical and
- 8 standard. And I don't understand why we --
- 9 COMMISSIONER BOTEL: Exactly. The selection
- 10 committee, I think -- I don't know that that would --
- 11 CHAIR DAVIS JOHNSON: Pardon me, I wanted to
- 12 complete.
- I don't know that that necessarily would have
- 14 had any bearing on scoring. I sit on selections in the
- 15 other side of my life, and so when that comes, our
- 16 Board is never involved in the decision making process
- 17 on selections.
- So to want to present to us at this juncture
- 19 just seems to me that we missed a step. I'm not -- I'm
- 20 not by any means suggesting that the firm that has the
- 21 prevailing points is not a good firm. I just
- 22 questioned why we did it this way.
- And whether or not, Mr. Davis, you know, you
- 24 said earlier, I think, you know, we were all aware of
- 25 the process. I recall what we voted on. But there is

- 1 still within procurement a process within that process.
- 2 So that's my only question, and I think that that's a
- 3 reasonable question. But, you know, I'm a vote.
- And I believe I asked the question: Do you
- 5 all want to hold off on the approval of the vote or did
- 6 you want to move forward before presentations were
- 7 provided to any group?
- 8 VICE CHAIR HUBBARD: Ma'am.
- 9 CHAIR DAVIS JOHNSON: Vice Chair.
- 10 VICE CHAIR HUBBARD: I guess for me, it's
- 11 this. Sure, I think that there should have been a
- 12 presentation to the community, to the selection body
- 13 and to the Council. We could have sat in on either
- 14 one. I don't understand the process that didn't have a
- 15 selection -- excuse me -- a presentation involved in
- 16 the process.
- 17 But what I do think now is that we have a
- 18 company that has followed the process, and they are
- 19 going to come back to make a presentation to us at any
- 20 time and every time that we request.
- 21 And in sitting here and thinking about it,
- 22 during those presentations, I'm certain that we'll be
- 23 given an opportunity to make our -- to make more
- 24 suggestions. We have the negotiation process to go
- 25 through. That will be another opportunity to make our

- 1 suggestions as well.
- I do feel, you know, that Mr. Davis, he made
- 3 some valid comments. The gentleman that spoke made
- 4 some valid comments that they followed the process,
- 5 they ranked the higher, they put their financials up
- 6 front.
- And so what do we do with the fact that the
- 8 other team did not put their financials up? So they
- 9 come in with a presentation. They didn't put their
- 10 financials up. Then what? What difference is that
- 11 going to make to the scoring, the fact that they did
- 12 not bring their financials? So how does -- what I'm
- 13 saying, it's not going to help one way or the other.
- 14 They are not going to have the number of points because
- 15 they did not bring their financials. And that's what
- 16 I'm trying to weed out.
- 17 And the reason I'm bringing this up, because,
- 18 one, no, I don't want it to become a political contest.
- 19 Two, I do -- I'm curious like everybody else. I would
- 20 have liked to have known what we're getting, what are
- 21 people proposing, because, you know, there are some
- 22 things I saw in the pictures that I'm not for.
- 23 CHAIR DAVIS JOHNSON: It is the collective
- decision by this body. We are not a body of one.
- 25 COMMISSIONER DAVIS: Madam Chair.

- 1 CHAIR DAVIS JOHNSON: Mr. Davis, you're
- 2 recognized.
- 3 COMMISSIONER DAVIS: In respect to what
- 4 everybody -- I do believe everybody's here to do the
- 5 right thing in this process. And Ms. Councilperson,
- 6 the Vice Chair just brought up a good point about the
- 7 financial statements. I just want to be a team player,
- 8 whatever it is that we decide to do, just like we was
- 9 back in June of 2017, I want to support this entire
- 10 Board to making a decision.
- And when we chose -- well, when the previous
- 12 Board, years ago, chose a master developer at the time,
- 13 no financial statements was required at the time, and
- 14 we saw what that got this city. This time there was a
- 15 financial statement required, and one group chose to.
- 16 One group, whatever reason they chose -- I can't speak
- for them because I wasn't in those meetings -- chose
- 18 not to do so.
- Now, if there would just happen to be a
- 20 presentation, I think it should be based on what is
- 21 submitted here today. There should be no changes or
- 22 shift because the gentleman, the professional that's
- 23 hired before us, Mr. Nottingham -- I apologize if I
- 24 pronounce it wrong, you have a very unique name -- gave
- 25 a presentation that talked about strengths and

- 1 weaknesses of both teams.
- 2 How can both teams go back fairly and give us
- 3 a presentation that's not different and still we make
- 4 the right decision based upon experience, based upon
- 5 financial capability and based upon approach?
- 6 So now back to the presentation. Like
- 7 Councilwoman -- Commissioner Miller-Anderson is saying,
- 8 she's right. Typically there is the presentation.
- 9 Councilperson Botel, I think, hit a good spot by saying
- 10 if we was -- if this Board chooses to go back, let it
- 11 go back to the selection committee.
- Because I know before the selection committee
- 13 made a decision, it came before the Board. There was
- 14 video footage that was public record anyone can review.
- 15 It had questions, and you know, you could see what's
- 16 happening.
- 17 But we had a committee that sat there
- 18 representing us, which was the technical review
- 19 committee. They took every note that we did in May and
- 20 June and represented our words amongst the questions
- 21 that we told them what we wanted and told both teams
- 22 this is what the Board wanted.
- They responded: Well, they wanted this. And
- 24 they went back and forth, back and forth representing
- 25 this Board, based upon the meetings that we've had,

- 1 which is something that didn't happen the first time,
- 2 which I thought was very unique, because our words and
- 3 our goals to achieve were in that conversation. And it
- 4 took all the politics out of the situation.
- Now, I can come and sell you a pretty
- 6 picture. If it's based upon interviews, do we want to
- 7 make that decision? Or is it based upon qualifications
- 8 and experience? That's the decision I want to make my
- 9 decision on.
- 10 You know, and like Madam Chair said, we got
- 11 to make a decision. You know, if we negotiate with
- 12 them and the negotiations don't work out, it goes to
- 13 number two. If we move forward and they do a wonderful
- 14 job, the City benefits.
- And that's still not to say that, hey, team
- one that has been recommended would reach out to some
- 17 of the folks, get them an opportunity to do that. We
- 18 can't make that a requirement. That's not to say that
- 19 they wouldn't -- that they couldn't do that on their
- 20 own. You know what I mean?
- 21 So it shows that Rivera Beach is moving in
- 22 the right direction. You know, there's not another
- 23 fight at City Hall over something, you know. I mean
- it's competition, not a fight, but it's competition.
- 25 And I'm saying everything I'm saying in

- 1 respect of why we here, and it's not personal. But we
- 2 see what happen when we make -- we're not going to make
- 3 the perfect decision, but the intent, I believe, of
- 4 this Board, the previous Board and this current Board
- 5 put six years of work combined in this decision.
- And the young lady that came and spoke
- 7 before, who came from Royal Palm Beach, talked about
- 8 it. She -- I give her credit. She's been very
- 9 consistent.
- 10 MAYOR MASTERS: Yes.
- 11 COMMISSIONER DAVIS: She sat through all
- 12 those meetings.
- And I give you credit, ma'am. You came to
- 14 all the charrettes, you came to all the workshops, you
- 15 came to the marina. You was one of very few folks from
- 16 the public.
- 17 Because if the public's going to -- and me
- 18 personally, I did my best to take no phone calls,
- 19 because I would have to disclose all these
- 20 conversations with this process, and I didn't want to
- 21 do that. Because I know in Rivera Beach when it's time
- 22 to make a tough decision, your phone will ring like it
- 23 did when you running for office. And it's tough, you
- 24 know.
- I think we got some great professionals on

- 1 both teams. I will say that on record. But someone
- 2 has to win, and that someone is the residents from
- 3 Rivera Beach. And our intent of what we did, I think,
- 4 had integrity to it. We had a chance to interrupt the
- 5 process and say: Hey, when was this going to come
- 6 before the Board?
- We spoke about it on numerous occasions, but
- 8 at no point was anyone concerned about -- well, I ain't
- 9 going to say, because maybe it was assumed, and that
- 10 can be a fair assessment based upon history. And I can
- 11 respect that, and I would have done that too, you know.
- 12 But how do we do this and don't end up with someone --
- 13 this is going to be an interview.
- But the dark -- this information, the
- 15 documentation that we have before us is going to be the
- 16 delivering factor on experience, approach and financial
- 17 capability.
- 18 COMMISSIONER MILLER-ANDERSON: I have an
- 19 idea.
- 20 COMMISSIONER DAVIS: And then we can
- 21 negotiate the community benefit. It comes back before
- 22 this Board for approval. If we don't like it, we move
- 23 to team so-and-so.
- 24 MAYOR MASTERS: Madam Chair.
- 25 COMMISSIONER DAVIS: And that process in

- 1 place to make sure that we have good folks at the
- 2 table, you know, with good, faithful negotiations.
- But I think if we was to do a presentation, I
- 4 can support what Councilperson Botel is stating, with
- 5 the selection committee reviewing it and making another
- 6 recommendation to the Board, and then the winner comes
- 7 before the Board, does a presentation of what was done
- 8 in that meeting, or maybe play a video, because they
- 9 would do the same presentation once again, and then the
- 10 public can get a chance to see.
- But before we can approve this and allow this
- 12 group to come back before this Board to give us a
- 13 presentation of the concept, because this is nothing
- 14 final, they're saying, hey, what you can consider or
- 15 what we could do, you know, based -- but it's all based
- 16 upon a market, a feasibility study.
- 17 VICE CHAIR HUBBARD: (Inaudible.)
- 18 CHAIR DAVIS JOHNSON: Madam Chair, you're
- 19 recognized -- Madam Vice Chair.
- VICE CHAIR HUBBARD: I have a suggestion
- 21 based on some of the things both of you said on the
- 22 end. Let's let them both do the presentation,
- 23 satisfying the community's desire. No, we won't change
- 24 the scoring or the ranking, because -- we won't change
- 25 the scoring because it is what it is. But it will give

Page 62 the -- we will give the community an opportunity to see 1 2 the presentation. 3 The evaluation committee have done their scoring based on what it is. We can't say you go back 4 5 and bring us anything, you go back and bring us 6 anything. We just want to see the wares, and we want 7 both to have the opportunity to show us that. So that everybody can have a little bit of what they want, 8 let's do it that way maybe. 10 CHAIR DAVIS JOHNSON: Are you suggesting that 11 we table the item until after the presentation? 12 COMMISSIONER DAVIS: Yes, ma'am. 13 MAYOR MASTERS: Madam Chair. 14 CHAIR DAVIS JOHNSON: One moment, Mr. Mayor. 15 MAYOR MASTERS: Okay, yes. 16 COMMISSIONER DAVIS: Yes, ma'am. 17 CHAIR DAVIS JOHNSON: Is that what you're 18 recommending, that we table it until after the 19 presentation? 20 VICE CHAIR HUBBARD: Yes, but we can --21 COMMISSIONER DAVIS: Presentation? 22 CHAIR DAVIS JOHNSON: Is that what you're 23 saying? 2.4 VICE CHAIR HUBBARD: Yes. 25 CHAIR DAVIS JOHNSON: All right, one moment.

- 1 Mr. Mayor, you're recognized.
- 2 MAYOR MASTERS: Yes, I heard what
- 3 Councilwoman Hubbard said, but I don't think that we
- 4 should put ourselves in a position to say what we're
- 5 going to do and what we're not going to do, because
- 6 just hearing the presentation is just hearing the
- 7 presentation. But if it's going to have an effect, we
- 8 won't know until we hear the presentation.
- 9 So I don't necessarily agree to say that the
- 10 score cannot change. We don't know what may happen.
- 11 And that's the whole purpose of hearing a presentation.
- 12 I heard from the gentleman, the company from Atlanta,
- 13 Georgia, and he said that he don't have any problem
- 14 with putting on a presentation. And the proof is in
- 15 the pudding. And if he said that, I'm willing to hear
- 16 that presentation; I'm willing to hear the other
- 17 presentation from the other party.
- I think Dr. Botel was right on the track in
- 19 the very beginning when she had said she had residents
- 20 who called. And I'm sure they were not politically
- 21 motivated, but they wanted to hear from both parties.
- 22 And that's where I am with this.
- I do know people in both camps. Mr. Steve
- 24 White is one of my good friends for over 25 years.
- 25 Stallings. Marion, I see over there, I worked with

- 1 several years.
- 2 But I always try to -- I'm not worried about
- 3 the politics of this matter. Every decision you make
- 4 have some political or politics. At the end of the
- 5 day, you're going to be -- and I'm going to use this
- 6 word religiously: You're damned if you do and you're
- 7 damned if you don't. So you might as well do and let
- 8 the people hear it. And at the end of the day, if what
- 9 you say is good, if what you say is good, then at that
- 10 point, then we can rock and roll.
- 11 So I want to stick with a public
- 12 presentation, but not -- without any necessary
- 13 restrictions. Thank you, Madam Chair.
- 14 COMMISSIONER MILLER-ANDERSON: Madam Chair.
- 15 CHAIR DAVIS JOHNSON: Commissioner
- 16 Miller-Anderson, you're recognized.
- 17 COMMISSIONER MILLER-ANDERSON: Well, I don't
- 18 want it to give the perception -- if I was the other
- 19 person, why would I come and do a presentation if it's
- 20 just -- if we're going with what we're going to go with
- 21 based on the recommendation? That, I don't support
- 22 that, and that's not where I am with it.
- 23 As I stated earlier, there are many questions
- 24 that I still have. What Mr. Evans is bringing forth to
- 25 us is a recommendation. There are many things to still

- 1 discuss. I know we had a selection committee, but I
- 2 even wonder, you know, what is -- I'm not aware of
- 3 those on the selection committee even having this
- 4 background and being able to truly evaluate.
- 5 And I haven't -- you know, I don't want to
- 6 make it seem like I don't -- I don't want to discredit
- 7 your organization and businesses, because I don't. But
- 8 I just know that, you know, sometimes we rush through
- 9 things and we do things for the wrong reasons, or we
- 10 select people for the wrong reasons, or we have people
- 11 on there that have conflicts, which I did bring up to
- 12 Mr. Evans some time ago, that I felt there was conflict
- 13 of interest on -- in many areas; in whether they list
- 14 people on the selection committee or whether it was the
- 15 people involved on the teams, or just a number of
- 16 things.
- 17 So for me, with the presentations, I'm not
- 18 saying to have the presentations done just to present.
- 19 I still have questions that I want to ask after the
- 20 presentations. And again, what Mr. Evans is bringing
- 21 forth is a recommendation. So I just wanted to go on
- 22 record that if that's the case, we need to just go

- 3 home, at a party somewhere. Halloween. This is not
- 4 right.
- 5 The whole thing tonight didn't need to
- 6 happen; did not need to happen had we followed
- 7 procedure. A presentation, that's like a normal
- 8 no-brainer thing to do.
- 9 Ms. Tonya Davis Johnson, you asked why that
- 10 didn't happen. The people are here tonight who can
- 11 tell you why that didn't happen, but if you don't ask
- 12 them, we're not going to know. Remember that.
- 13 Also, as far as a presentation goes, now
- 14 between the two groups there are two things which are
- 15 necessary. ADP, APD -- we don't know because there's
- 16 typos all over this thing -- that group must be
- 17 licensed in Florida. If they're not, we can't even
- 18 consider them.
- The Tony Brown Group, if they don't want to
- 20 give their financials, they're out of the picture.
- 21 That's a requirement. We went through this with
- 22 Viking. We're not going through it again. If they
- 23 don't want to do financials, they're out of the group.
- 24 So we may not have a presentation if both groups don't
- 25 do what they need to do, be licensed in Florida for the

- 1 ADP group if they're not, and financials from the Tony
- 2 Brown group. We won't have to waste three more hours
- 3 on this.
- 4 Tonight we still don't know, I still don't
- 5 know what the cost is to rehab the BB&T building on
- 6 Blue Heron and Broadway. Didn't see the reports. I've
- 7 asked for them. I will go over and get them. But we
- 8 don't know the cost. So we're being asked, you are
- 9 being asked to sign a check or approve money when we
- 10 don't know the cost. We can't continue this way.
- 11 Successful cities don't do it this way.
- 12 If you have nonspecific questions, no one on
- 13 staff -- and I'm not singling out anybody, but no one
- 14 on staff is accountable or responsible. We want to be
- 15 an up-and-coming city who does things the right way and
- 16 who -- we know what we're doing. People are laughing
- 17 at us.
- I have a couple what's happening questions.
- 19 What's happening on Avenue F and Blue Heron? That's
- 20 the place you're going to put Tony's Subs. What's
- 21 happening with that property?
- The parking mall at Ocean Mall. Ms. Botel,
- 23 you mentioned that like a lot of construction workers
- 24 are using the space there. Simple solution to that.
- 25 Developers must provide parking. If not, you put a

- 1 policeman right at the Ocean Mall. If they're wearing
- 2 a hard hat, they got to go to those two lots that we
- 3 bought for parking or the parking lot that we rented.
- 4 You can tell between a hard hat and a bikini. You go
- 5 this way or you go that way. Problem solved.
- 6 Cash America, dumpster behind Cash America.
- 7 I've brought this up about five times. All it is is a
- 8 phone call. Please get those covers put on there at
- 9 the dumpster. We've got a raccoon now coming, all
- 10 right? Those dumpsters are open all the time. That's
- 11 open all the time; the car wash is open all the time.
- 12 People throw their food from lunch in there. We've got
- 13 a raccoon now. I'm not happy about that.
- 14 The sign -- the air-conditioner on top of the
- 15 building there, Cash America, needs to go. The sign on
- 16 top of Dairy Belle needs to go.
- 17 And so let's figure out if we need a
- 18 presentation, because if those two companies don't
- 19 comply with our requirements, we're wasting our time
- 20 here. And it's a shame that we only had two
- 21 applicants. We know why we only had two. Thank you.
- 22 THE CLERK: Tommy Walker, followed by Steve
- 23 White.
- 24 MR. WALKER: Tommy Walker, 15 -- I feel like
- 25 just standing up here breathing for three minutes, what

- 1 I just went through. This is why it's very hard for
- 2 people to do business with us.
- 3 T. D. and I don't agree on a lot of things,
- 4 but I appreciate the way you laid that out, going all
- 5 the way back to June. I don't see what the difference
- 6 a presentation is going to make. I know we -- I would
- 7 want to see one. But Scott and his crew, everybody did
- 8 their due diligence, and they came up with a winner. I
- 9 am ready to move this city forward.
- 10 Oh, let me take this up. It's just time for
- 11 us to go forward. I don't know how to -- and sometime
- 12 I don't agree -- I think this may be the first time me
- and my queen disagree on something, but T. D. laid it
- 14 out, and I was expecting a vote.
- 15 And all this other stuff that I wrote down
- 16 here, I'm going to table till I hope that in your
- 17 hearts that you take the numbers -- I love Ezra, just
- 18 like most of you -- that we get the best company for
- 19 the job and they seem like somebody that we can work
- 20 with.
- 21 Make sure local participation is all we
- 22 worrying about. We don't want to spend \$40 million
- 23 like we did and we didn't create no black millionaires.
- 24 The money has to stay here; some of the money has to
- 25 stay here, and I'm hoping you guys will make sure of

- 1 that.
- It's been a pleasure. I learned a lot. I'm
- 3 looking forward to the next -- I don't even normally
- 4 come to CRA meetings, but I'm looking forward to the
- 5 next CRA meeting. Thank you very much.
- THE CLERK: Steve White.
- 7 MR. WHITE: Steve White.
- 8 So based on the decision that you all just
- 9 made, Ms. Miller-Anderson said that she doesn't want
- 10 the presentations that's going to be made going forward
- 11 to be a dog and pony show. But you established a
- 12 process, and we followed the process, the ADP team
- 13 followed the process. So what you've essentially done
- is made that process a dog and pony show.
- And so now, I mean if we're going to really
- 16 be honest about it, what has happened is one team
- 17 prevailed and one team lost. And basically what you're
- 18 saying is now we're going to replay the game because
- 19 one team lost.
- 20 And so if you want the people in this city to
- 21 value the integrity of the City and the integrity of
- 22 the process, that decision should never have been made,
- 23 to not honor a process that you all gave your okay to.
- 24 So you gave your okay to the process, we followed the
- 25 rules, including providing the financials and

- 1 everything that was required. One team chose not to
- 2 adhere to the rules, and now they get another bite at
- 3 the apple.
- 4 So you're asking the people to trust the
- 5 process, but you just made your own process a lack of
- 6 integrity by not honoring what you all put in place.
- 7 So if you go forward and presentations are allowed to
- 8 be made, as you all have decided that will be done,
- 9 what happens now if the other team prevails? How can
- 10 anyone trust that process? So it's really disingenuous
- 11 on what just happened.
- 12 You know that I love this city, born and
- 13 raised here, and I became a part of this team because I
- 14 really believe that it's an opportunity for us to do
- 15 something very, very positive in this community.
- 16 Mr. Walker talked about local participation.
- 17 We have local participation. I became a part of this
- 18 team because we're going to make sure that there are
- 19 community benefits. And that's really something that
- 20 I'm very, very passionate about. We're going to do
- 21 something that has not been done in the city before.
- 22 Viking did violate the integrity of this city
- 23 and did not do what they were supposed to do. Now you
- 24 have a group here that's 100 percent committed to doing
- 25 what needs to be done in this city, and you've really

- 1 just said to this team, to our team that all of the
- 2 effort that we put forth in a good faith effort is now
- 3 going to be disavowed and you're going to allow the
- 4 game to be replayed again. You can't -- that's -- I
- 5 don't know how you all can really justify doing that.
- 6 That is really not -- it's not fair.
- 7 You keep talking about the residents of the
- 8 city. It's not fair to the residents. It's not fair
- 9 to say we established a process, one team played by the
- 10 process, won fair and square, but now we're going to
- 11 throw that process out and replay the game. That's
- 12 just not fair.
- And I don't know what you all can do, but you
- 14 can't put the genie back in the bottle. You can't
- 15 allow, after we've made our presentation and everything
- 16 now to say to the other team that they get another
- 17 chance to make the presentation. You all, this is
- 18 disingenuous, and it's really not fair to the residents
- 19 of this city. Thank you.
- 20 MR. HAYGOOD: In response -- and I don't
- 21 usually do this -- you have the right under your
- 22 procurement code to interview. Any recommendation that
- 23 comes forward from a selection committee specifically,
- 24 you have the right to do interviews, period.
- 25 CHAIR DAVIS JOHNSON: Are there any further

Page 93 questions or comment? That's all the comments? 1 2 Mr. Walker -- Mr. White was the last comment card? 3 THE CLERK: Yes, Madam Chair. 4 CHAIR DAVIS JOHNSON: Okay, thank you. 5 VICE CHAIR HUBBARD: I hear what our attorney 6 is saying, we have the right to interview. The only 7 thing is that has put us in a bad situation tonight is the fact that staff did not put that in the process, 8 giving us an opportunity to have a presentation or to 9 10 interview. 11 And that's what I say to staff, because you have half of the community, half of the Council saying 12 people are calling them, asking for a presentation, and 13 the other half is saying, you know, how can we change, 14 you know, how can we put the genie back in the bottle, 15 16 how can we change a process that we already voted on 17 and said that we were going to go forward with? The only thing is, I think that it's going to 18 19 hold a little bit of integrity to the process is the 20 fact that, one, no one will be able to make a 21 presentation or to make anything outside what has 22 already been given to us. And I understand what has 23 been said, and I agree wholeheartedly with what has 2.4 been being said. 25 But only just to appease those that want to

- 1 see something or felt that they too had a right to have
- 2 seen a presentation, I don't think that it will hurt
- 3 the process, because no one's going to be able to
- 4 submit any documents that they haven't already
- 5 submitted, nor will anybody be able to present anything
- 6 outside of what their script says. So I think it will
- 7 be okay. And I do understand exactly how you feel, and
- 8 it's -- so that's, I guess -- and that's, you know,
- 9 it's best to be on the prevailing side of decisions,
- 10 you know.
- 11 COMMISSIONER DAVIS: Madam Chair.
- 12 CHAIR DAVIS JOHNSON: We took the vote to
- 13 table this?
- 14 THE CLERK: Yes, Madam Chair.
- 15 CHAIR DAVIS JOHNSON: Okay. Mr. Davis,
- 16 you're recognized.
- 17 COMMISSIONER DAVIS: Thank you.
- 18 I want to say to the residents of Riviera
- 19 Beach, please be patient with us in this process.
- 20 Let's stay together through this process. Allow this
- 21 Board to make a decision with the understanding that
- there's more than one person in the city of Riviera
- 23 Beach. We have people that do construction, people
- 24 that do building maintenance, we have electricians, we
- 25 have plasterers, we have finance people, we have

- 1 people, electricians, we have it all.
- 2 So when this come back before this Board, and
- 3 respect to all my colleagues up here, please allow them
- 4 and myself to make a professional decision. Let's not
- 5 make this a political decision. Let's make this a
- 6 professional decision based upon everybody that's going
- 7 to benefit in this community, not one individual. I'm
- 8 going to say it again: Not one individual. And I'm
- 9 talking to the community.
- If you come to the meeting, I welcome you.
- 11 I'm sure we all welcome you. But let's all have an
- 12 open mind with the understanding that we've had some
- things put in place to give us some strong foundation
- 14 of what we're looking at. And now we all may have some
- 15 other individual conversations and questions that we
- 16 want to get answered with respect to everyone on this
- 17 Board.
- But let's not allow what happened tonight to
- 19 create any kind of negativity on our brand or friction
- 20 in our community. Let's keep the public in mind,
- 21 everyone, how this project is going to filter
- 22 throughout this city.
- You had one, maybe two master developers
- 24 historically in this city, and we know what we got, all
- 25 right? Now we're in a position to get the best

- 1 qualified and experienced qualified candidate, whoever
- 2 that may be, to the table. And allow us to -- respect
- 3 all my colleagues -- to make a decision. That's all I
- 4 ask.
- 5 And I commend you, Board, for wanting to take
- 6 your time and doing this. I'm with you. But we have
- 7 to give them something great. They have to trust that
- 8 we want to do it.
- 9 And unless, for the first, one of the first
- 10 times in Riviera Beach, if nothing happens tomorrow or
- in another two, three months of my life, if something
- 12 happens and I'm just not here anymore, I can feel proud
- 13 that I sat here with you guys and made a decision that
- 14 was not driven in the wrong direction, but driven in
- 15 the right direction of the people. Not saying anyone
- 16 on this Board is doing that. I'm just saying how we
- 17 come -- how we stay together and ask the public, when
- 18 they do come, we want you to come, but please work with
- 19 us. That's all I'm stating.
- 20 CHAIR DAVIS JOHNSON: I want to take this
- 21 opportunity on behalf of the Mayor and the Board to
- 22 thank you, Mr. Irons, for being here with your team, as
- 23 well as the Tezral team and Mr. Saffold.
- 24 We understand that it is a process, and we
- 25 certainly don't want you to think that we have

- 1 discredited anything that has been proposed by either
- 2 proposer. We just simply want to see that the process
- 3 grows out.
- We've had the request to have presentations.
- 5 That is something that you do in the normal course of
- 6 business. I know that this is not outside your realm,
- 7 so we look forward to your presentation at the next
- 8 meeting.
- 9 But I certainly wanted to thank you both,
- 10 Mr. Nottingham, for the work that you've done, and to
- 11 staff. But we have to tighten up some things on the
- 12 staff side as we move forward, before we send things to
- 13 the Board for its approval without having had an
- 14 opportunity to ask the questions that we deem are
- 15 important before making a decision such as this.
- So thank you on behalf of the Mayor and the
- 17 City Council, and -- I'm sorry -- and on behalf of the
- 18 Commissioners, the CRA Commissioners.
- 19 Report of the Executive Director. Do you
- 20 have anything further, sir?
- 21 INTERIM EXECUTIVE DIRECTOR EVANS: Nothing
- 22 further, Madam Chair.
- 23 CHAIR DAVIS JOHNSON: Report of general
- 24 counsel.
- MR. HAYGOOD: I have nothing further.

- 1 CHAIR DAVIS JOHNSON: Discussion of the
- 2 Board. Mr. Mayor, would you like to make any comment?
- 3 MAYOR MASTERS: Yes. I echo the comments
- 4 from the previous speaker, our Chair, but I do want to
- 5 remind Mr. White that the gentleman from Atlanta did
- 6 say that you would be willing to make a presentation,
- 7 and I commend you for making that statement.
- I do want to conclude tonight again --
- 9 Mr. Willis Williams handed me his ballot to turn in.
- 10 But this is what it looks like. This is an absentee
- 11 ballot. Do not get this confused with a sample ballot.
- 12 But this is what it looks like.
- 13 If you have this at your house, please open
- 14 it up, fill it out, sign it. And make sure when you
- 15 sign, it is your original signature that's on record.
- 16 Don't do anything fancy, because it will not match. So
- 17 please, your regular signature. And no one can sign
- 18 this ballot for you. Make sure you sign it, and make
- 19 sure you date it. There's a little box here. If you
- 20 want the absentee ballots to continue to be sent to you
- 21 by the Supervisor of Elections, Susan Bucher, please
- 22 check that little box.
- 23 Again, we have hundreds out that have not
- 24 been returned, and it's almost getting too late to mail
- 25 them. Please go vote. Take the ballot, this thing,

- 1 with you over to Wells. They will cancel this and
- 2 they'll let you vote early. Or give me a call, and as
- 3 a courtesy and voluntarily, voluntarily I would come to
- 4 your house and get your ballot. Please have it filled
- 5 out, please have it in the envelope, have it signed by
- 6 you. Husbands cannot do wives; wives can't do
- 7 husbands. Please, sign your own ballot.
- And I will be happy to come, or someone from
- 9 the team of volunteers will be very happy to come and
- 10 get it in right away, because we're getting close to
- 11 the mailing deadline. The number again, I'll repeat it
- 12 twice: 561-247-2713; 561-247-2713.
- Dr. Botel, have a good trip in India when you
- 14 leave tomorrow.
- 15 Thank you, Madam Chair.
- 16 CHAIR DAVIS JOHNSON: Mr. Davis, any comment?
- 17 Any comment, Mr. Davis?
- 18 COMMISSIONER DAVIS: I would just say Happy
- 19 Halloween to everyone.
- 20 MAYOR MASTERS: It's almost over.
- 21 COMMISSIONER DAVIS: Please check your
- 22 children's candy. Be safe. Things are changing now
- 23 with the different time, but please check your
- 24 children's candy, put them to bed at a decent time,
- 25 don't give them candy too late.

- 1 COMMISSIONER MILLER-ANDERSON: Don't bring it
- 2 to school.
- 3 COMMISSIONER DAVIS: Don't bring it to
- 4 school.
- 5 To the Board that's here tonight, we have
- 6 some work to do. Staff knows what's anticipated, and I
- 7 look forward to delivering the best product that we can
- 8 deliver to those in the city.
- 9 To Mr. Saffold and his team, good luck. To
- 10 the team that's here, good luck. Thank you all for
- 11 coming out.
- But once again, to the residents at home,
- 13 please work with us to deliver the best product. Be
- 14 here with us. Do not push; do not push. Let's make
- 15 sure that we have an exciting opportunity to deliver
- 16 the best product, because when you have winners and
- 17 losers, you know, it -- and the only person I want to
- 18 see win is the residents from Rivera Beach, and whether
- 19 they -- from not just on beginning the project, but for
- 20 the next 50 years of that particular development
- 21 opportunity. You know, you're talking over
- 22 \$200 million of economic development. We're in 2018,
- 23 rolling to '19.
- 24 Michelle Obama said it the other day, you
- 25 know. She said, you know, she was talking to her

- 1 children about casting a vote. You know, when you
- 2 don't vote, you don't want someone casting a vote that
- 3 never had the opportunity, they didn't grow up around
- 4 cell phones. You are choosing your app. Michelle,
- 5 that's the comment she made.
- So when we make this decision, we can't hold
- 7 up from making the decision because time is of the
- 8 essence. The market is not waiting on us. We all
- 9 getting older, we all want to get better, but we all
- 10 got to deliver something as we choose our process for
- 11 the residents of Rivera Beach.
- 12 And I hope that developers, the people that
- 13 we choose and the ones that we don't choose find a way
- 14 to just get better, because we have more projects. You
- 15 know, we're talking about across the street from this
- 16 complex doing a P3. It's going to be extremely
- 17 significant. In the future, I'm sure that as we get
- 18 parking at the Ocean Mall and future development in
- 19 that area, that's going to be more development.
- 20 So there's much to come in this great city,
- 21 and we want to make sure that we set this tone as we
- lead off to other opportunities for whichever developer
- 23 was to choose, respond. But I do believe what drove us
- 24 to respondents is the critical and the most focus that
- 25 we had on the local participation and the community

- 1 benefit.
- I do believe that folks that may or may not
- 3 stay in the game may have had an issue with that. But
- 4 we do have a chance to say thank you to those who did
- 5 commit to that. And I think that definitely goes, that
- 6 say a lot about for the first time we had put something
- 7 in place as a Board that draw developers that was
- 8 interested in our community.
- 9 CHAIR DAVIS JOHNSON: Commissioner Botel.
- 10 COMMISSIONER BOTEL: Thank you. I'm leaving
- 11 at 5:00 in the morning for India.
- MAYOR MASTERS: Why are you still here?
- 13 COMMISSIONER BOTEL: Thank you. I have not
- 14 packed one thing yet. So let's go back.
- But I will say before I leave I want to get a
- 16 commitment, before we make any decision, from both
- 17 Mr. Irons and the other team. We visited FIU
- 18 yesterday. I took a team of people down on the
- 19 Brightline, my first trip on the Brightline, down to
- 20 visit the construction trade certification program at
- 21 FIU.
- We are going to attempt to bring that program
- 23 to Rivera Beach. It's being funded by Lennar
- 24 Construction Foundation. I'm meeting with Mr. White.
- 25 I've already put some of it into my calendar on the

- 1 19th because we're going to have a mentoring component
- 2 of that project.
- And I really want to be sure that when we
- 4 train young people in this community for construction
- 5 jobs, that there's going to be a place for them in this
- 6 project. That's really important for us, that we have
- 7 a place for those young people once they learn those
- 8 skills, that they have a place to put them to work in
- 9 this community. So I'm hoping to work with you on that
- 10 in the future.
- And thank you again to both teams for being
- 12 here. Appreciate that you were here, and I look
- 13 forward to hearing a presentation from you.
- 14 MAYOR MASTERS: Have a great trip.
- 15 CHAIR DAVIS JOHNSON: Commissioner
- 16 Miller-Anderson.
- 17 COMMISSIONER MILLER-ANDERSON: I just want to
- 18 say thank you to the both of the teams. And I
- 19 certainly concur with a lot of what Ms. Davis Johnson
- 20 has stated in regards to the staff tightening up on
- 21 some things. And like I said before, I do have some
- 22 concerns, and I will voice them during our next
- 23 meeting.
- 24 Mr. Evans or someone's going to mention about
- 25 the youth thing on Saturday, that announcement. So I

- 1 don't have it front of me, so I didn't know if you were
- 2 going to do that. That's it for me.
- 3 CHAIR DAVIS JOHNSON: Vice Chair.
- 4 VICE CHAIR HUBBARD: I too thank you for
- 5 presenting your proposal. We look forward to your
- 6 presentation.
- 7 And I want to remind everybody that on
- 8 November the 3rd, Saturday coming, at Cunningham Park
- 9 we're going to have the ribbon cutting, and I hope that
- 10 everyone will come out and attend. There are great
- 11 things going on in the city, and we look forward to
- 12 many, so --
- 13 MAYOR MASTERS: Tell them where the park is
- in case they don't know.
- 15 VICE CHAIR HUBBARD: The park is on 29th and
- 16 S Avenue in Riviera Beach; 29th and S Avenue. We will
- 17 start at 10 a.m. And we look forward to having each of
- 18 you come out to participate, and everybody is welcome.
- So Happy Halloween. Everybody be safe
- 20 tonight.
- CHAIR DAVIS JOHNSON: Mr. Evans, you want to
- 22 announce the youth event?
- 23 INTERIM EXECUTIVE DIRECTOR EVANS: Yes. The
- 24 Palm Beach County Sports Commission, in working with
