WHEREAS, All-Site Construction, Inc. entered a competitive bid with Palm Beach County for continuing contract for construction manager at risk services for various capital improvement projects and was awarded Contract No: R2018-1162 on August 14, 2018; and

WHEREAS, this contract allows All-Site Construction, Inc. to supply the subject services to other agencies under the same prices, terms and conditions; and;

WHEREAS, the City of Riviera Beach Utility Special District wishes to utilize the services of All-Site Construction, Inc.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CITY OF RIVIERA BEACH UTILITY SPECIAL DISTRICT, AS FOLLOWS:

SECTION 1: That the Utility Special District Board approves the contract for All-Site Construction, Inc. in an amount not to exceed \$476,579.50 to provide temporary modular building via a cooperative agreement with Palm Beach County contract awarded on August 14, 2018.

SECTION 2: That the District Board Chairperson and District Clerk are authorized to execute the contract between the Utility Special District and All-Site Construction, Inc.
