The total market value of the fund was under 119.2 million.

The fund has a return of 2.4% for the current quarter and 10.3% for the last 12 months.

Over shorter periods of time (5 year moving average), total fund performance is expected to out-perform and index portfolio comprised of 30% S&P 500, 30% Russell 2500, 30% Barclays Aggregate Bond index, and 10% NCREIF ODCE index.

Over a period of one complete market cycle (3-5 years), the total fund is expected to meet its actuarial target of 7.25%.

I'm deeply and sincerely grateful for the confidence you have placed in me as trustee for the City of Riviera Beach General Employees' Pension Board. You have given me the opportunity to serve in my city. "Many thanks to you." Your vote to re-appoint me for continued service to the General Employees' Pension Board will be highly appreciated.
