A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, RATIFYING THE CITY COUNCIL VOTE ON OCTOBER 17, 2018 TO RENAME THE RIGHT OF WAY PRESENTLY KNOWN AS WEST 28TH STREET SPANNING FROM WEST OF AVENUE 'S' CONTINUING TO BROADWAY AS "BISHOP JOHN D. ALEXANDER STREET"; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the section of West 28th Street from Broadway to Avenue 'S' is platted road right-of-way; and

WHEREAS, Bishop John D. Alexander was the pastor of Pentecostal Church of God located at 1289 W 28th Street; and

WHEREAS, Mayor Masters requested the renaming of the aforementioned section of West 28th Street from Broadway to Avenue "S" to "Bishop John D. Alexander Street"; and

WHEREAS, the Mayor and City Council finds that the renaming of said section is appropriate.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, THAT:

SECTION 1: The City Council hereby ratify its vote on October 17, 2018 renaming the section of West 28th Street from Broadway to Avenue "S" to "Bishop John D. Alexander Street".

SECTION 2. The City Council authorizes staff to transmit this resolution to the appropriate intergovernmental agencies.
