



THE BACKGROUND

- THIS ITEM WAS BROUGHT TO THE OCTOBER 10, 2018
- BOARD REQUESTED THE FOLLOWING CHANGES
- 1. THE REQUIREMENTS FOR THE RFP BE MORE DETAILED AND RESTRICTED TO ACCEPTING SOLICITATIONS FROM A BUSINESS THAT HAS BEEN IN OPERATION FOR THREE YEARS OR LESS.
- 2. THE SOLICITATION SHOULD EXCLUDE BUSINESSES WHO ARE EXPERIENCING HIGH PROFITS AND RESTRICT ACCEPTANCE OF SUBMITTALS FOR BUSINESS EXPERIENCING AN ACCUMULATED YEARLY REVENUE EXCEEDING \$100,000.
- 3. REQUIRE THE SUBMITTER TO FURNISH FINANCIAL DOCUMENTATION TO VERIFY INCOME.

THE BACKGROUND

- 4. LEASE PERIOD WILL BE MODIFIED TO TWO YEARS WITH A POSSIBLE ONE YEAR OPTION.
- 5. CHANGE THE NAME OF THE RFP FROM INCUBATOR TO AN INITIATIVE THAT RESEMBLES A MICRO STARTUP BUSINESS.
- 6. A MODIFICATION OF THE CRA'S CONTRIBUTION TO MAKE THE OPPORTUNITY ATTRACTIVE TO STARTUP BUSINESS.
- 7. PROVIDE THE SUBMITTER WITH RECOMMENDED USAGES FOR THE SPACE.

- EMERGING MICRO BUSINESS ENTREPRENEUR-MUST MEET THE FOLLOWING CRITERIA
- PRIVATELY OWNED & OPERATED
- OPERATING STAFF NOT EXCEEDING THREE
- AN OWNER SEEKING A BRICK & MOTOR LOCATION
- BUSINESS CAN ONLY BE IN OPERATION FOR LESS THAN THREE YEARS
- BUSINESS MUST BE DOMICILED IN PALM BEACH COUNTY WITH SPECIAL CONSIDERATIONS TO RIVIERA BEACH
- ACCUMULATING A YEARLY REVENUE LESS THAN \$75,000 A YEAR.

RFP DETAILS & PROGRAM REQUIREMENTS

• BUSINESS PLAN- THE PROPOSER SHOULD PROVIDE A COMPREHENSIVE BUSINESS PLAN THAT CLEARLY EXPLAINS THE VISION OF THE BUSINESS, A COMPLETE SWOT ANALYSIS, AND HOW WILL THIS BUSINESS VENTURE BE SUCCESSFUL IN THE AFOREMENTIONED LOCATION.

- FINANCIAL VERIFICATION- THE PROPOSER WILL BE REQUIRED TO FURNISH THE FOLLOWING DOCUMENTATION SO THAT THE BUSINESSES FINANCIALS CAN BE VERIFIED.
- LAST TWO YEARS TAX RETURNS
- A COPY OF THE BALANCE SHEET
- COPY OF A COMPLETED W-9 FORM
- COPY OF THREE MOST RECENT BANK STATEMENTS.
- COPY OF BUSINESS LICENSING
- COPY OF SUNBIZ DOCUMENT AFFIRMING LEGAL BUSINESS ENTITY

RFP DETAILS & PROGRAM REQUIREMENTS • BUSINESS READINESS CERTIFICATION- THE BUSINESS OWNER AWARDED WILL BE REQUIRED TO PARTICIPATE IN THE BUSINESS READINESS CERTIFICATION TRAINING HELD BY THE SMALL BUSINESS RESOURCE CENTER. • SIX WEEK 2 HOUR SESSION • MARKETING STRATEGIES • ACCOUNTING • LICENSING & INSURANCE • CREDIT AS AN ASSET

- COST BREAKDOWN- THE PROPOSER SHOULD COMPLETE THE COST BREAKDOWN SHEET TO REPORT THEIR PROPOSED FINANCIAL CONTRIBUTIONS TO THE REHAB LINE ITEMS.
- THE AGENCY AGREES TO COMMIT \$32,500 TO THE REHAB AND BUILD OUT EFFORTS.
