This letter is written in accordance with the requirements of Florida Statute, <u>Section 287.057(3)(c)</u>, The Procurement of Personal Property and Service, confirming that to the best of our knowledge Property Registration Champions Corp., a Florida Corporation and a Community Champions Company ("PRC") is the sole provider of the property registration program services that includes, but is not limited to, the identification, notification and enforcement of property registration compliance program ("Program") in conjunction with Local Government Ordinances and policy as established.
