SERVICE AGREEMENT

This Contract for Services (this "Agreement") is made effective as of _____, 20___, by and between **Riviera Beach Public Library** (requesting party) ("hereinafter host"), and Ersula Odom-McLemore dba Sula Too, LLC of 5508 N 50th Street, Suite 16A, Tampa, Florida 33610 (hereinafter Sula Too").

I. DESCRIPTION OF SERVICES. Beginning on February 14, 2019, *Sula Too* will provide to *the host* the following services (collectively, "Services"):

II. PAYMENT FOR SERVICES.

A. Pursuant to this Agreement, in exchange for the Services described herein, the *host* will pay compensation to *Sula Too* in the amount for performance and per diem expenses:

- \$500 2/14 event
- \$375 2/15 event
- \$120 up to \$150 Hotel
- \$218 mileage (Based on Riviera Beach - approximately 400 miles, roundtrip from Tampa)
- \$0 Food as lunch will be included at the event and with hotel providing breakfast
- Total: \$1,213

B. Payment shall be presented to performer on or before the day of performance. No later than immediately after performance conclusion.

III. TERM. This Contract will terminate automatically upon completion of the Services by *Sula Too* as required by this Contract, or at some other time as agreed upon by the parties of this Agreement.

IV. WORK PRODUCT OWNERSHIP. *Sula Too* LLC reserves all rights to the performance and recordings are not permitted unless authorized by performer in advance of performance.

V. WARRANTY. *Sula Too* shall provide its services and meet its obligations under this Contract in a professional and timely manner, using knowledge and recommendations for performing the services which meet generally acceptable standards on similar projects.

VI. REMEDIES. In addition to all other rights, a party may have available according to law, if a party defaults by failing to substantially perform any provision, term or condition of this Contract (including without limitation the failure to make a monetary payment when due), the other party may terminate the Contract by providing written notice to the defaulting party. This notice shall describe with sufficient detail

the nature of the default.


