I am pleased to provide the enclosed proposal for the Sam Cooper Way Emergency Repair and Water Main Abandonment project in Riviera, Florida. The bid is based off the GIS aerial photograph supplied via email correspondence, known Riviera Beach technical specifications, standard details and onsite meetings with the City's staff. This proposal is intended to be utilized in conjunction with the piggyback agreement with Johnson-Davis, Inc. Due to the Emergency nature of this project and potential inaccuracies with the GIS system, it would be recommended to perform this work on a time and material basis.

The scope;

Temporarily repair roadway from alleged damage caused by HDD contractor in Riviera Beach. Pothole and locate existing main configurations. Identify needed repairs to water main. Cut and cap unnecessary AC main and abandon by grouting. Add requested water services (2) on newer main. Complete permanent restoration of roadway according to City specifications in addition to all other areas affected by construction activities. The project includes geotechnical testing for records.

Exclusions are any engineering, governmental impact fees or required permits. These may be added and passed on at cost.
