## RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, APPROVING THE RENAMING OF THE RIGHT OF WAY PRESENTLY KNOWN AS WEST 34<sup>TH</sup> STREET SPANNING FROM BROADWAY TO AVENUE "S" TO "REVEREND LEROY PARRISH STREET"; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, the section of West 34<sup>th</sup> Street from Broadway to Avenue "S is platted road right-of-way; and

**WHEREAS**, Reverend Leroy Parrish was called to pastor the Pleasant Heights Missionary Baptist Church in 1988. Thereafter and over the ensuing 39 years Pastor Parrish has continued to be an exceptional visionary, an excellent teacher and a great leader in his service to our Riviera Beach community; and

**WHEREAS**, the Mayor has requested the renaming of the aforementioned section of West 34<sup>th</sup> Street from Broadway to Avenue "S" to "Reverend Leroy Parrish Street" in honor of the leader of the Pleasant Heights Missionary Baptist Church family, who also is a former employee with the City of Riviera Beach, having retired after 30 years in the Public Works Department. The Mayor has provided City Staff with supporting documentation; and

**WHEREAS**, Pastor Parrish and the Pleasant Heights Church family have agreed to adopt the renamed street with plans to engage the neighbors and property owners focusing on community clean-up and beautification, as well as on neighborhood crime prevention programs. In addition to the aforementioned street adoption programs, Pastor Parrish and the Pleasant Heights Church family have also pledged to partner with various non-profits within the City and with members of any other concerned neighborhood organizations to promote a climate of positive change throughout the City of Riviera Beach; and

**WHEREAS**, the Mayor and City Council find that the renaming of the section of West 34<sup>th</sup> Street from Broadway to Avenue "S" to "Reverend Leroy Parrish Street" is appropriate.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, THAT:

**SECTION 1:** The Mayor and City Council approve the renaming of the section of West 34<sup>th</sup> Street from Broadway to Avenue "S" to "Reverend Leroy Parrish Street".

**<u>SECTION 2.</u>** The City Council authorizes staff to transmit this resolution to the appropriate intergovernmental agencies.

**<u>SECTION 3.</u>** This Resolution shall take effect immediately upon its passage and approval by the City Council.
