MEDIATION SETTLEMENT AGREEMENT

The Parties agree as follows: Pending approval of the Riviera Beach City Council,

- 1) The Defendant, City of Riviera Beach, will pay the sum of NINETY THOUSAND DOLLARS AND ZERO CENTS \$90,000.00, payable to Plaintiff(s) and plaintiffs counsel's trust account (Plaintiff counsel's FEIN #43504734) in exchange for mutually agreeable release of all claims against this Defendant arising out of this action. Upon receipt and bank clearance of settlement proceeds, Plaintiff counsel shall file a dismissal with prejudice/stipulation for dismissal. City Council approval will be sought within forty-five (45) days of this settlement agreement.
- 2) Payor shall render the release to Plaintiff's counsel within five (5) days from City Council's approval and shall have fifteen (15) days from receipt of the executed release to tender payment. Plaintiff authorizes and Plaintiff counsel agrees to hold all settlement funds in trust until fully executed release has been returned to Defense counsel.
- 3) The Plaintiff shall satisfy or resolve all liens and subrogated interests.
- 4) If all parties are not present, then the signatories to this Mediation Settlement Agreement further agree that they have full and total authority to execute this Mediation Settlement Agreement on behalf of any litigants not present at the mediation.
- 5) Each party pays its own attorney's fees and costs, unless stated otherwise below.
- 6) The Mediator is the mere scrivener of this agreement, and all terms are solely those of the parties.
