WHEREAS, the cooperative agreement expires May 7, 2020.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CITY OF RIVIERA BEACH UTILITY SPECIAL DISTRICT, AS FOLLOWS:

SECTION 1: That the USD Board approves the contract for Barney's Pumps, Inc. in an amount not to exceed \$325,000 to provide all materials, labor, and equipment in order to supply Barney's Submersible Sewage Pumps and Accessories as set forth more fully in Exhibit "A".
