**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, AUTHORIZING THE DIRECTOR OF FINANCE AND ADMINISTRATIVE SERVICES TO APPROPRIATE FUND BALANCE IN THE MAJOR DISASTER FUND NUMBER 607-00-271000 IN THE AMOUNT OF \$178,420.00 FOR HURRICANE PREPAREDNESS; AUTHORIZING THE DIRECTOR OF FINANCE AND ADMINISTRATIVE SERVICES TO SET UP A BUDGET FOR SAME; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, The City is preparing for Hurricane Season, which occurs June 1 through November 30; and

**WHEREAS**, City Staff will be utilizing the temporary Public Works Facility as the City's Emergency Operations Center as well as to house emergency personnel during an event; and

**WHEREAS**, Staff recommends various enhancements to facilities in order to ensure that City Staff are safe during potential weather event; and.

**WHEREAS**, The recommended enhancements are necessary to ensure that the City's Emergency Management Staff can plan and respond appropriately to the community's needs during a disaster.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, FLORIDA, THAT:**

**SECTION 1:** The City Council authorizes the Director of Finance and Administrative Services to appropriate fund balance in the Major Disaster Fund Number 607-00-271000 in the amount of \$178,420.00 for Hurricane Preparedness.
