**WHEREAS,** the pumps at the Utility District's potable water repump station located at Avenue C have recently failed; and

WHEREAS, the ability to pump water into and out of the potable water ground storage tank located at this repump station is critical to maintaining adequate water supply during peak consumption and in the event of a fire; and

**WHEREAS**, the potable water repump station located at Avenue C does not have a permanent backup generator and the necessary controls to run the pumps in the event of a power outage; and

**WHEREAS**, this project will improve the integrity and reliability of the potable water distribution system; and

**WHEREAS**, in the interest of protecting the public health and safety, the Utility Special District has asked Holtz Consulting Engineers, Inc. to provide emergency engineering support services for the repairs and upgrades to the potable water repump station located at Avenue C; and

- **SECTION 3:** That the Utility Special District Board approves the emergency agreement with Holtz Consulting Engineers, Inc. in the amount not to exceed \$1,425,941.14; authorizing the Utility Special District's Finance Director to transfer \$1,210,396 from Fund Balance Reserve to Project #18157 in GL #413 31103 563000.
- **SECTION 4**: That the District Finance Director is authorized to pay for same under Project # 18157.
- **SECTION 5**: That the Executive Director shall have authority to approve change orders in an amount not to exceed ten percent (10%) of the contract amount.
- **SECTION 6:** This Resolution shall take effect upon passage and approval by the Utility Special District Board.
