

RESOLUTION NO. 33-19

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, APPROVING AN EMPLOYMENT AGREEMENT WITH DEIRDRE M. JACOBS AS INTERIM CITY MANAGER COMMENCING APRIL 16, 2019 UNTIL AUGUST 14, 2019; AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE THE AGREEMENT; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, on April 15, 2019 at a Special City Council meeting Deirdre M. Jacobs was hired to serve as the Interim City Manager for the City of Riviera Beach by unanimous vote for 120 days or until a new City Manager is hired; and

**WHEREAS**, Deirdre M. Jacobs negotiated an employment agreement outlining the terms and conditions of her employment; and

**WHEREAS**, the employment agreement is retroactive to April 16, 2019.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, as follows:**

**SECTION 1.** That the City Council hereby approves an agreement with Deirdre M. Jacobs as Interim City Manager of the City of Riviera Beach, commencing April 16, 2019 until August 14, 2019 or until a new City Manager is hired.

**SECTION 2.** That the Mayor and City Clerk are authorized to execute the employment agreement on behalf of the City, said agreement is attached hereto.

**SECTION 3.** That this resolution shall take effect immediately upon its passage and approval by City Council.


