**WHEREAS**, Gehring Group was ranked as the number one (1) firm to provide the services identified in the City's Request for Qualifications; and,

**WHEREAS**, City staff recommends placing the City's Agent of Record services with the Gehring Group for Fiscal Years 2019-2022 with optional two (2) additional 12- months renewal.

## NOW, THEREFORE BE IT RESOLVED, BY THE CITY COUNCIL OF THE CITY OF RIVIERA BEACH, PALM BEACH COUNTY, FLORIDA, as follows:

**SECTION 1.** That the City Council approves the three (3) year agreement for professional services with Gehring Group as Agent of Record for the purpose of facilitating health and voluntary Insurances.
